Wax sealed tenders are invited from eligible bidders by CGM, Orissa Telecom Circle, for and on behalf of Bharat Sanchar Nigam Limited, for carrying out various works on job contract basis at RRC, Bhubaneswar.

1. SCOPE OF WORK

The contractor shall carry out various works on job contract basis as per terms and conditions mentioned herein after, for a period of one year from the date of signing of the agreement.

2. ELIGIBILITY REQUIREMENT

- a) The bidder should submit an undertaking to the effect that none of their relatives are working in DOT/BSNL in annexure-II.
- b) Experience certificate showing number of works executed with cost particulars not less than 5 lakh in the two previous financial years issued by an officer not below the rank of Dy. General Manager or equivalent rank of any Central Govt./ State Govt./PSUs. Here work means various works on job contract basis or cable laying work in BSNL.
- c) The bidder should have PAN card of the firm/individual in case of proprietorship.
- d) The bidder should have Service Tax Registration Certificate with proof of up to date payment.
- e) The bidder should have valid labour license under contract Labour Act 1970 (R & A) (Central Govt.)
- f) The bidder should have EPF & ESI Registration certificate with proof of up-to-date payment.
- g) The bidder should submit an undertaking that he will submit the labour licence for those many number of labourers for which he will be awarded within two months, If he doesnot possesses the licence of such labourers.
- h) BSNL will not in any way be responsible for any breach of labour act or any cases relating to labour and employment. However, the following points may be implemented.
 - (i) Muster roll has to be maintained by the contractor in respect of contract labourers engaged by them.
 - (ii) The payment of contract labourers by the contractor is to be carried out as per rate approved by the Central Govt. under the minimum wages Act. 1948.
 - (iii) The contract labourers engaged by the contractors may be covered under ESI and EPF scheme by the contractor himself as per rules.
 - (iv) The contractor will issue identity cards to the engaged contract labourers.

1. ISSUE OF BID DOCUMENTS-

Bid document shall be issued during the office hours on all working days from the date of publication of NIT up to 13:00 hours of 07.03.2012

From the Sub-Divisional Engineer (RRC), O/o CGMT Orissa, 2nd Floor, Door Sanchar Bhawan, Unit-IX, Bhubaneswar: 751022., on written application with the copies of the documents (Valid labour license, Service tax registration certificate, Sales tax clearance certificate and experience certificate related to various works on job contract or cable laying) in support of their eligibility to participate in the tender along with the cost of bid document in the form of DD of Rs.520/- (Rupees Five Hundred Twenty only) from any nationalized or scheduled bank in favour of **Sr. Accounts Officer (A&P), BSNL, Office of the Chief General Manager Telecom Orissa, Bhubaneswar –751001** payable at Bhubaneswar.
