It is the responsibility of the bidders who have downloaded the tender document from the website to keep themselves abreast of such amendments before submitting the tender document.

Intending bidders are requested to register themselves with M/s. ITI through www.tenderwizard.com/BSNL for obtaining user-id, Digital Signature etc., by paying Vendor registration fee and processing fee for participating in the above mentioned tender.

BSNL has decided to use process of e-tendering for inviting this tender and thus the physical copy of the tender would not be sold.

Bidders to Note:

Crossed DD / Bankers cheque drawn on any scheduled bank in favour of the **Accounts Officer (A&P)**, O/o CGMT, BSNL, **Odisha Circle**, and payable at Bhubaneswar for an amount mentioned in table-A against the item (See Table-A) shall have to be submitted towards tender fee along with the tender bid failing which the tender bid will be liable for rejection.

1) Eligibility Criteria:

(i) (a) The eligible bidders should be Indian companies /Firms registered to manufacture the tendered item in India, having obtained clearance from Reserve Bank of India wherever applicable
OR

(b) The eligible bidders should be Indian Companies/Firms registered to supply tendered item (as per the MOA) and having MOU with the original equipment manufacturer valid for 5 years from the date of NIT for supply of tendered items.

(ii) (a) The bidder should have obtained either valid Type Approval Certificate from TEC New Delhi, or valid Technical Specification Evaluation Certificate from QA Circle BSNL Bangalore for the GR as specified in Section VI of the tender document **and should have successfully executed at least one educational/commercial order for the tendered item to DoT/BSNL/MTNL** as per the GR mentioned in Section VI of the tender document
OR

(b) The bidder should have applied for TSEC for the tendered items to QA Circle BSNL Bangalore for the GR as specified in Section VI of the tender document. A copy of Form QF-103 along with the registration number allotted by QA circle shall be submitted along with the bid **and the bidder should have experience of supply of at least 25% of tendered quantity anywhere in the world**. The experience of bidder/OEM will be considered for this purpose. Documentary evidence regarding proof of supply shall be furnished by the bidder. However equipments will be accepted only after successful completion of TSEC process.

(iii) The bidder should submit an undertaking to the effect that none of their relatives are working in BSNL

4. The bidder shall have a valid and current Sales Tax registration/ CST/ VAT, Permanent Income Tax Account No., TIN No. and shall enclose along with bid. The bidder has to give his Bank Account No. also.

Attested copies of relevant document to substantiate fulfillment of all the eligibility conditions enumerated above must be submitted along with the bid, otherwise the bid will be liable for rejection.
