The MSE bidders registered with the MSME bodies like National Small Scale Industries Corporation etc. are exempted from payment of tender document fee. However, they shall furnish a proof regarding registration with bodies under the Ministry of Micro, Small &Medium Enterprises for the sweeping, cleaning, housekeeping on Job Basis, valid on the date of opening of the tender. MSE bidders claiming exemptions from Tender fee & EMD as per MSME guidelines must also register their UAM on CPPP and submit proof in this regard along with their bid.

Note: The exemption of Tender Paper cost and EMD for MSME/NSIC category of bidders with the specific registration for example. The name of the beneficiary in case of the sole bidder or proprietary firm should either be in the name of person/Company, with which capacity she /he is participating in the tender And in case of the limited company, the MSME/NSIC registration must be in the name of all board of Directors of the same company. 2. Eligibility Criteria: The bidder should meet following eligibility requirements

2.1 General Qualification

- 2.1.1 The Bidder should have valid firm registration (Individual Registration with State/central Government/Nagar Nigam/Local Authority is required. In case of Proprietary firm/ Partnership firm registration with registrar of firms is required. In case of Pvt. Ltd Company the certificate of incorporation of the firm/company is required.
- 2.1.2 The Bidder must not be black-listed by any Central/ State Governments/ PSUs in India at the time of submission and opening of the tender. An undertaking as required must be submitted in this regard.
- 2.1.3 The Bidder must have a valid PAN & valid registration under GST Act. If the bidder is not registered with GST authority at the time of bid submission, then he shall have to submit GST registration at the time of award of work/Lol/signing of contract, if declared successful.
- 2.1.4 Valid EPF & ESI Registration certificate with up to date challan as the case may be.

2.2 Technical Qualification

The Bidder must have an experience of executing works related to supply of man power/job contract works/sweeping & cleaning/housekeeping under Central Govt./State Govt/Central PSU/state PSU/State/urban local bodies in the last three financial years i.e. 2018-19, 2019-20 & 2020-21 for an amount at least Rs. 2,94,000/- (i.e 35% of the estimated cost of the tender).taking together for all the above mentioned Financial years.

(Bidders will be required to submit the documentary support claims of their required experience, through certificates issued by any executive of AGM rank officer in case of PSUs, Gazetted rank officer for State/ Central govt. and Circle Head,

2.3 Financial Qualification

- 2.3.1 The Bidder must have Valid Turn over Certificate from a reputed Chartered Accountant for FY 2018-19, 2019-20 & 2020-21 duly audited for an amount at least Rs. 2,94,000/- (i.e 35% of the estimated cost of the tender).
- 2.3.2 The bidder must submit the solvency certificate for an amount at least Rs. 2,94,000/- (i.e 35% of the estimated cost of the tender) along with the technical bid.

Note 1:-The bidders shall submit necessary documentary proof showing that they meet the eligibility criteria along with their tender bid. All documents submitted will also be self-attested by the bidder.

Note 2:-Work Order(s) will not be considered as an experience.

3. Bid Security/EMD:

- a. The bidder shall furnish the bid EMD in one of the following ways:-
- I. Paid through DD/online Banking/RTGS/NEFT as per section 1.1which should be valid for **150** days (i.e. one month above the offer/bid validity period) from the tender opening date.
- II. The Bidder can Submit a FDR pledged to AO (Cash) O/o GMTD Koraput which should be valid for **150** days (i.e. one month above the offer/bid validity period) from the tender opening date.
- III. The MSE bidders registered with the designated MSME bodies like National Small-Scale Industries Corporation etc are exempted from payment of bid security. However, they shall furnish a proof regarding registration with bodies under the Ministry of Micro, Small & Medium Enterprises for the supply of man power/job contract works/sweeping & cleaning/housekeeping, valid on the date of opening of the tender.

- IV. The existing vendor/contractors having pending due from BSNL may submit an undertaking in the specified format of the tender document in lieu of EMD/Bid Security/Performance security.

- 9. Incomplete, ambiguous, Conditional, unsealed tender bids are liable to be rejected.
- **10.** GMTD Koraput BSNL reserves the right to accept or reject any or all tender bids without assigning any reason. He is not bound to accept the lowest bid.
- 11. The bidder shall furnish a declaration, as per Section 6 (B), in his tender bid that no addition / deletion / corrections have been made in the terms & conditions of the downloaded tender document for which their bid is being submitted and these are identical to the tender document appearing on the website.
- a. In case of any correction/ addition/ alteration/ omission in the tender document, the tender bid shall be treated as non-responsive and shall be rejected summarily.
- b. All documents submitted in the bid offer should be preferably in English/Hindi/ State's official language. In case the certificate viz. experience, registration etc. is issued in any other language other than English/Hindi/ State's official language, the bidder shall attach a translation of the same in English/Hindi/ State's official language, duly attested by the bidder & the translator to be true copy in addition to the relevant certificate.

SECTION- 2 Tender Information

1. Type of tender: Single stage submission & Two stage opening.

Digitally signed online bids are to be submitted in Single Stage Bidding and two stage opening(Techno commercial & Financial) e-tendering process using two electronic Envelopes from the eligible bidders by the time and date specified in the Bid Document.

Note: The bids will be evaluated techno-commercially first and thereafter financial bids of techno-commercially compliant bidders only, shall be opened.

- 2. **Bid Validity Period** The bid will remain valid for **150 days** from the tender opening date
- 3. The electronic envelopes will contain documents satisfying the eligibility / Technical & commercial conditions in first envelope called **Techno-commercial** envelope and the second envelope called as **Financial Envelope** containing financial bid/quote.
 - a. Techno-commercial envelope shall contain:-
 - 1) Scanned copy of EMD.
 - 2) Scanned copy of payment of cost of tender document i.e. tender fee.
 - 3) Certificate(s) showing fulfillment of the eligibility criteria(s) stated in Section-I Clause 2 of the Detailed NIT.
 - 4) Power of Attorney (PoA) & authorization for executing the power of Attorney in accordance with Clause 14.3 of Section 4 Part A.(not required in case of Proprietary / partnership firm if the proprietor/partnership himself signs the documents) and board resolution in favour of authorized signatory.
 - 5) Copy of Articles and Memorandum of Association or Partnership deed or proprietorship deed as the case may be.
 - 6) Details of the firm along with List of Directors on the Board of the Company, list of partners, as applicable.
 - 7) Attestation of the signature of the authorized signatory, issuing PoA, by Bank.
 - 8) Bidder's Profile & Questionnaire duly filled & signed as per Section-8.
 - 9) Indemnity bond declaration for indemnifying BSNL against any non- compliance by bidder towards all applicable statutory requirements, if work is awarded, as perAnnexure-1.
 - 10) Letter of authorization for attending bid opening event as per Section -7 Part (C).
 - 11) No Near-Relationship Certificate duly filled & signed as per Section-6 PartB.
 - 12) Undertaking & declaration duly filled & signed as per Section-6 Part A
 - 13) Tender / Bid form-Section 9 Part A.
 - 14) Documents as per Checklist submitted as perAnnexure-2.
 - b. Financial envelope shall contain:
 - 1) Price Schedule (as per Section 9Part-B)
 - c. Offline Documents (Who do not submitted EMD & Bid cost online):

The following documents are required to be submitted offline (i.e. **offline submissions**) to AGM(PLG), Room no-204, Door Sanchar Bhawan Koraput, Koraput as per tender condition in a sealed envelope. The envelope shall bear the tender number, name of work and the phrase: "Do Not Open Before due date".

- 2) NEFT/RTGS/DD/ Banker's cheque against Tender document cost(in original).

- 3) Power of Attorney in accordance with Clause 14. 3 of Section 4 Part A and authorization for executing the power of Attorney.
- 4) Integrity Pact (on plain paper, applicable only if tender's estimated value exceeds the threshold of Rs. 10.0 Crores for applicability of Integrity Pact as per letter No.CA/MMT/15-02/2014 dated 16.10.2018)

4. Payment terms

- 4.1 The bidder should submit the invoice to the officer in-charge of the site. The Tax Invoices are to be submitted by bidder in triplicate. Bill to be certified by SDE/AO I/C & countersigned by AGM/CAO I/C on **monthly** basis to O/o GMTD Koraput for processing for payment. SDE/AO I/C should specifically mention the penalty if any during the period. The payment will be made to the contractor observing all the formalities & satisfactory work certificates.
- 4.2 Tax Invoices shall be paid through Electronic Clearance Scheme (ECS) only. The contractor should submit the mandate form for this purpose along with the Agreement while entering into the Contract.
 - **Note:** All statutory taxes and levies as applicable shall be deducted at source before payment.
- 4.3 Online generated GST payment details of previous month shall be submitted with the invoice(s) for payments.
- 4.4 Monthly certification should be given by officer concerned with the quantum of work.
- 4.5 The rate as fixed by two categories may be treated as highest upper ceiling limit. In any case it will not be increased the upper ceiling limited throughout the agreement period.
- 5. Time line for start of services: Immediately after acceptance of AWO and Agreement signed

6. Duration of Contract (Validity of tender):

Normally contract will be awarded for One Year. However, extension for six months or part thereof, will be considered, keeping in view the various factors such as exigency of service, satisfactory performance of the firm with the same terms and conditions of the tender with increase in estimated cost.

SECTION-3

SCOPE, SPECIFICATION & SCHEDULE OF WORK TO BE CARRIED OUT

The details of scope and specification of work for sweeping, cleaning & house keeping work has been mentioned below. The schedule of work as per site has also been given in a table.

SCOPE, SPECIFICATION

I. Sweeping, Cleaning & House keeping work

Sweeping, cleaning of exchange premises & office building, cleaning of toilets/bath rooms/plantation office premises etc.

- (a) The contractor will have to depute cleaners for carrying out cleaning/sweeping of office rooms including cleaning of doors, windows, inner roof of building, tables, chairs, computers, fax machine, fan, light, racks etc. and cleaning of toilets/bath-rooms on daily minimum 3 hours.
- c) Door Sanchar Bhawan, GMTD, office & Telephone Bhawan campus premises also to be maintained for cleanliness.

Conditions of work:-

- The contractor should instruct the sweepers to carry out the sweeping/cleaning works properly under the guidance and supervision of the concerned AGM/SDE/JTO.
- Bath room and toilets to be kept clean.
- All the materials for cleaning and sweeping purpose such as brooms, clothes, phenyl, washing powder, vim and acid etc to be supplied by the contractor.
- On every Sunday inside roof of building, window corner, glass frame to be dusted and cleaned.

In case of Door Sanchar Bhawan, SDE (HRD)/AGM Admin will issue work order for every work month and supervise the sweeping & cleaning work. Accordingly he will issue certificate regarding carrying out of work satisfactorily for passing the bill. AGM (HR & Admn) will also supervise the sweeping & cleaning of Door Sanchar Bhawan Koraput & countersign the bill copy.

In other cases, SDE & AGM concerned will look after the sweeping & cleaning work of their concerned area and issue certificate accordingly

SDE Internal Telephone Bhawan, Koraput will be overall I/C of the sweeping & cleaning work of the whole Telephone Bhawan Koraput area on the report of concerned AGM. So, concerned SDE & AGM (Internal) Telephone Bhawan, Koraput will certify the satisfactory performance of the sweeping & cleaning work of their concerned area for passing the bill.

Some Important points to be done related to the work:

- ➤ Reporting of any accident or mishaps, thefts or any untoward incidents or Watching of exchange assets/ stores lying within exchange/Office compound immediately must be brought to the notice of the controlling officer or Officer In Charge.
- The vendor has to complete the work daily basis and report to the concerned office incharges except Sundays and national holidays.
- ➤ EPF and ESI of the person, if any engaged by the Bidder is the sole responsible of bidder. Being a principal employer, BSNL can check all the EPF/ESI payment before bill payment or any time to avoid further litigation.
- > The contractor and service manager must answer to the call/sms/whatsapp made by any BSNL officer. In case of busy, he should call back immediately.

Note: No staff deployed directly or indirectly by the contractor for the Job service would have any claim for getting future employment in BSNL.

3. VALIDITY OF THE CONTRACT.

The contract shall be valid for One year from the date of signing of the contract. The GMTD, Koraput reserves the right to increase the contract period from the agreed period up to six months with same rates and terms and conditions if satisfactory working report for the first year. However if Tendering authority reserves the right to cancel the contract at any time without assigning any reasons by giving one month notice for termination.

SECTION-4 Part A GENERAL INSTRUCTIONS TO BIDDERS (GIB)

1. **DEFINITIONS**

- **1.1 "The Purchaser** "means the Bharat Sanchar Nigam Ltd. (BSNL), ...Odisha Telecom Circle, Koraput SSA.
- **1.2 "The Bidder"** means the Company. Individual or firm who participates in this tender and submits its bid.
- **1.3** "The Supplier" or "The Vendor" or "Service Provider" means the individual or firm awarded the contract.
- **1.4** "**The Services**" means providing maintenance services for external plant which the Supplieris required to supply to the Purchaser under the contract.
- **1.5** "The Advance Work Order" or "Letter of Intent" means the intention of Purchaser to place the Work Order on the bidder.
- 1.6 "The Work Order" means the order placed by the Purchaser on the Supplier signed by the Purchaser including all attachments and appendices thereto and all documents incorporated by reference therein. The Work order shall be deemed as "Contract" appearing in the document.
- **1.7 "The Contract Price"** means the price payable to the Supplier under the Work order for the full and proper performance of its contractual obligations.
- 1.8 "Telecom Service Provider" means any Telecom operator in India, who is licensed by the Department of Telecommunications (DOT), Government of India to provide telecom services to the general public or to the other DOT licensed Telecom operators. "Telecom Service Provider" also refers to any Telecom operator in other countries providing telecom services to general public of that country or to other telecom operators of the same country.
- **1.9** "Successful Bidder(s)" means the bidder(s) to whom work in this tender is awarded.
 - "Zone" means the Group of exchanges/ Zone of contiguous exchanges.
 - "SSA" means Secondary Switching Areas defined by BSNL (generally comprising of one or more revenue districts).
 - "BA" means Business Area comprising of one or more SSA's

2 ELIGIBILITY CONDITIONS:

Kindly refer to of Section-1 Clause7

Bidder is expected to obtain clearance from Reserve Bank of India, wherever applicable. The Bidder must furnish the documentary evidence to meet the eligibility conditions laid down in general, technical, and financial qualification criteria.

3 COST OF BIDDING

The bidder shall bear all costs associated with the preparation and submission of the bid. BSNL will, in no case, be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

4 DOCUMENTS REQUIRED

The detailed list of services required to be provided by the bidder, bidding procedures and contract terms and conditions are prescribed in the Bid Documents. The contents of the Bid documents are specified in the covering Letter.

The Bidder is expected to examine all instructions, forms, terms and specifications in the Bid Documents and clarifications/ amendments/ addenda, if any. Failure to furnish all

information required as per the Bid Documents or submission of the bids not substantially responsive to the Bid Documents in every respect will be at the bidder's risk and may result in rejection of the bid.

5 CLARIFICATION OF BIDDOCUMENTS

A prospective bidder, requiring any clarification on the Bid Documents shall notify BSNL in writing by E-mail id & by Email (both) to tender inviting authority as indicated in the invitation of Bid. BSNL shall respond in writing to any request for the clarification of the Bid Documents, which it receives **latest upto 7 days from issue of NIT** Copies of the query (without identifying the source)and clarifications by BSNL shall be sent to all the prospective bidders who have received the bid documents.

Any clarification issued by BSNL in response to query raised by prospective bidders shall form an integral part of bid documents and shall amount to an amendment of the relevant Clauses of the bid documents.

6 AMENDMENT OF BIDDOCUMENTS

BSNL may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, may modify bid documents by amendments prior to the date of submission of Bids with due notification to prospective bidders.

The amendments shall be notified in writing by E-mail id or Email or by Addendum through e-tendering portal to all prospective bidders on the address intimated at the time of purchase of the bid document from BSNL and these amendments will be binding on them.

In order to afford prospective bidders a reasonable time to take the amendment into account in preparing their bids, BSNL may, at its discretion, extend the deadline for the submission of bids suitably.

7 DOCUMENTS COMPRISING THE BID

The bid prepared by the bidder shall ensure availability of the following components:

- a) Documentary evidence establishing that the bidder is eligible to bid and is qualified to perform the contract if its bid is accepted in accordance with the Clause 2 &10.
- b) EMD/Bid Security furnished in accordance with Clause12.
- c) A Bid form and price schedule completed in accordance with Clause 8 & 9.

8 BIDFORM

The bidder shall complete the bid form and appropriate Price Schedule furnished in the Bid Documents, indicating the services to be provided along with the prices as per Section-9

9 BID PRICES – Not applicable

10 DOCUMENTS ESTABLISHINGBIDDER'S ELIGIBILITY AND QUALIFICATION-

- 10.1. The bidder shall furnish, as part of the bid documents establishing the bidder's eligibility, the following documents are required as per eligibility terms and conditions of Bid Documents.
 - a) Valid MSE Certificate, if applicable. In case the ownership of such MSE Entrepreneurs happens to be from SC / ST category and/or owned by women, proof in this regard also need to be submitted.
 - b) Additional documents to establish the eligibility and qualification of bidder as specified inSection-1.
 - c) Power of Attorney as per Clause 14.3 (a) and (d) of this Section and authorization for executing the power of Attorney as per Clause 14.3 (b) or (c) of this Section.
 - d) Documentary proof of GST registration. If the bidder is not registered with GST authority

- at the time of bid submission, then he shall have to submit GST registration at the time of award of work/ Lol/signing of contract, if declared successful.
- e) Certificates from all Directors/ Partners of the bidder Company/firm stating that none of their near relatives are working in BSNL in accordance with Clause 33 of this Section.
- f) Certificate of incorporation /Registration
- g) Article or Memorandum of Association or partnership deed or proprietorship deed as the case may be. List of all Directors including their name(s), Director Identification Number(s) (DIN) and address (es) along with contact telephone numbers of office and residence. In case of Amendment of MoA, The new complete amended MoA copy to be uploaded online in the tender portal; else the bidder will be considered as non-responsive.
- h) One declaration from the bidder regarding his firm name, address of correspondence, valide-mailid, mobile number, Landline number (if available), Whatsapp number. Communication by BSNL authority to any of the mode shall be treated as valid proof of communication.

10 .2 Documentary evidence for financial and technical capability.

11.0 DOCUMENTS ESTABLISHING SERVICES' CONFORMITY TO BID DOCUMENTS

- 11.1 Pursuant to Clause 7 of this Section, the bidder shall furnish, as part of its bid, documents establishing the conformity of its bid to the Bid Documents of all services which he proposes to supply under the contract.
- 11.2 The documentary evidences of the "services" conformity to the Bid Documents may be, in the form of literature, drawings, data etc. and the bidder shall furnish:
- (a) A Clause-by-Clause compliance on the Purchaser's Job Specifications and Commercial Conditions demonstrating substantial responsiveness to the Job Specifications and Commercial Conditions. In case of deviations, a statement of the deviations and exception to the provision of the Job Specifications and Commercial Conditions shall be given by the bidder. A bid without Clause-by- Clause compliance of the Scope of Work, Section 3, General (Commercial) Conditions & Special (Commercial) Conditions, General Conditions (Section-II Part A, B) shall not be considered.

12. BID SECURITY /EMD

- 12.1 The bidder shall furnish, as part of its bid, a bid security as mentioned in Section-1(DNIT).
- 12.2 The existing vendor/contractors having pending due from BSNL may submit an undertaking in the specified format of the tender document in lieu of EMD/Bid Security/Performance security.
- 12.3 The MSE bidders are exempted from payment to bid security:
 - A proof regarding valid registration with body specified by Ministry of Micro, Small & Medium Enterprise for the tendered items will have to be attached along with the bid.
 - b) The enlistment certificate issued by MSME should be valid on the date of opening of tender.
 - If a vender registered with body specified by Ministry of Micro, Small & Medium Enterprise claiming concessional benefits and fails to accept AWO/ Lol& submit required performance security or fails to obey any of the contractual obligations after being awarded work; he will be debarred from any further work/ contract by BSNL for Two years from the date of issue of such order. The bid security is required to protect BSNL against the risk of bidder's conduct, which would warrant the forfeiture of bid security pursuant to Para12.7.

- 12.4 A bid not secured in accordance with Para 12.1 and 12.2 shall be rejected by BSNL being non-responsive at the bid opening stage and archived unopened on e-tender portal for e-tenders and returned to the bidder unopened(for manual bidding process)
- 12.5 The bid security of the unsuccessful bidder will be discharged/ returned as promptly as possible and within 30 days of finalization of the tender or expiry of the period of the bid validity period prescribed by BSNL pursuant to Clause 13.
- 12.6 The successful bidder's bid security will be discharged upon the bidder's acceptance of the advance work order satisfactorily in accordance with Clause 27 and furnishing the performance security, except in case of L-1 bidder, whose EMBG/EMD shall be released only after the finalization of ordering of complete tendered quantity/sites in pursuance to Clauseno.27.3of this Section.
- 12.7 The bid security may be forfeited:
- a) If the bidder withdraws or amends its bid or impairs or derogates from the bid in any respect during the period of bid validity specified by the bidder in the bid form or extended subsequently; or
- b) If the bidder does not accept the AWO and/ or does not submit PBG &sign the contract/ agreement in accordance with Clause28.

13. PERIOD OF VALIDITY OF BIDS

- 13 .1 Bid shall remain valid for period specified in Clause 2 of Tender Information. A bid valid for a shorter period and if on pointing out by BSNL for same, the bidder does not undertake to make his bid valid for required duration, then the bid shall be rejected by BSNL and treated as non-responsive.
- 13.2 In exceptional circumstances, BSNL may request the consent of the bidder for an extension to the period of bid validity. The request and the response thereto shall be made in writing. The bid security provided under Clause12 shall also be suitably extended. The bidder may refuse the aforesaid request without risk of forfeiture of its bid security. A bidder accepting the request and granting extension will not be permitted to modify its bid.

14. FORMAT AND SIGNING OF BID

- 14.1 The bidder shall submit his bid online, complying all eligibility conditions, other terms and conditions of tender document to be read along with the clarifications and amendments issued in this respect. All the documents must be authenticated, by hand signatures by the authorized person and then uploaded on e-tender portal. The letter of authorization shall be indicated by written power-of-attorney accompanying the bid.
- 14.2 The bid shall contain no interlineations, erasures or overwriting except as necessary to correct errors made by the bidder in which case such corrections shall be signed by the person or persons signing the bid. All pages of the original bid, except for unamended printed literatures, shall be manually signed by the person or persons signing the bid.

14.3 Power of Attorney

a. The power of Attorney should be submitted and executed on the non-judicial stamp paper of appropriate value as prevailing in the concerned states(s) and the same be attested by a Notary public or registered before Sub-registrar of the state(s) concerned. It should be specific for the particular tender and should have been executed after the NIT date.

- b. The power of Attorney be executed by a person who has been authorized by the Board of Directors of the bidder in this regard, on behalf of the Company/ institution/ Body corporate.
- c. In case of the bidder being a firm, the said Power of Attorney should be executed by all the partner(s) in favour of the said Attorney.
- d. In case, authorized signatory of the bid (i.e. PoA holder) is different than the person who submits the online bids using digital signatures certificate (DSC), then the power of Attorney should also include the name of this person submitting online bids on e-tender portal.

15. SEALING AND MARKING OF BIDS

- **15.1** The bid should be submitted as per Sec-II Clause 3 of tender information.
 - 15.1.1 The bids are being called under Single Stage Bidding & Two stage opening using two Envelope System. The details of sealing & marking of bids in each case is given below:
 - 15.1.2 In Single stage bidding & single envelope system, the bidder shall submit all the documents specified for Techno-commercial bid & Financial bid in a single envelope -Not applicable for this tender.
 - 15.1.3 In Single stage bidding & two envelopes system the bidder shall submit his bid online in two electronic envelopes;(ReferSection-4PartC))
 - A. The First envelope will be named as Techno-commercial bid. This envelope will contain documents of bidder's satisfying the eligibility / Technical & commercial conditions as per Clause 2 & 10 with Bid Security as per Clause 12.
 - B. <u>Second envelope will be named as Financial bid containing Price Schedules as per Section 9 Part B.</u>
 - 15.2 a) The offline envelope shall contain
 - i. Bid document cost in original
 - ii. Bid security/EMD in original
 - iii. Power of attorney

- b) The offline envelope shall bear the name of the tender, the tender number and the words' **DO NOT OPEN BEFORE'**(due date & time).
- c) Deleted
- d) Offline envelope should be deposited as per section IV Clause 15. The responsibility for ensuring that the tenders are delivered in time.
- e) Venue of Tender Opening: BSNL Bhawan, O/o The GMTD, Door Sanchar Bhawan, Koraput -764020 at specified time & date as stated in NIT.
- f) In case the bidder not able to submit the offline documents ,The bidder has to submit on If due to administrative reasons, the venue of Bid opening is changed, it will be displayed on BSNL website, e-tender portal (as the case may be).
- 15.3 Deleted
- 16. SUBMISSION OF BIDS
- 16.1 Bids must be submitted online only by the bidders on or before the specified date & time indicated in Clause6 of Section-I i.e. DNIT.

16.2 BSNL may, at its discretion, extend this deadline for the submission of bids by amending the Bid Documents in accordance with Clause 6 in which case all rights and obligations of BSNL and bidders previously subject to the deadline will thereafter be subjected to the extended deadline.

17. LATE BIDS

17.1 No bid shall be accepted after the specified deadline for submission of bids prescribed by BSNL.

18. MODIFICATION AND WITHDRAWAL OF BIDS

- 18 .1 The bidder may modify, revise or withdraw his bid after submission prior to deadline prescribed for submission of bid.
- 18.2 The bidder's modification, revision or withdrawal shall have to be online and digitally authenticated (in case of e-tendering) & physically (in case of manual bidding process) as per Clause 15.
- 18.3 Subject to Clause 20, no bid shall be modified subsequent to the deadline for submission of bids.

19. OPENING OF BIDS BY BSNL

- 19.1 BSNL shall open bids online (in case of e-Tenders) in the presence of the authorized representatives of bidders online who chose to attend, at time &date specified in DNIT(Section-1) on due date.
- 19.2 The bidder's representatives, who are present, shall sign in an attendance register. Authority letter to this effect shall be submitted by the authorized representatives of bidders before they are allowed to participate in bid opening (A Format is given in enclosed in Section-7C).
- 19.3 A maximum of two representatives of any bidder shall be authorized and permitted to attend the bid opening but the or should authorized by the bidder. The same should be uploaded online.
- 19.4 Name of envelopes to be opened & information to be read out by Bid Opening Committee
 - (i) In Single stage bidding & single stage Opening (single envelope) system; technocommercial bid &financial Bid will be opened on the date of tender opening given in NIT-(Not Applicable for this tender)
 - (ii) In Single stage bidding & two envelopes system, the bids will be opened in 2 stages i.e. the techno-commercial bid shall be opened on the date of tender opening given in NIT. Thereafter the CET will evaluate Techno- commercial bids & the report of CET will be approved by competent authority.
 - The financial bids of those bidders who are approved to be techno- commercially compliant/eligible/sucessful by the competent authority, will be opened by TOC in front of techno commercially eligible bidders/authorized representatives by sending them a suitable notice.
 - (iii) The following information should be read out at the time of Techno- commercial bid opening:
 - a) Name of the Bidder
 - b) Name of the item
 - c) EMD amount & validity and acceptability
 - d) Information in respect of eligibility of the bidder.
 - e) Details of bid modification/withdrawal, if applicable.
 - (iv) The following information should be read out at the time of Financial bid opening:
 - a) Name of the Bidder

- b) Name of the item
- c) Prices quoted in the bid
- d) Discount, if offered
- e) Taxes &levies

(Information as per electronic forms shall be populated as comparison chart on e-tender system and no information shall be read out)

19.5 The date fixed for opening of bids ,if subsequently declared as holiday by the BSNL, the revised date of schedule will be notified. However, in absence of such notification, the bids will be opened on next working day, time and venue remaining unaltered.

20. CLARIFICATION OF BIDS

- 20.1 To assist in the examination, evaluation and comparison of bids, BSNL may, at its discretion ask the bidder for the clarification of its bid. The request for the clarification and the response shall be in writing. However, no post bid clarification at the initiative of the bidder shall be entertained.
- 20.2 If any of the documents, required to be submitted along with the technical bid is found wanting, the offer is liable to be rejected at that stage. However BSNL at its discretion may call for any clarification/missing/wanting documents within a stipulated time period. In case of non-compliance to such queries, the bid will be out rightly rejected without entertaining further correspondence in this regard.

21. PRELIMINARY EVALUATION

- 21.1 BSNL shall evaluate the bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are generally in order.
- 21.2 Arithmetical errors shall be rectified on the following basis. Based on the quoted percentage of taxes, etc. the amounts quoted thereof shall be worked out and rounded off to 2 decimal points.
- 21.3 If there is a discrepancy between words and figures, the amount in words shall prevail. If the supplier does not accept the correction of the errors, its bid shall be rejected.
- 21.4 Prior to the detailed evaluation pursuant to Clause 21, BSNL will determine the substantial responsiveness of each bid to the Bid Document. For purposes of these Clauses, a substantially responsive bid is one which confirms to all the terms and conditions of the Bid Documents without material deviations. BSNL's determination of bid's responsiveness shall be based on the contents of the bid itself without recourse to extrinsic evidence.
- 21.5 A bid, determined as substantially non-responsive will be rejected by BSNL and shall not subsequent to the bid opening be made responsive by the bidder by correction of then onconformity.
- 21.6 BSNL may waive any minor infirmity or non-conformity or irregularity in a bid which doesn't constitute a material deviation, provided such waiver doesn't prejudice or affect the relative ranking of any bidder.

22. EVALUATION AND COMPARISON OF SUBSTANTIALLY RESPONSIVE BIDS-

- 22.1 The BSNL shall evaluate in detail and compare the bids previously determined to be substantially responsive pursuant toclause21.
- 22.2 The evaluation and comparison of responsive bids shall be done on the basis of Net cost to BSNL on the prices of the services offered excluding GST, as per the price schedule in the Section -9 Part B of the Bid Document after arithmetical correction in the manner laid down in clause 21.2 above. Vendors should furnish the correct

HSN/SAC in the price Schedule. If the supplier fails to furnish necessary supporting documents i.e. GST invoices etc. in respect of the Duties/taxes for which ITC is available to BSNL, the amount pertaining to such Duties/Taxes will be deducted from the payment due to the firm.

23. CONTACTING BSNL

- 23.1 Subject to Clause 20, no bidder shall try to influence BSNL on any matter relating to its bid, from the time of the bid opening till the time the contract is awarded.
- 23.2 Any effort by a bidder to modify its bid or influence BSNL in BSNL's bid evaluation, bid comparison or contract award decision shall result in the rejection of the bid.

24. PLACEMENT OF ORDER

- 24.1 BSNL shall consider placement of orders on those eligible bidders whose offers have been found technically, commercially and financially acceptable and whose Services have been approved / validated by the Purchaser. The Purchaser reserves the right to counter offer price(s)against price(s)quoted by any bidder.
- 24.2 The Purchaser intends to limit the number of technically and commercially responsive One (1) bidder from the list of such bidders arranged in increasing order of their evaluated prices starting from the lowest for the purpose of ordering. The distribution of the quantity shall be as given in Table 1 below.

If there is no eligible & willing MSE bidder then the allocation of quantity shall be dereserved & procured from participating bidders as per Table 1(A).

- a. If there is any eligible & willing MSE L1 bidder then allocation of quantity shall be as per Table 1(A) and there shall not be any separate reserved quota for MSEs in any zone if any.
- b. If there is no eligible & willing MSE L1 bidder, but there is one or more eligible & willing MSE bidders within the price band of L1+15% then allocation of quantity shall be as per Table 1(B). The 20% reserved quantity shall be equally distributed amongst such eligible & willing MSE bidders subject to Para 2(ii) of DO No. 21(1) -2011-M.A..April 25th, 2012 from Ministry of Micro, Small & Medium Enterprise (MSME).
- (ii). In the event of any of the eligible bidder(s) not agreeing to supply the transportation or not being considered by BSNL for ordering the service, inter-se ranking of the bidders below the aforesaid bidder(s) will be recast to fill up the vacated slot(s). This will be done to ensure that the number of

bidders on which order for supply of equipment to be placed remains same as specified in the tender.

25. PURCHASER'S RIGHT TO VARY QUANTITIES

- 25.1. GMTD reserves the right to increase or decrease the work by + or 25 % while placing the work order.
- 25.2. The GMTD Koraput reserves the right to offer the contract to any other tenderer or any other agency in case of unsatisfactory work. The contractor should carry out the work to the satisfaction of BSNL officer in charge and in the event of his failure the contract work will be got done from some other agency at the cost of the contractor and payment will be settled as mentioned in the tender.
- 25.3. The decision of GMTD, Koraput on any matter connected to this tender is final binding on the bidder(s).

26. BSNL's RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS

The Purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds of purchaser' saction.

27. ISSUE OF ADVANCE WORK ORDER

- 27.1. The issue of an Advance Work Order shall constitute the intention of BSNL to enter into contract with the bidder.
- 27.2 The bidder shall within 14 days of issue of the advance work order, give its acceptance along with performance security in conformity with the proforma providedwiththebiddocumentatSection-7B.
- 27.3 L-1 bidder may be issued Advanced Work Order (AWO)
- 27.4 In the event of withdrawal of AWO/LoI, subsequent claim of bidder for placement of Work Order/signing of contract, shall not be entertained by this office.

28. SIGNING OF CONTRACT

- 28.1 The issue of Work Order (WO) shall constitute the award of contract on the bidder.
- 28.2 Upon the successful bidder furnishing performance security pursuant to Clause 27 of this Section, the Purchaser shall discharge the bid security in pursuant to Clause 12 of this Section, except in case of L-1 bidder, whose EMBG / EMD shall be released only after finalization of ordering of complete tendered quantity in pursuance to Clause nos. 27 of this Section.

29. ANNULMENT OF AWARD

Failure of the successful bidder to comply with the requirement of Clause 27 & 28 shall constitute sufficient ground for the annulment of the award and the forfeiture of the bid security in which event the BSNL may make the award to any other bidder on its discretion or call for new bids.

30. QUALITY ASSURANCE(QA) REQUIREMENTS-This Clause is not applicable

31. REJECTION OF BIDS

- 31.1 While all the conditions specified in the Bid documents are critical and are to be complied, special attention of bidder is invited to the following Clauses of the bid documents. Non-compliance of any one of these shall result in outright rejection of the bid.
 - a) Clauses 12.1 & 13.1 of Section- 4 Part A: The bids will be rejected before handing

- over to CET, if offline documents are not submitted as per Clause 12.1 and bid validity is less than the period prescribed in Clause 13.1 mentioned above.
- b) Clause 2 & 10 of Section-4Part A: If the eligibility condition as per Clause 2 of Section 4 Part A is not met and/ or documents prescribed to establish the eligibility as per Clause 10 of Section 4 Part A are not enclosed, the bids will be rejected without further evaluation.
- c) Clause 11.2 (c) of Section-4 Part A: If Clause-by-Clause compliance as well as deviation statements as prescribed are not given, the bid will be rejected at the stage of primary evaluation.— This Clause is Not Applicable
- d) While giving compliance to Section-5 Part A, General Commercial conditions, Section-4 Part B, Special Instructions to Bidders, Section-5B Special (Commercial) Conditions of Contract and Section-3 Technical Specifications ambiguous words like "Noted", "Understood", "Noted & Understood" shall not be accepted as complied. Mere "Complied" will also be not sufficient, reference to the enclosed documents showing compliances must be given.
- e) Section-9 Price Schedule: Prices are not filled in as prescribed in price schedule.
- 31.2 Before outright rejection of the Bid by the purchaser for non-compliance of any of the provisions mentioned in Clause 31.1(a), 31.1(b) of Section-4PartA, the bidder company is given opportunity to explain their position, however if the person representing the company is not satisfied with the decision of the purchaser, he/they can submit the representation to the purchaser immediately with full justification quoting specifically the violation of tender condition if any.
- 31.3 Bid opening team will not return the bids submitted by the bidders on the date of tender opening even if it is liable for rejection and will preserve the bids in sealed cover as submitted by taking the signatures of some of the desirous representatives of the participating bidder/companies present on the occasion.
- The in-charge of Bid opening team will mention the number of bids with the name of the company found unsuitable for further processing on the date of tender opening and number of representations received in Bid opening Minutes and if Bid opening team is satisfied with the argument of the bidder/company mentioned in their representation and feel that there is prima-facie fact for consideration, the in-charge of the bid opening team will submit the case for review to Officer competent to approve the tender as early as possible preferably on next working day and decision to this effect should be communicated to the bidder company within a week positively. Bids found liable for rejection and kept preserved on the date of tender opening will be returned to the bidders after issue of work order against the instant tender.
- 31.5 If the reviewing officer finds it fit to open the bid of the petitioner, this should be done by giving three (working) days notice to all the participating bidders to give opportunity to participants desirous to be present on the occasion.
- 32. ACTION BY PURCHASER AGAINST BIDDER(S)/ VENDOR(S) IN CASE OF DEFAULT. As per Appendix-1 to Section 4 PartA.
- 33. Clause deleted.
- 34. NEAR-RELATIONSHIP CERTIFICATE
- 34.1. The bidder should give a certificate that none of his/ her near relative, as defined below, is working in the units where he is going to apply for the tender. In case of

proprietorship firm certificate will be given by the proprietor. For partnership firm certificate will be given by all the partners and in case of

limited company by all the Directors of the company excluding Government of India/ Financial institution nominees and independent non-Official part time Directors appointed by Govt. of India or the Governor of the state and full time Directors of PSUs both state and central. Due to any breach of these conditions by the company or firm or any other person the tender will be cancelled and Bid Security will be forfeited at any stage whenever it is noticed and BSNL will not pay any damage to the company or firm or the concerned person.

- 34.2. The Company or firm or the person will also be debarred for further participation in the concerned unit.
- 34.3 The near relatives for this purpose are defined as:-
 - (a) Members of a Hindu undivided family.
 - (b) They are husband and wife.
 - (c) The one is related to the other in the manner as father, mother, son(s) & Son's wife (daughter in law), Daughter(s) and daughter's husband (son in Law), brother(s) and brother's wife, sister(s) and sister's husband (brother in law).
- 34.4. The format of the certificate is given in Section6 (B).

35. VERIFICATION OF DOCUMENTS AND CERTIFICATES

The bidder will ensure that all the documents and certificates, including experience/ performance and self-certificates submitted by him are correct and genuine before enclosing them in the bid. The onus of proving genuineness of the submitted documents would rest with the bidder.

If any document/ paper/ certificate submitted by the participant bidder is found / discovered to be false / fabricated / tempered / manipulated either during bid evaluation or during award of contract or thereafter, then BSNL will take action as per Clause-4 of Appendix-1 of this Section.

Note for Tender opening Committee:

- At the time of tender opening, the TOC will check/ verify that the documents conforming to eligibility part are submitted by the participant bidder duly authenticated by the authorized signatory to obviate any possibility of doubt and dispute and maintain veracity of the documents/papers/certificates.
- The documents/ papers to be submitted in respective bid part have been explicitly stated in Clause-7 of Section-4 Part A.
- This opened bid part which is already signed by the authorized representative of the bidder company during bid submission will be signed by the tender opening committee on hard copy and preserve it along with the bids received online in case of e-tendering.
- These papers will be treated as authentic one, in case of any dispute.

- 20.8.2 The parties to the arbitration agreement, while agreeing for resolution of dispute by fast track Procedure, may agree that the arbitral tribunal shall consist of a sole arbitrator who shall be chosen by the parties.
- 20.8.3 The arbitral tribunal shall follow the following procedure while conducting arbitration proceedings Under Sub-section(1):-
 - (a) The arbitral tribunal shall decide the dispute on the basis of written pleadings, documents and submissions field by the parties without oral hearing;
 - (b) The arbitral tribunal shall have power to call for any further information or clarification from the parties in addition to the pleadings and documents filed by them:
 - (c) An oral hearing may be held only, if all the parties make a request or if the arbitral tribunal considers it necessary to have oral hearing for clarifying certain issues:
 - (d) The arbitral tribunal may dispense with any technical formalities, if an oral hearing is held, and adopt such procedure as deemed appropriate for expeditious disposal of the case.
- 20.8.4 The award under this section shall be made within a period of six months from the date the arbitral tribunal enters upon the reference.
- 20.8.5 If the award is not made within the period specified in sub-section (4), the provisions of sub-Sections (3) To (9) of section 29 A shall apply to the proceedings.
- 20.8.6 The fees payable to the arbitrator and the manner of payment of the fees shall be such as may be agreed between the arbitrator and the parties.
- 20.8.7 The arbitral tribunal shall make and publish the award within time stipulated as under:

Amount of Claims and Counter Claims	Period for making and publishing of the award (counted from the date the arbitral tribunal enters upon the reference)
Up to Rs 5 Crores	Within 6 months (Fast Track procedure)
Above Rs.5 Crores	Within 12 months

However, the above time limit can be extended by the Arbitrator for reasons to be recorded in writing with the consent of parties and in terms of provisions of the Act.

20.8.8 In case arbitral tribunal of 3 arbitrators, each party shall be responsible to make arrangements for the travel and stay, etc. of the arbitrator appointed by it. Claimant shall also be responsible for making arrangements for travel

/ stay arrangements for the Presiding Arbitrator and the expenses incurred shall be shared equally by the parties.

In case of sole arbitrator, BSNL shall make all necessary arrangements for his travel / stay and the expenses incurred shall be shared equally by the parties.

- 20.8.9 The Arbitration proceeding shall be held at New Delhi or Circle or SSA Headquarter (as the case maybe).
- 20.8.10 Subject to the aforesaid conditions, provisions of the Arbitration and Conciliation Act, 1996 and any statutory modifications or re-enactment thereof shall apply to the arbitration proceedings under this Clause.

21. SETOFF

Any sum of money due and payable to the supplier (including security deposit refundable to him) under this contract may be appropriated by the purchaser or the BSNL or any other person(s) contracting through the BSNL and set off the same against any claim of the Purchaser or BSNL or such other person or person(s) for payment of a sum of money arising out of this contract or under any other contract made by the supplier with the Purchaser or BSNL or such other person(s) contracting through the BSNL.

25. COURTJURISDICTION

- 25.1 Any dispute arising out of the tender/ bid document/ evaluation of bids/ issue of APO shall be subject to the jurisdiction of the competent court at the place from where the NIT/ tender has been issued.
