### SECTION – III <u>GENERAL TERMS AND</u> <u>CONDITIONS</u> <u>AND INSTRUCTIONS FOR</u> <u>BIDDERS/TENDERERS</u> & <u>ELIGIBILITY CRITERIA</u>

### 1) DEFINITIONS

- (a) "The User" means the GENERAL MANAGER BSNL, CUTTACK BUSINESS AREA, Orissa Circle, acting on behalf of CMD, Bharat Sanchar Nigam Limited.
- (b) "The Bidder" means the individual or firm who participates in the tender and submits its bid.
- (c) "The Contractor" means the individual or firm providing Driver works under the contract.
- (d) "The Service" means the supply of driver which the contractor is required to provide to the user under the contract.
- (e) "The letter of intent" means the intention of the user to place the work order on the bidder.
- (f) "The work order" means the order placed by the user on the contractor signed by the user including all attachments and appendices there to and all documents incorporated by reference therein. The work order shall be deemed as "Contract" appearing in the document.
- (g) "The Contract Price" means the price payable to the contractor under the work order for the full and proper performance of its contractual obligations.
- B) <u>SCOPE OF TENDER:-</u>

The Bidder is required to provide drivers on 'Monthly Contract Basis'/Daily Contract basis for a initial period of one year from the date of commencement of services.

### Terms and Conditions:

(a) "BSNL" or "The Nigam" or "The Tendering Authority" means Bharat Sanchar Nigam Limited (A Govt. of India Enterprise) acting on behalf of the President of India and represented by the General Manager BSNL, Cuttack Business Area

(b) "The Bidder" means the individual or firm who participates in this tender & submits its bid.

(c) "The Work Order" means the order placed by the BSNL on the Bidder signed by the Engineer- in- Charge of BSNL including all attachments & appendices thereto and all document incorporated by reference therein. The work shall be deemed as "Contract" appearing in the document

(d) "The Contract Price" means the price payable to the bidder under the work order for full & proper performance of its contractual obligations.

(e) "Site Engineer" means the concerned Sub-Divisional Officer (Phones) or Sub-Divisional Officer (Telegraphs) or Accounts Officer in-charge of this Business Area under whom the contractor will provide the requisite number of Driver on 'Monthly Contract Basis'/Daily Contract Basis for a initial period of one years from the date of commencement of services, as per actual requirement of concerned site Engineer.

(f) "Engineer In-Charge" means the controlling DE/AGM/CAO of respective Site Engineer of this Telecom District who is designated as the "Engineer in-Charge" of respective "Site Engineer"

(g) "E-Tender Portal" means the website "https://etenders.gov.in/eprocure/app" who is providing e Tendering solution to BSNL.

(h) "ETS" means the Electronic Tendering System through the e-Tender Portal <u>GST Compliance</u>

The bidder should submit valid GST regn. Certificate or mention as unregistered dealer as per GST act.

(i) A self declaration that the bidder is not blacklisted by GST authorities

(ii) In case the supplier get blacklisted during the tenure of contract then any loss suffered by

BSNL will be recovered from the bill / security money.

- (iii) If the bidder has multiple GST number then all such numbers will be provided.
- (iv) The bidder should submit correct HSN / SAC codes the bidder will be responsible for loss to BSNL owing to wrong furnishing of the HSN / SAC codes.
- (v) The bidder should submit GST invoice / Debit & Credit Note as per rule.
- (vi) The bidder should submit the latest GSTR-1

It would be responsible of the supplier to declare correct information of invoice and to file GST returns in time enabling BSNL to avail Tax credit. Any loss by BSNL for not complying GST provisions will be recovered from the bidder.

1. The Bidder/Contractor should be based at any part/District of the odisha and operating their business within the area of odisha state.

- 2. The Bidder/Contractor should have an established Office having necessary infra-structure and sufficient man-power on its rolls so as to provide immediate, satisfactory and efficient services of driver.Tenders received from Firms/Establishments operating from residential premises and not having an established Office Premises with necessary infra-structure and man power on its rolls will not be accepted and will be treated as rejected.
- 3. The Bidder/Contractor are hereby informed that the Company will arrange inspection of their Office Premises and infra-structure facilities of Tenderer/Bidder through a Committee of Officials of the Company and/or through an Investigator appointed for the purpose, to verify the existence and to assess the competance of Bidders/Tenders in providing satisfactory and efficient services required in the Tender Document. The report shall be taken into account for the purpose of qualification of Technical Bid of Bidders/Tenderers. The decision of the GM,BSNL,Cuttack ,Business Area,Cuttack in this regard shall be final and binding on the Bidders/Tenderers.
- 4. The Bidder/Contractor should have a experience of providing of vehicles with Drivers on Monthly Contract Basis/Daily contract basis.
- 5. The Bidder/Contractor should be possessing/holding a valid License issued by Central/State Government/concerned Department of Government for providing Contract Labour under the Contract Labour (Regulation and Abolition) Act. In case any other permission or Certificate is required for providing Contract Labour to the Company, the Bidder/Contractor will be required to submit the same within one month of award of the work. The successful Bidder/Contractor would be required to deploy Driver as per norms prescribed under the said Act.
- 6. The Bidder/Contractor should be registered with Service Tax/GST Authorities and should have a valid Service Tax Registration Number issued by Service Tax Authority.
- 7. The Company will debar Bidders/Tenderers having relatives working in The BSNL from tendering in any capacity. A Non-relationship Certificate is required to be submitted as per Annexure -D of the Tender Document.
- 8. The Bidder/Contractor should be abide by following condition:-

(A) Pay the total amount of Monthly Wages, Overtime and other charges mentioned in the Tender Document to the drivers deputed for our Company through "E-transaction". Payment of amount of Wages to the drivers in Cash by the Bidder/Contractor is prohibited and will not be accepted.

(B) Provide alternative driver, whenever the regular driver deputed by them is not reporting for duty and/or is on leave treating it as a Mandatory Requirement so as to ensure continuity of services of driver to BSNL. In case of failure to provide alternate driver the Bidder/Contractor should be ready to bear the penalty imposed as per the terms and conditions of the Tender Document.Please note the penalty for not providing alternate driver in the absence of regular driver by the Bidder/Contractor is to be borne by the

Bidder/Contractor . The Bidder/Contractor will not be allowed to pass on the panelty amount to the driver deputed by them.

(C) The Bidder/Contractor are required to submit "Letter of Acceptance" in this regard as per specimen enclosed as Annexure -M and non-compliance of the above requirement or any requirement given in this Tender Document and any deviation in compliance of the requirement mentioned in the Tender Document will be treated as a default in providing satisfactory services. In such an event, the General Manager BSNL, Cuttack Business Area reserves the right to cancell the Work Order given to Bidder/Contractor and the Security Deposit deposited with the Company by such Bidder/Contractor will be forefeited.

9. The Tenders from Individual / Firm / Organization including its Partners / Shareholders / Directors who have been blacklisted / prosecuted by any departments / statutory bodies in any State or by any Court of Law, shall not be entertained. An Undertaking on the Letter Head of the Company as per specimen given in Annexure -P is required to be submitted along with Technical Bid.

10. The Tenders from Bidders who's Technical Bid(s) were earlier rejected by BSNL on account of fake supporting documents etc. shall not be entertained.. The Tenders/Bids should be valid for a period of 150 days from the date of opening of Technical Bid of tender.

11. The duration of the Contract will be for a initial period of one year from the date of commencement of services after award of contract on the rates quoted by Bidder/Contractor in the Financial Bid with a provision to extend the contract for a further period of one year by same rate, terms and conditions of the tender on providing satisfactory and efficient services with incrase in tender cost. The rates of "Service Charges" quoted by the Bidder/Contractor in their Financial Bid shall remain fixed during the currency of the Contract for a initial period of one year and no revision in rates will be permitted.

### 12. PREPARATION & SUBMISSION OF BIDS:

I) Contents of the Bid:

The bid contains three parts -

Part A: - The scanned copies of the Payment of Cost of Tender paper and EMD through online/ RTGS/NEFT/FDR/TDR/DD from scheduled / Nationalized Bank & Power of attorney (If applicable) have to be uploaded in the e- Tender Portal of https://etenders.gov.in/eprocure/app

Part B:-The Second part relates to uploading of scanned documents required for Technical Bid as per Section VI in the appropriate place of the e-Tender Portal.

Part C:-The third part relates to uploading of Financial Bid containing the Price schedule in excel format filled carefully in the appropriate place of the e-Tender Portal.

### **13. BID OPENING AND EVALUATION:-**

Financial bids & Technical bids shall be submitted by the bidder at the same time. The bids will be opened in two stages. The Tendering Authority will open the technical bids in the presence of bidders or their authorized representatives on the due date as per NIT. The bidder or one of his authorized representatives shall be permitted to attend the bid opening. Authorization letter to this effect shall be submitted by the bidders before they are allowed to participate in bid opening as per Annexure -G. The bidders can view the opening details after the Tendering Authority opened them.

a. The bidder or his representative, who is present, shall sign in tender opening register.

B.The date fixed for opening of bids, if subsequently declared as holiday by BSNL, the revised date of schedule will be notified in the e-Tender Portal. However, in absence of such notification, the bids will be opened on the next working day, time remaining unaltered.

C. Technical bids will be evaluated by the Tendering Authority and after completion of the technical Evaluation; the eligible bidders list for the financial bid opening will be made available in the e-Tender Portal. Opening date and time of Financial Bid will be notified in the e-Tender Portal after opening of the Technical Bid.

The bidder shall bear all costs associated with preparation and submission of bid. BSNL in no case be responsible for these costs regardless of the conduct or outcome of the bidding process.

### **14. PLACE OF OPENING OF TENDER BIDS**

Authorized representatives of bidders (i.e. vendor / organization) can attend the Tender Opening Event (TOE) at "Room No -201(A), 1<sup>st</sup> Floor, Door Sanchar Bhawan, Link Road, Cuttack 753012", where BSNL Tender Opening Officers would be conducting through online e-Tender as per NIT. If due to administrative reasons, the date and venue of e- Bid opening is changed, same will be displayed prominently in the notice board of the e-Tender Portal.

15. The Tenderer/Bidder has to submit Earnest Money Deposit of Rs.12000/- & the cost of Tender paper to be paid through online Banking/RTGS/NEFT/FDR/TDR/DD from scheduled / Nationalized Bank only in favour of AO(Cash),BSNL, Cuttack, Business Area, Cuttack (payment through cheque or any other mode is not acceptable) in favour of ". Tenders without the Earnest Money Deposit will be deemed rejected.

16. The Earnest Money shall be forfeited if

(i) The Bidder/Contractor withdraws his Tender during the Validity Period of Tender.

(ii) The Successful Bidder/Contractor fails to comply with all the terms and conditions of the Tender Document during the currency of the contract.

17. Earnest Money Deposit of unsuccessful Tenderer/Bidders will be refunded within 30 days from the date of opening of tenders except of the qualified bidder.

18. As per Public Procurement Policy of Government of India, exemption from payment of Earnest Money Deposit is allowed to NSIC/Micro and Small Enterprises (MSEs) provided such MSEs enclose certified copy of Valid Certificate of Registration as MSEs issued by appropriate Registering Authority and letter from such Registering Authority certifying exemption from payment of Earnest Money Deposit to such MSEs. Kindly note that if these documents are not attached with the Bid/Tender Document submitted by MSE Bidder/Contractor their Bid/Tender shall not be entertained and shall be treated as rejected.

19. The Bidder/Contractor who will qualify in the "Technical Bid" will only be eligible for opening of their "Financial Bid". The date and time of opening of "Financial Bid" shall be uploaded on BSNLWebsite and shall be intimated to individual qualified bidders through their E-mail address provided in the Tender Document. All Tenderers/Bidders are, therefore, advised to visit the website regularly for updates.

20. If at any stage, it is found that the documents, certificates, bills and documents pertaining to mandatory proof of payment of minimum wages, statutory payments and other payments submitted by the Bidder/Contractor are forged or have been manipulated, the work order issued to the Bidder/Contractor shall be cancelled and the Security Deposit of the Bidder/Contractor lying with the Company shall be forfeited without any claim whatsoever on the Company and the Bidder/Contractor is liable for action as deemed fit by the General Manager BSNL,Cuttack Business Area, Cuttack.

21. The Contract with the Bidder/Contractor can be cancelled by the General Manager BSNL, Cuttack Business Area by giving one month's notice in writing without assigning any reason, whatsoever.

22. In case the Bidder/Contractor desires to cancell the contract, he is required to give three months notice in writing to the General Manager BSNL, Cuttack Business Area, Cuttack

23. The General Manager BSNL, Cuttack Business Area, Cuttack, reserves the right to reject/cancel any or all the tenders without assigning any reason, whatsoever.

24. SCOPE OF SERVICES, TERMS AND CONDITIONS.

a. The Bidder/Contractor is required to provide the services of Driver strictly on 'Monthly Contract Basis'/Daily basis as case may be for a initial period of one years from the date of commencement of services, after award of contract, on the rates quoted by

Bidder/Contractor in the Financial Bid with a provision to extend the contract for a further period of one years with same rates terms & condition of the tender. The rates of "Service Charges" quoted by the Bidder/Contractor in their Financial Bid shall remain fixed during the currency of the Contract for a initial period of one years and no revision in rates will be permitted.

25.PROCEDURE FOR SUBMISSION OF MONTHLY BILL FOR REIMBURSEMENT OF PAYMENT TO BIDDER/CONTRACTOR

a. The services of driver is required for 10 hours daily (excluding lunch time of half an hour) on six days a week basis. The duty hour of driver will start from the actual time of reporting for duty intimated to him by authorised official of the company and will end from the actual time of relieving from duty and will vary on day to day basis as per requirement of the Company. However, if needed, the driver can be called for duty at any time and can be used beyond the daily limit of 10 hours and duty on N ational Holidays/Sundays should be compensated by giving C-Off on some working day as far as possible. The "Per Hour Rate" is fixed Rs.50/-(fifty) only as Overtime Charges will be reimbursed to the Bidder/Contractor. The driver has to report at the place of duty at any location within the Cuttack Business Area, in t i m at e d to him as per need by the authorised officer. The location of reporting for duty may vary on day-to-day basis as per requirement of the authorised officer.

b. The overtime will be paid as per actual hours of duty performed by the driver subject to to the following daily/monthly maximum limits:-

c.The Bidder/Contractor is required to make payment of Wages as per the Tender Document to the Driver by the 5th day of every month.

d. The Company shall have the right to deduct from the money/amount due to the Bidder/Contractor, any sum required or estimated to be required, for making good the loss suffered by a driver deputed, by reason of non-fulfillment of the conditions of the contract of the benefit of the drivers, non-payment of wages or

e. The "Services Charges" quoted by the Bidder/Contractor in their "Financial Bid" are being paid to Bidder/Contractor as profit margin for providing the services of driver including alternate driver on monthly contract basis.

f. The Bidder/Contractor, on award of the contract, is required to submit list of drivers deputed by them along with details like age, father's name, residential address etc. The Police Verificiation Report in respect of each driver is required to be arranged, obtained and submitted to BSNL by the Bidder/Contractor at his own cost.

26. a. The Driver provided by the Bidder/Contractor can be deputed for Outstation Duty also, whenever required, for which a amount fixed of Rs. 100/- will be borne by the bidder towards Night Halt charges including fooding charges of the driver & the same may be disburse by the company on submission of the bill.

(b) Provide alternate driver, whenever the regular out-sourced driver deputed by them is not reporting for duty and/or on leave treating it as Mandatory Requirement as the G e n e r a 1 M a n a g e r B S N L , C u t t a c k B u s i n e s s A r e a is making payment of Reliever/Leave Cost of the Bidder/Contractor . In case of failure to provide alternate driver the Bidder/Contractor should have to bear the penalty of Rs. 500/- per day as per the terms and conditions of the Tender Document and the Company will not allow

the Bidder/Contractor to recover/deduct this panelty amount from the amount payable to the driver deputed by them.

27. In case of absence/non-availability of the driver deputed for a particular day or period on account of leave or otherwise, the Tenderer is required to arrange for alternative Driver (for which reliever/leave cost is being paid to the Bidder/Contractor ) so as to ensure continuance of the services of Driver treating it as a Mandatory Requirement. In case the Bidder/Contractor fails to provide Driver/Alternate Driver on any day or period during the currency of the Contract, a panelty of Rs. 500/- per day shall be imposed on the Bidder/Contractor , which will be adjusted from the monthly bill submitted for reimbursement. (Please note that the Bidder/Contractor will not deduct/recover this panelty from the amount payable to the driver deputed by them and the Bidder/Contractor will have to bear the panelty amount, if any imposed)

28. The Sucessful Bidder/Contractor , on award of the Contract, is/are required to deposit an amount of Rs.30,000/- as Performance Security Deposit with the Company in form of PBG/Bank FDR (valid up to 2  $\frac{1}{2}$  years) from the date of contract of work. This deposit will remain with the Company during the currency of the contract and no interest shall be paid on this amount.

30. The Driver should have a valid Driving Licence for driving four wheeler including for driving in hill stations and difficult terrains. The driver should be physically fit. The Driver should always carry original valid Driving Licence with him while on duty and follow all the traffic rules strictly. In case any penalty is imposed by Police and Other Authorities for not carrying original valid Driving Licence by Driver or for violating the traffic rules, the penalty imposed will be borne by the Bidder/Contractor.

31. The behaviour of the driver should be soft spoken, polite, cordial, obedient and not convicted in any Civil or Criminal Court/Law Agencies. The Bidder/Contractor, on award of contract, shall have to give Undertaking in this regard to General Manager BSNL, Cuttack Business Area. In case of any misbehaviour, in addition to taking legal action, the Tenderer will be penalized for the same and the decision of the competent authority of the company in this regard shall be final and binding on the Tenderer.

- 33. The driver would necessarily keep mobile phone with connection with him for 24 hours and would attend and make calls at the directions of occupants.
- 34. The driver for reporting at the place of duty & reliving from duty as per time given below or as per direction of user/Contrlling officer of the vehicle.

35. The Driver is required to maintain/up-date Log Book on daily basis for use of the Vehicle provided by the GM,BSNL,Business Area, Cuttack on the basis of duties given to him and produce the same to the company officials whenever demanded/required for record and other purposes. The calculations of wages and overtime payable will be made on the basis of entry in the Log Book duly signed by the User Officer.

36. The driver will carry-out daily cleaning of the car provided to him for driving and maintain the same in a good presentable condition. The cleaning material will be provided by the Company.

### **37. COST OF BIDDING**

The bidder shall bear all costs associated with the preparation and submission of the bid. BSNL in no case be responsible for these costs regardless of the conduct or outcome of the bidding process.

### **38.CLARIFICATION ON BID DOCUMENTS**

A prospective bidder, requiring any clarification of the Bid Documents shall notify the Tendering authority in writing to the Tendering authority's mailing address indicated in the NIT. The Tendering authority shall respond in writing to any request for clarification of the Bid Documents, which it receives up to 08.03.2021 . Copies of the query (without identifying the source) and clarifications by the Tendering authority shall be sent individually to all the prospective bidders who have received the bid documents.

Any clarification issued by BSNL in response to query raised by prospective bidders shall (a) form an integral part of bid documents and it may amount an amendment of relevant clauses of the bid document.

### **39. DOCUMENTS TO BE SUBMITTED FOR BID**

- The details of documents to be submitted through online in e-Tender Portal are as detailed a. at Section-VII. If any one of the above items required to be submitted along with the Technical bid is found wanting, the offer is liable to be rejected at that stage.

### **41. PREPARATION OF BID DOCUMENTS – TECHNICAL BID & FINANCIAL BID**

It is a two bid system and the bid prepared by the bidder shall comprise Technical Bid and Financial Bid and should be prepared as per Clause.31 of this Section.

### 42. BID FORMS

The bidder shall fill in the tender document in all respects, sign on all pages along with seal of the firm if any and upload required scanned documents as per Section-VII of the same in e-Tender Portal.

### **43. BID PRICE**

The bidder shall quote rates in FINANCIAL BID given in Section VIII.

### 44. COMPLIANCE

The bidder should ensure unconditional clause- by - clause compliance with all the terms and conditions of the tender document and a declaration to the effect in Annexure C of section VI should be given along with bid document.

### 45. A. BID SECURITY/EMD

- (a) The bidder must deposit the amount for bid security/EMD through Online/NEFT/RTGS/DDs stated in section II only from any nationalized/scheduled bank as per Section-I Para 2(b).
- (b) The successful bidder's bid security will be discharged upon the bidder's acceptance of the award of contract satisfactorily and furnishing the performance security.

<u>Part C:</u> The third part relates to uploading of Financial Bid containing the Price schedule in excel format filled carefully in the appropriate place of the e-Tender.

### II. SUBMISSION OF BIDS:

- a. All the clauses of the bids must be complied with and price bids must be quoted online by the bidders before the locking/closing time of the bid that is 12:00 Hrs of 14.03.2021.
- b. Scanned document wherever necessary are to be uploaded in the appropriate places of the document.
- c. Scanned documents wherever necessary are to be uploaded in the appropriate places of the document.
- d. If any one of the document required to be uploaded is found to be missing, the concerned bid shall be rejected at the opening stage itself.

The bidder or one of his authorized representatives shall be permitted to attend the bid opening. Authorization letter to this effect shall be submitted by the bidders before they are allowed to participate in bid opening as per Annexure G in Section VI. - (b) The bidder or his representative, who is present, shall sign in tender opening register.

### **51. PRELIMINARY EVALUATION**

- (a) Tendering authority shall evaluate the bids to determine whether they are complete in all respects, whether any computational errors have been made, whether required sureties have been furnished etc.
- (b) Prior to the detailed evaluation, the Tendering authority will determine the substantial responsiveness of each bid to the Bid documents.
- (c) For purposes of these clauses, a substantially responsive bid is one, which conforms, to all the terms and conditions of the Bid documents without any material deviation. The tendering authority's determination of bids responsiveness shall be based on the contents of the bid itself without recourse of extrinsic evidence.
- (d) A bid, determined as substantially non-responsive will be rejected by the Tendering authority and shall not, subsequent to the bid opening, be made responsive by the bidder by correction of the non- conformity. The tendering authority shall not be bound to show the reasons/causes of rejection the bid.
- (e) The Tendering authority may waive any minor infirmity or non-conformity or irregularity in a bid, which does not constitute a material deviation, provided such waiver, does not prejudice or affect the relative ranking of any bidder.
- (f) The tendering authority reserves the right to verify the original documents prior to opening of Financial Bid.

### **52. EVALUATION AND COMPARISON OF SUBSTANTIALLY RESPONSIVE BIDS**

- a) The Tendering authority shall evaluate and determine as to whether the bid is substantially responsive or not as per above conditions.
- b) Arithmetical errors shall be rectified on the following basis. If there is a discrepancy between the unit price and total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected by the Tendering authority. - c) If the bidder does not accept the correction of the errors, his bid shall be rejected.

### 53. CONTACTING THE TENDERING AUTHORITY

- f) However if any of the contractor is not doing the work after issuing work order by the concerned AGM(HR & Admn) O/o GM,BSNL, CUTTACK,Business Area,Cuttack then GM,BSNL reserves the right to award the work to any other willing contractor with submission of additional PBG.
- g) Normally the amount of S.D will remain unaltered in all cases mentioned above.

### 54. SIGNING OF CONTRACT AGREEMENT:-

The successful tenderer shall be required to execute an agreement on a non-judicial stamp paper of Rs.100/-(Rupees One Hundred only) at his own cost as per the enclosed proforma within 10 (Ten) days from the date of deposit of PSD in this office. In the event of failure of the tenderer to sign the agreement within 10(Ten) days of being called upon to do so after depositing required PSD, or in the event of his failure to start the work as stipulated in the work order, then the amount of PSD. (Performance Security Deposit) in the form of TDR (Term Deposit Receipt) or BG (Bank Guarantee) or EMD as the case may be, shall be forfeited by BSNL and the acceptance of the tender shall be considered as revoked.

### 55. VALIDITY OF THE CONTRACT.

- i) The contract shall be valid for one year from the date of signing of the contract.
- ii) In case of extension of contract for a period another one year, the concerned contractor has to submit a request letter for his willingness to work in same terms and condition of agreement.

### **56. DISPUTES IN TENDER FINALIZATION:**

In the event of any disputes arising out of finalizing of tender agreement or any other matter relating to this tender the decision of GM, BSNL, Business Area, Cuttack shall be final and binding on all concerned.

### **57. DISQUALIFYING CLAUSE:**

The BSNL reserves the right to disqualify such bidders who have a record of not meeting the contractual obligations against earlier contracts entered into with the BSNL. The terms and conditions enumerated above shall be binding and the bidders shall have to accept them in writing along with tender. The GM, BSNL, Business Area, Cuttack reserves the right to vary the quantum of work against each respective zone as per actual requirement in the field from time to time.

58. The BSNL reserves the right to award work to more than one contractor in any location in exigency of service. However, the quantity of work may vary on contractor to contractor at any given point of time.

### **59.Termination of Contract by BSNL**

- (a) The GM,BSNL,Business Area, Cuttack may, at its option, cancel or omit the execution of one or more items of work under this contract and may part of such items without any compensation whatsoever to the contractor.
- (b) BSNL may without prejudice to any other remedy for breach of contract may terminate the contract in whole or in parts by giving one months notice in writing to the service provider if the contractor fails to execute the work assigned to him within the period specified in the contract or any extension thereof granted by BSNL.
- (c) If the contractor fails to perform any other obligation (s) under the Conditions of the contract.
- (d) All instruction, notices & communication etc. under the contract given in writing and if sent to the last known place of business, shall be deemed to be served on the date, even in ordinary course of post, these would have been delivered to the service provider.
- (e) Notwithstanding anything contained herein, BSNL reserves the right to terminate the contract at any stage or time during the period of contract ,by giving one month notice in writing without assigning any reason and without incurring any financial liability whatsoever to the service provider.
- (f) The GM,BSNL,Business Area, Cuttack may, at any time, at its option cancel and terminate this contract by written notice to the contractor, in which event the contractor shall be entitled to payment for the work done up to the time of such cancellation and a reasonable compensation in accordance with the contract prices for any additional expenses already incurred for balance work exclusive of purchases and/or while of material, machinery and other equipment for use in or in respect of the work.
- (g) BSNL may also by giving written notice and without compensation to the contractor terminate the contract if the contractor becomes unwilling, bankrupt or otherwise insolvent without affecting its right of action or remedy as hirer.

### 60.( Deleted)

### **61. PERIOD OF VALIDITY OF BIDS**

- (a). Bid shall remain valid for 150 days from date of opening of the bid. A BID VALID FOR A SHORTER PERIOD SHALL BE REJECTED BY BSNL AS SUBSTANTIALLY NON-RESPONSIVE BID.
- (b) A bidder accepting the request of tendering authority for an extension to the period of the bid validity in exceptional circumstances will not be permitted to modify the bid.

# 62. TENDERING AUTHORITY'S RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALLBIDS

The Tendering authority reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the Tendering authority's action.

### **63.Force Majeure:**

If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such no performance or delay in performance under the under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of BSNL as to whether the works have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation Read, understood, complied & agreed

under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract. 64. Arbitration:

- a In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to the matters, the decision to which is specifically provided under this agreement), the same shall be referred to sole arbitration of GM,BSNL,Business Area, Cuttack or any other person appointed by him.
- In case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the function of the GM,BSNL,Business Area, Cuttack or by whatever designation such officers may be called (hereinafter referred to as the said officer). In the event of such Arbitrator to whom the matter is originally referred to vacates his office on resignation or otherwise or refuses to do work or neglecting his work or being unable to act as Arbitrator for any reasons whatsoever, the GM,BSNL,Business Area, Cuttack of BSNL, Odisha shall appoint another person to act as Arbitrator in the place of outgoing Arbitrator and the person so appointed shall be entitled to proceed further with the reference from the stage at which it was left by the predecessor and that the award of the arbitrator shall be final and binding on both the parties. Contractor will have no objection in any such appointment that arbitrator so appointed is an employee of BSNL or a Government Servant or that he has to deal with the matter to which the agreement relates or that in the course of his duties as a BSNL employee he has expressed his views on all or any of the matters in dispute. The adjudication of such Arbitrator shall be governed by the provisions of the Arbitrator and Conciliation Act 1996, or any statutory modification or re-enactment there of or any rules made thereof.
- b. The venue of Arbitration proceeding shall be Office of GM,BSNL,Business Area, Cuttack or such other place as the arbitrator may decide.
- c The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to aforesaid arbitration and conciliation Act, 1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.

### 65. Set Off:

- a. Any sum of money due and payable to the contractor (including security deposit refundable to him) under this contract may be appropriated by BSNL and set off the same against any claim of BSNL for payment of a sum of money arising out of this contract or under any other contract made by contractor with BSNL.
- b. In the event of said security deposit being insufficient, the balance of total amount recoverable as the case may be shall be deducted from any such due to the service provider under this or any other contract with BSNL. Should this amount be insufficient to cover the said full amount recoverable, the service provider shall pay to BSNL on demand the balance amount, if any, due to BSNL within 30 days of the demand by BSNL.
- c. If any amount due to the company is so set off against the said security deposit, the service provider shall have to make good the said amount so set off to bring the security deposit to the original value immediately by not later than 10 days.

### **66. REJECTION OF BID**

The bid will be rejected in case of:-

- Non-submission of required documents as per Section VII. i.
- Bid quoted with conditional rates. ii.
- Non-submission of bid security iii.
- Late submission of bid iv.
- Non-acceptance of correction of price As per Clause 36 (c) v.

### **67. DEBARRING CONDITIONS**

a. Sub-contracting of the job will debar and disqualify a successful bidder.

b. BSNL reserves the right to disqualify such bidders who have a record of not meeting contractual obligations against earlier contract entered into with BSNL.

c. The engagement and employment of driver and payment of wages to them as per existing provisions of various labour laws and regulations is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be breach of this contract.

d. BSNL reserves the right to blacklist a bidder for a suitable period in case he fails to honour his bid without sufficient ground.

### 69. INTIMATION OF CORRECTIONS/MODIFICATIONS TO TENDER DOCUMENT

a. The correction/modification, if any, in the tender document will be uploaded in the Website i.e. www.orissa.bsnl.co.in and e tenders.govt.in/eprocure/app as per NIT, which will be treated as final.
