3. (a) Intending bidders are requested to register themselves with M/s. NIC Limited through the website **www.etenders.gov.in/eprocure** for obtaining user-id, Digital Signature etc., by paying Vendor registration fee and processing fee for participating in the above mentioned tender.
3. (b) BSNL has decided to use the process of e-tendering for inviting this tender and thus the physical copy of the tender would not be sold.
3. (c) The bidders shall furnish a declaration that no addition / deletion / corrections have been made in the downloaded tender document being submitted and it is identical to the tender document appearing on Web-site (**www.etenders.gov.in/eprocure** as per Annexure - E of Section VIII.
3. (d) In case of any correction/ addition/ alteration/omission is found in the original tender document; the tender bid shall be treated as non-responsive and shall be rejected.
- 4.(a) The bidder should have an experience in Jointing & OverHead drawing of 4 OF cable for provisioning/maintenance of FTTH connections in BSNL/MTNL/Other PSUs/Central Govt. or Revenue share partners with minimum 400 connections or Revenue Share for maintenance or capital works of FTTH connections with minimum of 35 % of estimated cost for the FY 2018-19,2019-20 and 2020-21 .Total experience for the FY 2018-19,2019-20 and 2020-21 taking together must be at least 35 % of the estimated cost for the zone which applied..Experience certificate in this regard is to be issued by an officer not below the rank of Deputy General Manager or equivalent. Experience certificate issued by any TDE or equivalent duly countersigned by an officer not below the rank of DGM will also be considered. The Vendor should submit Turn Over certificate for the ,FY 2017-18,FY 2018-19 and 2019-20, the turn over certificate issued after July 2019 must have a Valid UDIN number else the bidder will be rejected from this tender.
4. (b) All the minimum required tools like OFC splicing machine, OTDR, GPS meter, drilling machine are to be arranged by the Successful Bidder. The successful bidder must have one set of such tools in his own name, before execution of the agreement.
4. (c) The documents as listed out in Section VII should be uploaded in the E-Tender Portal.
5. BSNL has adopted e-tendering process which offers a unique facility for ,Public Online Tender Opening Event (TOE)'. BSNL's Tender Opening Officers as well as authorized representative of bidder can attend the Public Online Tender Opening Event (TOE) from the comfort of their offices. However, if required, bidders or their authorized representatives can attend the Tender Opening Event at the **Conference Hall, 3rd Floor, Door Sanchar Bhawan, Unit-IX, Bhubaneswar-751022** where BSNL's Tender Opening Officers would be conducting Public Online Tender Opening Event (TOE).

8. All documents submitted in the bid offer should be preferably in English. In case the certificate viz., experience, registration etc., is issued in any language other than English, the bidder shall attach an English translation of the same duly attested by the bidder & the translator in addition to the relevant certificate. All computer generated documents should be duly signed by the bidder.
9. All statutory taxes as applicable shall be deducted at source before payment.
