Bids of such bidders only shall be accepted without offline envelope provided they submit the scan copies of online payment receipt in online technical bid as a proof.

- 1) **Place of opening of Tender bids:** BSNL has adopted e-tendering process which offers a unique facility for 'Public Online Tender Opening Event (TOE). BSNL's Tender Opening Officers as well as authorized representatives of bidders can attend the Public Online Tender Opening Event (TOE) from the comfort of their offices. However, if required, authorized representatives of bidders (i.e. service provider organization) can attend the TOE at the chamber of GMTD, BSNL, Berhampur where BSNL's Tender Opening Officers would be conducting Public Online Tender Opening Event (TOE).

- 3) The GMTD, BSNL, Berhampur reserves the right to reject any or all tender bids without assigning any reason thereof. The GMTD BSNL Berhampur is not bound to accept the lowest tender.
