INSTRUCTIONS FOR TENDERERS USING DOWNLOADED TENDER DOCUMENTS FROM WEB:

The blank prescribed tender form conditions and tender documents can also be downloaded from the website www.odisha.bsnl.co.in. Such tenderers who downloaded tender document from web should submit tender cost of on payment of **Rs 177.00 (Rs 150.00 + vat Rs 27.00) (Rupees one hundred seventy seven only)** either by Bankers cheque or Demand draft of a scheduled bank in favour of the **Account Officer (Cash), O/o G.M.T.D, BSNL, Cuttack** (payable at Cuttack).

The downloaded “tender document” in which rates are quoted should be properly sealed. Loose / spiral bound submission shall be rejected out rightly. The tender shall furnish a declaration to this effect that no addition / deletion / corrections have made in the tender document submitted and it is identical to the tender document on website. Every page of the downloaded tender shall be signed by tenderer with stamp seal of his firm/organization.

The unopened tenders shall be returned to the tenderers after the final decision on the tender is reached.
