- b. Incase L1 does not turned up then supply work will be carried out by L2 at L1 rate.

- **a.** Penalty up to 5% per week delay of the actual cost of the purchase order will be imposed **on** the supplier in case the delivery is delayed for more than 30 days.
- **b.** In case of imposition of penalty, the amount will be deducted from the pending bills, if any, otherwise from the Security Deposit of the vendor. In any case, penalty will not exceed 10%.
