4. Eligibility Criteria: The bidder should meet following eligibility requirements

4.1 General Qualification

4.1.1 The Bidder should have valid firm registration (Registration with Nagar Nigam/Local Authority in case of Proprietary firm & in case of Pvt. Ltd Company/Partnership firm registration with registrar of firms/company is required) certificate of incorporation of the firm/company within India.

4.1.2 *In case any bidder from a country which shares a land border with India will be eligible to bid in any procurement whether of goods, services (including consultancy services and non-consultancy services) or works (including trunk project) only if the bidder is registered with the Competent Authority, specified in Annexure-4.*

4.1.3 The Bidder must not be black-listed for Telecom business by any Central/State Governments/PSUs in India at the time of submission of bid. An undertaking must be submitted in this regard.

4.1.4 The Bidder must have a valid PAN & valid registration under GST Act. If the bidder is not registered with GST authority at the time of bid submission, then he shall have to submit GST registration at the time of award of work/LoI/signing of contract, if declared successful.

4.2 Technical Qualification

The Bidder must have an experience of executing Transportation work/Transportation of electrical or telecom stores etc. of any Central Govt/Central Govt PSU/State Government/TSPs/Private firms in the last three financial years i.e. 2018-19, 2019-20 and 2020-21. The Bidder must have

(a) One year experience of any one financial year of at least 80% of estimated cost of the Tender.

OR

(b) Two years experience of any two financial years of at least 50% of estimated cost of the Tender in each financial year.

OR

(c) Three years experience of at least 40% of estimated cost of the Tender in each financial year.

Bidders will be required to support claims of their required experience, through certificates issued by any executive of DGM rank officer or equivalent in case of PSUs/State/Central govt. and Circle Head, in case of private TSPs/Firms (Compulsory for Private TSP)

“Micro and Small Enterprises (MSE) bidder should submit their valid Udyam Registration Certificate including URN (Udyam Registration Number) issued from MSME, in order to avail the benefits available to MSEs as contained in Public Procurement Policy for MSEs. URN certificate should broadly cover the Equipment/services offered in Tender”

4.3 Financial Qualification

4.3.1 The Bidder must have Solvency certificate from its banker, (nationalized/scheduled bank of India), **to the tune of 40% of annual estimated tender cost**, (Solvency certificate should not be older than NIT publication date)

Note 1:-The bidders shall submit necessary documentary proof showing that they meet the eligibility criteria along with their tender bid. All documents submitted will also be self-attested by the bidder.

Note 2:-Work Order(s) will be issued or Contract agreement(s) will be signed only upon successful verification of the eligibility documents submitted in the bid, with the originals of the eligibility documents, which shall have to be produced by successful bidder.

Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the competent Authority as per OMs No.6/18/2019-PPD dated 23rd July, 2020 & 24th July, 2020 of Public Procurement Division, Department of Expenditure, Ministry of Finance imposing restrictions under Rule 144 (xi) of the General Financial Rules (GFRs) 2017 on the grounds of Defence of India and National Security (Pl refer the OMs N.6/18/2019-PPD dated 23rd July, 2020 & 24th July, 2020). Bidders complying this order in all respect only will be considered for placing orders. Non compliance of this order will result in rejection of bid at evaluation stage itself. An undertaking is to be submitted by the bidder on the Bidder Company's letterhead (in Original) as per the Proforma at Annexure-4.

- b. Bank Guarantee(s) from a Scheduled Bank in India, drawn in favour of "AO (Cash), BSNL, O/o GMBA, Dhenkanal" which should be valid for **150** days (i.e. one month above the offer/bid validity period) from the tender opening date.
- c. Through NEFT/RTGS in Union Bank of India, Dhenkanal.
- d. The MSE bidders registered with the designated MSME bodies like National Small Scale Industries Corporation etc. are exempted from payment of bid security.
