**Note:** In case the last date of submission / opening of bid is declared to be a holiday, last date of submission / opening of bid will get shifted automatically to next working day at the same scheduled time. Any change in bid submission/ opening date due to any other unavoidable reasons will be notified through the BSNL web site and/ or e-Tender Portal.

The MSE bidders registered with the designated MSME bodies like National Small Scale Industries Corporation etc. are exempted from payment of tender fee. However, they shall furnish a proof regarding registration with bodies under the Ministry of Micro, Small & Medium Enterprises for photocopies valid on the date of opening of the tender. *MSE bidders claiming exemptions from Tender fee & EMD as per MSME guidelines must also register Udyam Registration Certificate indicating URN (Udyam Registration Number) issued from MSME, in order to avail the benefits available to MSEs as contained in Public procurement policy for MSEs. URN certificate should broadly covered the Equipment/ Service offered in tender and submit proof in this regard along with their bid.*

**Note:** The exemption of Tender Paper cost and EMD for MSME/NSIC category of bidders with the specific registration for example. The name of the beneficiary in case of the sole bidder or proprietary firm should either be in the name of person/Company, with which capacity she /he is participating in the tender. And in case of the limited company, the MSME/NSIC registration must be in the name of all board of Directors of the same company. Any deviation will not be considered.

- 1.1 A separate bid form along with price bid (as per Section-9 Part B) for each zone is a separate tender. The evaluation of the tender as well as allotment of the work will be done zone wise.

- 2.1 The bidders downloading the tender document are required to submit the tender fee of amount **Rs. 500 + applicable GST** through online payment through NEFT/RTGS along with their tender bid failing which the tender bid shall be left archived unopened/ rejected. The online payment will made to "AO (Cash), BSNL, O/o GMTD, Bhubaneswar." and payable at Bhubaneswar.
- 2.2 **Availability of Tender Document on the e-tender portal for bid submission:** The tender document shall be available for downloading from BSNL website [www.odisha.bsnl.co.in](http://www.odisha.bsnl.co.in) & [www.etenders.gov.in/eprocure/app](http://www.etenders.gov.in/eprocure/app) from **11/07/2022** onwards.
- 2.3 Physical copy of the tender document would not be available for sale.
- 2.4 The Tender document shall not be available for download from e-tender portal on its submission / closing date
3. **Eligibility Criteria :** The bidder should meet following eligibility requirements
- 4.1. **General Qualification :**
- 4.1.1 The Bidder should have valid firm registration (Registration with Nagar Nigam/Local Authority in case of Proprietary firm & in case of Pvt. Ltd Company/Partnership firm registration with registrar of firms is required) certificate of incorporation of the firm/company.
- 4.1.2 The Bidder must *not be black-listed for Telecom business by any Central/ State Governments/ PSUs in India and GST Authority at the time of submission of bid. An undertaking must be submitted in this regard.*
- 4.1.3 The Bidder must have a valid PAN card and IT return for the financial Year 2019-20, and 2020-21 & valid registration under GST Act. If the bidder is not registered with GST authority at the time of bid submission, then he shall have to submit GST registration at the time of award of work/ LoI/signing of contract, if declared successful.
- 4.2 **Technical Qualification:**
- a) The bidder should have minimum work experience of two years during the last three Financial Years (2019-20, 2020-21 & 2021-22) and up to the date of bidding of current Financial Year for Supply of telecom equipments in BSNL/MTNL/Central Government/State Government / any Central/State Public Sector Undertakings.
- b) The bidder should have work experience of minimum Rs.8,75,000/- (Rupees Eight Lakhs Seventy Five Thousand) only during the last three Financial Years (2019-20, 2020-21 & 2021-22) taken together for Supply of telecom equipments in BSNL/MTNL/Central Government/State Government / any Central/State Public Sector Undertakings. Experience certificate in this regard is to be issued by an officer not below the rank of Deputy General Manager or equivalent. Experience certificate issued by any TDE duly countersigned by an officer not below the rank of DGM will also be considered.
- c) The bidder should submit Experience Certificate to this effect. Experience Certificates, issued by an officer not below the rank of Deputy General Manager or equivalent rank of the concerned organization, are to be furnished.
- (Bidders will be required to support claims of their required experience, through certificates issued by any executive of DGM rank officer, in case of PSUs and with approval of Circle Head, in case of private TSPs/Private Firms)

**4.3 Financial Qualification :**

The Bidder must have valid IT return for the financial years 2019-20 and 2020-21.

**Note 1:-**The bidders shall submit necessary documentary proof showing that they meet the eligibility criteria along with their tender bid. All documents submitted will also be self-attested by the bidder.

**Note 2:-**Work Order(s) will be issued or Contract agreement(s) will be signed only upon successful verification of the eligibility documents submitted in the bid, with the originals of the eligibility documents, which shall have to be produced by successful bidder, if required.

**Note 3:** Work Order will not be taken as experience certificate.

**4.4 Bid Security/EMD:**

The bidder shall furnish the bid EMD in one of the following ways:-

4.4.1 The cost of EMD to be paid through online Banking/ RTGS/ NEFT/TDR in favour of "AO (Cash), BSNL, O/o GMTD Bhubaneswar of "Bharat Sanchar Nigam Limited, Bhubaneswar" which should be valid for **180** days (i.e. one month above the offer/bid validity period) from the tender opening date.

4.4.2 The MSE bidders registered with the designated MSME bodies like National Small Scale Industries Corporation etc. are exempted from payment of tender fee. However, they shall furnish a proof regarding registration with bodies under the Ministry of Micro, Small & Medium Enterprises for the construction/Operations/Maintenance services in Telecom Industry / maintenance and installation of OF cables, valid on the date of opening of the tender. The scope of area of the above MSE registered bidders must be for construction/ maintenance of underground telecom cables/ maintenance and installation of OF cables /telecom outdoor network etc. **MSE bidders claiming exemptions from Tender fee & EMD as per MSME guidelines must also register Udyam Registration Certificate indicating URN (Udyam Registration Number) issued from MSME, in order to avail the benefits available to MSEs as contained in Public procurement policy for MSEs. URN certificate should broadly covered the Equipment/ Service offered in tender and submit proof in this regard along with their bid.**
