If due to administrative reasons, the date and venue of e- Bid opening is changed, same will be displayed prominently in the notice board of the e-Tender Portal.
- 12. The Tenderer/Bidder has to submit Earnest Money Deposit of Rs.12600/- & the cost of EMD and

cost of Tender paper to be paid through online Banking/RTGS/NEFT/FDR/TDR/Bank Guarantee from scheduled / Nationalized Bank only in favour of AO(Cash),BSNL,Cuttack (payment through cheque or any other mode is not acceptable) in favour of ". Tenders without the Earnest Money Deposit will be deemed rejected.

- 13. The Earnest Money shall be forfeited if
 - (i) The Bidder/Tenderer withdraws his Tender during the Validity Period of Tender.
 - (ii) The Successful Bidder/Tenderer fails to comply with all the terms and conditions of the Tender Document during the currency of the contract.
- 14. Earnest Money Deposit of unsuccessful Tenderer/Bidders will be refunded at the earliest from the date of opening of tenders except of the qualified bidder.
- 15. As per Public Procurement Policy of Government of India, exemption from payment of Earnest Money Deposit is allowed to Micro and Small Enterprises (MSEs) provided such MSEs enclose certified copy of Valid Certificate of Registration as MSEs issued by appropriate Registering Authority and letter from such Registering Authority certifying exemption from payment of Earnest Money Deposit to such MSEs. Kindly note that if these documents are not attached with the Bid/Tender Document submitted by MSE Bidder/Tenderer their Bid/Tender shall not be entertained and shall be treated as rejected.
- 16. The Bidder/Tenderer who will qualify in the "Technical Bid" will only be eligible for opening of their "Financial Bid". The date and time of opening of "Financial Bid" shall be up-loaded on BSNL Website and shall be intimated to individual qualified bidders through their E-mail address provided in the Tender Document. All Tenderers/Bidders are, therefore, advised to visit the website regularly for updates.
- 17. If at any stage, it is found that the documents, certificates, bills and documents pertaining to mandatory proof of payment of minimum wages, statutory payments and other payments submitted by the Bidder/Tenderer are forged or have been manipulated, the work order issued to the Bidder/Tenderer shall be cancelled and the Security Deposit of the Bidder/Tenderer lying with the Company shall be forfeited without any claim whatsoever on the Company and the Bidder/Tenderer is liable for action as deemed fit by the GENERAL MANAGER, BSNL, CUTTACK BA
- **18.** The Contract with the Bidder/Tenderer can be cancelled by the GENERAL MANAGER,BSNL,CUTTACK BA, Cuttack by giving one month's notice in writing without assigning any reason, whatsoever.
- 19. In case the Bidder/Tenderer desires to cancell the contract, he is required to give three months notice in writing to the GENERAL MANAGER, BSNL, CUTTACK BA, Cuttack
- **20.** The GENERAL MANAGER, BSNL, CUTTACK BA, reserves the right to reject/cancel any or all the tenders without assigning any reason, whatsoever.
- 21.SCOPE OF SERVICES, TERMS AND CONDITIONS.
- a. The Bidder/Tenderer is required to provide the services of Driver strictly on 'Monthly Contract Basis' or daily contract basis for a initial period of one years from the date of commencement of services, after award of contract, on the rates quoted by Bidder/Tenderer in the Financial Bid with a provision to extend the contract for a further period of one years with same rates terms & condition and subject to maximum ± 25% of total tender cost of the tender. The rates of "Service Charges" quoted by the Bidder/Tenderer in their Financial Bid shall remain fixed during the currency of the Contract for a initial period of one years and no revision in rates will be permitted.

22.PROCEDURE FOR SUBMISSION OF MONTHLY BILL FOR REIMBURSEMENT OF PAYMENT TO BIDDER/TENDERER

a. The services of driver is required for 10 hours daily (excluding lunch time of half an hour) on six days a week basis. The duty hour of driver will start from the actual time of reporting for duty intimated

to him by authorised official of the company and will end from the actual time of relieving from duty and will vary on day to day basis as per requirement of the Company. However, if needed, the driver can be called for duty at any time and can be used beyond the daily limit of 10 hours and duty on National Holidays/Sundays should be compensated by giving C-Off on some working day as far as possible. The "Per Hour Rate" is fixed Rs.50/-(fifty) only as Overtime Charges will be reimbursed to the Bidder/Tenderer. The driver has to report at the place of duty at any location within the Cuttack Telecom District, intimated to him as per need by the authorised officer. The location of reporting for duty may vary on day-to-day basis as per requirement of the authorised officer.

b. The overtime will be paid as per actual hours of duty performed by the driver subject to the following daily/monthly maximum limits:-

- c.The Bidder/Tenderer is required to make payment of Wages as per the Tender Document to the Driver by the 5th day of every month.
- **d.** The Company shall have the right to deduct from the money/amount due to the Bidder/Tenderer, any sum required or estimated to be required, for making good the loss suffered by a driver deputed, by reason of non-fulfillment of the conditions of the contract of the benefit of the drivers, non-payment of wages or
- e. The "Services Charges" quoted by the Bidder/Tenderer in their "Financial Bid" are being paid to Bidder/Tenderer as profit margin for providing the services of driver including alternate driver on monthly contract basis.
- f. The Bidder/Tenderer, on award of the contract, is required to submit list of drivers deputed by them along with details like age, father's name, residential address etc. The Police Verificiation Report in respect of each driver is required to be arranged, obtained and submitted to BSNL by the Bidder/Tenderer at his own cost.
- 23. a. The Driver provided by the Bidder/Tenderer can be deputed for Outstation Duty also, whenever required, for which a amount fixed of Rs. 100/- will be borne by the bidder towards Night Halt charges including fooding charges of the driver & the same may be disburse by the company on submission of the bill.
 - (b) Provide alternate driver, whenever the regular out-sourced driver deputed by them is not reporting for duty and/or on leave treating it as Mandatory Requirement as the GENERAL MANAGER, BSNL, CUTTACK BA, Cuttack is making payment of Reliever/Leave Cost of the Bidder/Tenderer. In case of failure to provide alternate driver the Bidder/Tenderer should have to bear the penalty of Rs. 500/- per day as per the terms and conditions of the Tender Document and the Company will not allow the Bidder/Tenderer to recover/deduct this panelty amount from the amount payable to the driver deputed by them.
- 24. In case of absence/non-availability of the driver deputed for a particular day or period on account of leave or otherwise, the **Tenderer is required to arrange for alternative Driver** (for which reliever/leave cost is being paid to the Bidder/Tenderer) so as to ensure continuance of the services of Driver treating it as a Mandatory Requirement. In case the Bidder/Tenderer fails to provide

Driver/Alternate Driver on any day or period during the currency of the Contract, a panelty of Rs. 500/- per day shall be imposed on the Bidder/Tenderer, which will be adjusted from the monthly bill submitted for reimbursement. (Please note that the Bidder/Tenderer will not deduct/recover this panelty from the amount payable to the driver deputed by them and the Bidder/Tenderer will have to bear the panelty amount, if any imposed)

- 25. The Sucessful Bidder/Tenderer, on award of the Contract, is/are required to deposit an amount of Rs.31,500/- as Security Deposit with the Company. This deposit will remain with the Company during the currency of the contract and no interest shall be paid on this amount.
- **26.** The Bidder/Tenderer will be required to make payment to the Driver deployed only through payment or through "Account Payee" Cheque Only by the 5th of every month.
- 27. The Driver should have a valid Driving Licence for driving four wheeler including for driving in hill stations and difficult terrains. The driver should be physically fit. The Driver should always carry original valid Driving Licence with him while on duty and follow all the traffic rules strictly. In case any penalty is imposed by Police and Other Authorities for not carrying original valid Driving Licence by Driver or for violating the traffic rules, the penalty imposed will be borne by the Bidder/Tenderer.
- 28. The behaviour of the driver should be soft spoken, polite, cordial, obedient and not convicted in any Civil or Criminal Court/Law Agencies. The Bidder/Tenderer, on award of contract, shall have to give Undertaking in this regard to GENERAL MANAGER, BSNL, CUTTACK BA, Cuttack. In case of any misbehaviour, in addition to taking legal action, the Tenderer will be penalized for the same and the decision of the competent authority of the company in this regard shall be final and binding on the Tenderer.
- **29.** The driver, in addition to safe driving of the car, is expected receive/alighten the occupants in a very respectful manner and would obey the instructions of the occupants.
- **30.** The driver would **necessarily keep mobile phone with connection with him for 24 hours** and would attend and make calls at the directions of occupants..
- **31.** The driver for reporting at the place of duty & reliving from duty as per time given below or as per direction of user/Contrlling officer of the vehicle.

S.N	TIMINGS
1	Reporting for duty At or Before 6.00 AM in the Morning
2	Relieving from duty At or After 10.00 PM in the Night

- 32. The Driver is required to maintain/up-date Log Book on daily basis for use of the Vehicle provided by the GENERAL MANAGER, BSNL, CUTTACK BA on the basis of duties given to him and produce the same to the company officials whenever demanded/required for record and other purposes. The calculations of wages and overtime payable will be made on the basis of entry in the Log Book duly signed by the User Officer.
- **33.** The driver will carry-out daily cleaning of the car provided to him for driving and maintain the same in a good presentable condition. The cleaning material will be provided by the Company.

34.COST OF BIDDING

The bidder shall bear all costs associated with the preparation and submission of the bid. BSNL in no case be responsible for these costs regardless of the conduct or outcome of the bidding process.

35.CLARIFICATION ON BID DOCUMENTS

A prospective bidder, requiring any clarification of the Bid Documents shall notify the Tendering authority in writing to the Tendering authority's mailing address indicated in the NIT. The Tendering authority shall respond in writing to any request for clarification of the Bid

Documents, which it receives latest up to 7days from issue of NIT. Copies of the query (without identifying the source) and clarifications by the Tendering authority shall be sent individually to all the prospective bidders who have received the bid documents.

(a) Any clarification issued by BSNL in response to query raised by prospective bidders shall form an integral part of bid documents and it may amount an amendment of relevant clauses of the bid document.

36. DOCUMENTS TO BE SUBMITTED FOR BID

- a The details of documents to be submitted through online in e-Tender Portal are as detailed at **Section**
 - VII. If any one of the above items required to be submitted along with the Technical bid is found wanting, the offer is liable to be rejected at that stage.
- b. Documents in original should be submitted for verification as required by the Tendering Authority.
- c. The bidder will verify the genuineness and correctness of all documents and certificates including experiences/performance certificates, submitted by the bidder or any other firm / associates before submitting them in the bid. The onus of proving genuineness of the submitted documents would rest with the bidder.
- d As per the requirement of the tender's condition, if any documents/paper/certificate submitted by the bidder is found to be false/fabricated/tampered / manipulated at any stage during bid evaluation or after award of contract, then the bid security (EMD/PBG/TDR) of the bidder would be forfeited and the bidder would be disqualified from the tender. Action would be taken for banning of business dealing with the defaulting firm. In case contract has already been awarded to the bidder, then PBG would be forfeited and the contract would be rescinded / annulled and BSNL would be at liberty to procure the services from any other source at the risk and cost of the defaulting bidder. Action would also be taken for banning business dealing with the defaulting firm. An undertaking to this effect should be submitted by the bidder as per format at **Annexure-Mof Section-VIII.**

37. AMENDMENT TO BID DOCUMENT

(a) At any time, prior to the date of submission of bid, tendering authority may, for any reason whether at its own initiative or in response to a clarification required by a prospective bidder, modify the bid documents by amendments. The amendments shall be notified in the E-Tender BSNL Website and these amendments will be binding on them.

(b) In order to afford prospective bidders reasonable time to take the amendments

- into account in preparing their bids, the Tendering authority may, at its discretion, extend the deadline suitably for the submission of bids.
- (c) It is the sole responsibility of the bidder to confirm from the E-Tender BSNL website and/or from the following contacts regarding amendments, if any, or any other clarifications before uploading of the tender document.

38. PREPARATION OF BID DOCUMENTS – TECHNICAL BID & FINANCIAL BID

It is a two bid system and the bid prepared by the bidder shall comprise Technical Bid and Financial Bid and should be prepared as per Clause.31 of this Section.

39. BID FORMS

The bidder shall fill in the tender document in all respects, sign on all pages along with seal of the firm if any and upload required scanned documents as per Section-VII of the same in e-Tender Portal.

40. BID PRICE

The bidder shall quote rates in FINANCIAL BID given in Section VI.

41. COMPLIANCE

The bidder should ensure unconditional clause- by – clause compliance with all the terms and conditions of the tender document and a declaration to the effect in Annexure C of section VI should be given along with bid document.

42. A. BID SECURITY/EMD

- (a) The bidder must deposit the amount for bid security/EMD through Online/NEFT/RTGS as stated in section II only from any nationalized/scheduled bank as per Section-I Para 2(b).
- (b) The successful bidder's bid security will be discharged upon the bidder's acceptance of the award of contract satisfactorily and furnishing the performance security.
- (c) The Bid security of unsuccessful bidder will be discharged / returned as early as possible after expiry of the period of bid validity.
- (d) A BID WITHOUT BID SECURITY/BID SECURITY WITH OUT BID SHALL

BE TREATED AS NON- RESPONSIVE AND SHALL BE REJECTED BY THE

TENDERINGAUTHORITY.

B.FORFEITURE OF BID SECURITY/EMD

The Bid Security/EMD may be forfeited

- (a) If the successful bidder backs out to accept the tender and/or does not deposit the Performance Security Deposit @ 5% of estimated costs of tender, or
- (b) The successful bidders do not come for execution of agreement after deposit of performance security deposit within the scheduled time;
- (c) Withdraws his bid during the period of bid validity specified by the bidder in the bid form;

43. FORMAT AND SIGNING OF BID

- (a) The bid shall contain no interlineations, erasures or overwriting, except as necessary to correct errors made by the bidder in which case such corrections shall be signed by the persons signing the bid.
- (b) The over writing / erasures in the bid made by the bidder shall be signed by the person signing the bid.
- (c) The letter of authorization shall be indicated by written power-of-attorney, if any, accompanying the bid. All pages of the original bid, except for un-amended printed literatures, shall be signed by the person or persons signing the bid.

44. PREPARATION & SUBMISSION OF BIDS:

I) Contents of the Bid:

The bid contains three parts –

<u>Part A:</u> The scanned copies of the Payment of Cost of Tender paper and EMD through online /NEFT/RTGS&Power of attorney (If applicable) have to be uploaded in the e- Tender from BSNL Website http://odisha.bsnl.co.in/new-tender.html or https://etenders.gov.in/eprocure/app

- Part B: The Second part relates to uploading of scanned documents required for Technical Bid as per Section VII in the appropriate place of the e-Tender Portal.
- Part C: The third part relates to uploading of Financial Bid containing the Price schedule in excel format filled carefully in the appropriate place of the e-Tender.

II. SUBMISSION OF BIDS:

- b. Scanned document wherever necessary are to be uploaded in the appropriate places of the document.
 - c. Scanned documents wherever necessary are to be uploaded in the appropriate places of the document.
 - d. If any one of the document required to be uploaded is found to be missing, the concerned bid shall be rejected at the opening stage itself.

- (b) The bidder may withdraw his bid after submission prior to the deadline prescribed for submission of bids. The bidder's withdrawal shall have to be online and digitally authenticated.
- (c) No bid shall be modified subsequent to the deadline for submission of bids as above.

46. BID OPENING AND EVALUATION:-

- (b) The bidder or his representative, who is present, shall sign in tender opening register.
- (c) The date fixed for opening of bids, if subsequently declared as holiday by BSNL, the revised date of schedule will be notified in the e-Tender Portal. However, in absence of such notification, the bids will be opened on the next working day, time remaining unaltered.
- (d) Technical bids will be evaluated by the Tendering Authority and after completion of the technical Evaluation; the eligible bidders list for the financial bid opening will be made available in the e-Tender Portal.
- (e) Opening date and time of Financial Bid will be notified in the e-Tender Portal after opening of the Technical Bid.

47. PLACE OF OPENING OF TENDER BIDS

51. PRELIMINARY EVALUATION

- (a) Tendering authority shall evaluate the bids to determine whether they are complete in all respects, whether any computational errors have been made, whether required sureties have been furnished etc.
 - (b) Prior to the detailed evaluation, the Tendering authority will determine the substantial responsiveness of each bid to the Bid documents.

- (c) For purposes of these clauses, a substantially responsive bid is one, which conforms, to all the terms and conditions of the Bid documents without any material deviation. The tendering authority's determination of bids responsiveness shall be based on the contents of the bid itself without recourse of extrinsic evidence.
- (d) A bid, determined as substantially non-responsive will be rejected by the Tendering authority and shall not, subsequent to the bid opening, be made responsive by the bidder by correction of the non- conformity. The tendering authority shall not be bound to show the reasons/causes of rejection the bid.
- (e) The Tendering authority may waive any minor infirmity or non-conformity or irregularity in a bid, which does not constitute a material deviation, provided such waiver, does not prejudice or affect the relative ranking of any bidder.
- (f) The tendering authority reserves the right to verify the original documents prior to opening of Financial Bid.

52. EVALUATION AND COMPARISON OF SUBSTANTIALLY RESPONSIVE BIDS

- (a). The Tendering authority shall evaluate and determine as to whether the bid is substantially responsive or not as per above conditions.
- (b) Arithmetical errors shall be rectified on the following basis. If there is a discrepancy between the unit price and total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected by the Tendering authority. If there is a discrepancy between words and figures, the amount in words shall prevail.
- (c) If the bidder does not accept the correction of the errors, his bid shall be rejected.
- (d) The financial bid will be evaluated only the substantially responsive bids.

53. CONTACTING THE TENDERING AUTHORITY

- a. Subject to seeking clarifications on e-tendering and tender document, no bidder shall try to influence the Tendering authority on any matter relating to its bid, from the time of the bid opening till the time the contract is awarded.
 - B. Any effort by a bidder to influence the Tendering authority in the tendering authority's bid evaluation, bid comparison or contract award decisions shall result in the rejection of the bid.

C.Award of contract & Work:

- a) The BSNL shall consider award of contract only to those eligible bidders whose offers have been found technically, commercially and financially responsive, eligible and accepted. Normally the bid of the tenderer who quote the lowest rate (as mentioned in financial bid) will be accepted.
- b) However the BSNL reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders.
- c) The BSNL reserves the right to disqualify such bidders who have a record of not meeting contractual obligations against earlier contracts entered into with the BSNL CUTTACK ABA.
- d) The BSNL reserves the right to counter offer price(s) against price(s) quoted by any bidder.
- e) The assessment of GM,BSNL,CUTTACKin this regard shall be Final and binding.

- f) However if any of the contractor is not doing the work after issuing work order by the concerned AGM(HR & Admn) O/o GM,BSNL,CUTTACKthen GM,BSNL,CUTTACK,BA reserves the right to award the work to any other willing contractor with submission of additional PBG.
 - 9) Normally the amount of SD will remain unaltered in all cases mentioned above.

54.SIGNING OF CONTRACT AGREEMENT:-

The successful tenderer shall be required to execute an agreement on a non-judicial stamp paper of Rs.100/-(Rupees One Hundred only) at his own cost as per the enclosed proforma within 10 (Ten) days from the date of deposit of PSD in this office. In the event of failure of the tenderer to sign the agreement within 10(Ten) days of being called upon to do so after depositing required PSD, or in the event of his failure to start the work as stipulated in the work order, then the amount of PSD. (Performance Security Deposit) in the form of TDR (Term Deposit Receipt) or BG (Bank Guarantee) or EMD as the case may be, shall be forfeited by BSNL and the acceptance of the tender shall be considered as revoked.

55. VALIDITY OF THE CONTRACT.

- i) The contract shall be valid for one year from the date of signing of the contract.
- ii) In case of extension of contract for a period another one year, the concerned contractor has to submit a request letter for his willingness to work in same terms and condition of agreement subject to ± 25% of tender cost.

56. DISPUTES IN TENDER FINALIZATION:

In the event of any disputes arising out of finalizing of tender agreement or any other matter relating to this tender the decision of GM,BSNL,CUTTACK shall be final and binding on all concerned.

57. DISQUALIFYING CLAUSE:

The BSNL reserves the right to disqualify such bidders who have a record of not meeting the contractual obligations against earlier contracts entered into with the BSNL. The terms and conditions enumerated above shall be binding and the bidders shall have to accept them in writing along with tender. The GM,BSNL,CUTTACKreserves the right to vary the quantum of work against each respective zone as per actual requirement in the field from time to time.

58. The BSNL reserves the right to award work to more than one contractor in any location in exigency of service. However, the quantity of work may vary on contractor to contractor at any given point of time.

59.Termination of Contract by BSNL

(a) The GM,BSNL,CUTTACK may, at its option, cancel or omit the execution of one or more items of work under this contract and may part of such items without any compensation whatsoever to the contractor.

BSNL may without prejudice to any other remedy for breach of contract may terminate the contract in whole or in parts by giving one months notice in writing to the service provider if the contractor fails to execute the work assigned to him within the period specified in the contract or any extension thereof granted by BSNL.

- (b) If the contractor fails to perform any other obligation (s) under the Conditions of the contract.
- (c) All instruction, notices & communication etc. under the contract given in writing and if sent to the last known place of business, shall be deemed to be served on the date, even in ordinary course of post ,these would have been delivered to the service provider.
- (d) Notwithstanding anything contained herein, BSNL reserves the right to terminate the contract at any stage or time during the period of contract ,by giving one month notice in writing without assigning any reason and without incurring any financial liability whatsoever

to the service provider.

(e) The GM,BSNL,CUTTACK may, at any time, at its option cancel and terminate this contract by written notice to the contractor, in which event the contractor shall be entitled to payment for the work done up to the time of such cancellation and a reasonable compensation in accordance with the contract prices for any additional expenses already incurred for balance work exclusive of purchases and/or while of material, machinery and other equipment for use in or in respect of the work.

(f)BSNL may also by giving written notice and without compensation to the contractor terminate the contract if the contractor becomes unwilling, Non responsive bankrupt or otherwise insolvent without affecting its right of action or remedy as hirer.

60. Penalty Clause:

For delays in the contractor's performance:

- a. The time allowed for completion of work as entered in the work order shall be strictly adhered to by the contractor and shall be reckoned from the seventh day from the issue of the work order by BSNL. The contractor shall pay as penalty amount Rs.200 per day 2hrs in the incomplete work for every day delay or part thereof in completion of work subject to a maximum of Rs.500/-per day..
- b. On any date the penalty payable as above reaches 10% of the estimated cost of the work the contractor should proceed with the work further only on getting a written instruction from the concerned DE, that, he is allowed to proceed further with the work.
- c. Penalty for delay in completion in work shall be recoverable from the bill of the contractor and/or by adjustment from the SD or from the bill of any other contract of BSNL.

61. PERIOD OF VALIDITY OF BIDS

- (a) Bid shall remain valid for 150 days from date of opening of the bid. A BID VALID FOR A SHORTER PERIOD SHALL BE REJECTED BY BSNL AS SUBSTANTIALLY NON-RESPONSIVE BID.
- (b) A bidder accepting the request of tendering authority for an extension to the period of the bid validity in exceptional circumstances will not be permitted to modify the bid.

<u>62. TENDERING AUTHORITY'S RIGHT TO ACCEPT ANY BID AND TO REJECT</u> ANY OR ALL BIDS

The Tendering authority reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds for the Tendering authority's action.

63.Force Majeure:

If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof,

neither party shall by reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such no performance or delay in performance under the under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exist, and the decision of BSNL as to whether the works have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

64.Arbitration:

a In the event of any question, dispute or difference arising under the agreement or in connection there—with (except as to the matters, the decision to which is specifically provided under this agreement), the same shall be referred to sole arbitration of GM,BSNL,CUTTACKor any other person appointed by him.

In case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the function of the GM,BSNL,CUTTACKor by whatever designation such officers may be called (hereinafter referred to as the said officer). In the event of such Arbitrator to whom the matter is originally referred to vacates

his office on resignation or otherwise or refuses to do work or neglecting his work or being unable to act as Arbitrator for any reasons whatsoever, the GM,BSNL,CUTTACKof BSNL, Odisha shall appoint another person to act as Arbitrator in the place of outgoing Arbitrator and the person so appointed shall be entitled to proceed further with the reference from the stage at which it was left by the predecessor and that the award of the arbitrator shall be final and binding on both the parties. Contractor will have no objection in any such appointment that arbitrator so appointed is an employee of BSNL or a Government Servant or that he has to deal with the matter to which the agreement relates or that in the course of his duties as a BSNL employee he has expressed his views on all or any of the matters in dispute. The adjudication of such Arbitrator shall be governed by the provisions of the Arbitrator and Conciliation Act 1996, or any statutory modification or re-enactment there of or any rules made thereof.

- b. The venue of Arbitration proceeding shall be Office of GM,BSNL,CUTTACK, or such other place as the arbitrator may decide.
- The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to aforesaid arbitration and conciliation Act, 1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.

65.Set Off:

- a. Any sum of money due and payable to the contractor (including security deposit refundable to him) under this contract may be appropriated by BSNL and set off the same against any claim of BSNL for payment of a sum of money arising out of this contract or under any other contract made by contractor with BSNL.
- b. In the event of said security deposit being insufficient, the balance of total amount recoverable as the case may be shall be deducted from any such due to the service provider under this or any other contract with BSNL. Should this amount be

- g The engagement and employment of driver and payment of wages to them as per existing provisions of various labour laws and regulations is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be breach of this contract.
 - h BSNL reserves the right to blacklist a bidder for a suitable period in case he fails to honour his bid without sufficient ground.

69. INTIMATION OF CORRECTIONS/MODIFICATIONS TO TENDER DOCUMENT
