- a) The quantities stipulated in the tender are approximate and the BSNL reserves the right to vary the quantity of works to the extent of (-) 50% to (+) 50% of quantity during contract period at the same rates and terms & condition with prior approval of the competent authority.
- b) A bidder can participate maximum in 2(Two) zones. Bidders who have been blacklisted /debarred by any BSNL unit and under currency of penalty, will not be eligible to participate in the above tender.
- c) For participating in e-Tendering process bidder shall access e-Bid document uploaded on the e tender portal and pay requisite tender processing fee as defined for the tender by e-tender service provider.
- d) EMD:-The bidder has to submit and sign Bid Security Declaration accepting that if they withdraw or modify their bids during period of validity etc., they will be suspended/ debarred/banned for the period of one year.

- f) In case of bidding for two Zones, one Cumulative EMD and Tender fee amount for both Zones, for which bids have been submitted, shall be accepted. Bidder will have option to apply in maximum 2(Two) Zones of their choice. L1 bidder will be decided Zone-wise. The evaluation of the Tender will be done Zone wise.

  - a) For an amount equal to at least 50% of estimated cost of work put to tender during last 5 Financial years taken together, i.e. from FY 2015-16, plus the subsequent period ending the month preceding the one in which NIT is issued.

b) For an amount equal to at least 70% of estimated cost of work put to tender during last 7 Financial years taken together, i.e. from FY 2016-17, plus the subsequent period ending the month preceding the one in which NIT is issued.

"Similar works is defined as work involving the Optical Fiber Cable Construction/ Rehabilitation/ reconstruction works"

### Notes:-

- The experience of having successful completion of OF Cable Construction / Rehabilitation / Re-Construction works is to be reckoned in terms of payment received for such works during the above said periods.
- ii) The Experience should be of Optical Fiber Cable Construction/Rehabilitation/Re-Construction work only and does not include any other work like Pole less / Up-gradation / Maintenance works of UG / External Plant/ UG Cable (Copper) etc.
- iii) The experience certificate issued by Class-1 Officer/ Group A Officer /Circle Project Head in respect of PSU /BSNL/DOT/MTNL/Central / State Govt.
- iv) In case, supplier gets black-listed during the tenure of BSNL contract, then BSNL has the right to recover the Input Credit Loss suffered by it due to any default by the vendor.

- v) Of late, big Govt. contracts are being carried out by the Public Sector Undertakings mentioned herein through a chain of contractors. In such case, the experience certificate, if issued, in favor of a contractor, in the chain, by such PSUs in the prescribed format shall be acceptable.
- vi) In case of Bidder Bids for more than one Zone, Then his experience should be equal to Sum total of experiences required in all Zones participated, as per eligibility conditions.
- vii) Declaration/Undertaking regarding the firm has not been declared, black listed/Debarred/ Banned for taking part in tender anywhere in the unit of BSNL (Corporate Office/Circle/BA/ OA/SSA etc.)/GST authorities and MTNL/ Central/State Govt. /PSU /Undertaking, as per format, Declaration-II of Section-XVIII of tender document in Rs 10/-Non Judicial Stamp paper. - 4) **Period of contract:** The period of this contract will be for 02(Two) years from the date of agreement. However, the BSNL reserves the right to extend the contract further, in terms of six months or less, up to one year on the same rates, terms & conditions, which shall be binding on the contractor.
- 5) Date of sale of tender document, Last date of submission of bid, Date of opening of Bids:-
- 6) If the date of opening of the bids happens to be holiday, the tenders will be opened on the next working day at the same time and the same venue.
- 7) The tender is invited through e-tendering process through the e-tender portal (www./etenders.gov.in/eprocure/app). Kindly refer Section-VI of Tender document for further instructions on e-tendering. Prospective bidders should get their registration done well in time on the e- tender portal and obtain the Digital Signature Certificate (DSC) from authorized CA, which is essential for participating in the tendering process. This link can also be visited using BSNL website (www.odisha.bsnl.co.in).
- 8) Tender will not be accepted/received on the e-tendering portal after due date and time. The officer in charge BSNL reserves the right to reject any or all tenders without assigning any reason whatsoever.
- 9) As the tender is invited through e-tendering process, physical copy of the tender document would not be available for sale. The bidder needs to download the tender document using the link as mentioned above.
- 10) All the documents in Qualifying Bid —Part-A and Financial bid-Part B are to be uploaded in the respective electronic envelops/parts on e-tender portal including proof of deposit of cost towards e-payment/ NEFT/ RTGS/ BG towards cost of tender and e-payment e-payment/ NEFT/ RTGS/ BG towards EMD.
- 11) Last date and time of submission of tender document:
- (i) Date & Time of submission of Tender bids online on or before 16/12/2022 upto 15:00 hrs.)
- (ii) Envelope containing offline document should be submitted **on or before 17/12/2022 up to 13:30 hrs.** (on the date of opening where the opening of online document is 15:00 hrs.)
- (iii) Date and time of opening of Tender: 17/12/2022 at 15:00 hrs.
- 12) The units registered under single point registration scheme of NSIC / MSE units (*Registered under UDYAM AADHAR*) for OF Cable laying works are exempted from depositing the price of tender document and from payment of earnest money deposit (EMD). Such bidder shall have to upload the document in proof of registration of valid NSIC/MSE for carrying out OFC work along with bid document.
- 13) Bid Security amount (EMD) is to be paid in the form of through online Banking RTGS/NEFT or Crossed Demand Draft issued by any nationalized /scheduled bank, drawn in favor of Accounts Officer (Cash) BSNL, O/o GMTD BHUBANESWAR, payable at BHUBANESWAR.
- 14) The bidder may submit and sign "Bid Security Declaration" accepting that if they withdraw or modify their bids during period of validity etc., they will be suspended/ debarred/banned for the period of one year, in lieu of above clause 12(b) as per Declaration-IV.
- 15) The successful bidder including NSIC/MSE bidder shall submit an equivalent to 3 % (DoE OM No. 9/4/2020-PPD Dated 12.11.2020). of the tender approved value in the form of Performance Bank Guarantee (PBG). The bidder will also submit material security (BG) as per letter of intent (Section-X).
- 16) If a vendor registered with body specified by Ministry of Micro, small and medium enterprise claiming concessional benefits (such as exemption from Tender Fee and EMD) is awarded work by BSNL and subsequently fails to obey any of the contractual obligation, he may be debarred from any further work / contract by BSNL for one year from the date of issue of such order and MSME authority issuing the certificate shall also be informed for taking suitable action.
- 17) The bidders downloading the tender document are required to submit the tender fee amount mentioned, For Each Zone, Through e-Payment/NEFT/RTGS/ BG along with their tender bid failing which the tender bid shall be left archived unopened/ rejected.
