Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. Benifits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

Bhubaneswar or in case hisdesignation n is changed or his office is abolished, then in such cases to the sole arbitration of the ficer for the time e being entrusted (whether in addition to his own duties or otherwise) with the functions of the CGMT, B SNL, Bhubaneswar or by whatever designation such an officer may be called (hereinafter referred to as t he said officer), and if the CGMT, BSNL, Bhubaneswar or the said officer is unable or unwilling to act as s uch, then to the sole arbitration of some other person appointed by the CGMT, BSNL, Bhubaneswar or th e said officer.
