1. SCOPE OF WORK

The contractor shall carry out various works on job contract basis as per terms and conditions mentioned herein after for a period of two years from the date of signing of the agreement.

2. ELIGIBILITY REQUIREMENT

- a) The bidder must have sufficient infrastructure to carry out various works on job contract basis.
- b) The bidder should submit an undertaking to the effect that none of their relatives are working in DOT/BSNL in annexure-II.
- c) Experience certificate showing number of works executed with cost particulars not less than 25 lakhs in the two previous financial years issued by an officer not below the rank of Dy General Manager or equivalent rank of any Central Govt./ State Govt./PSUs. Here work means various works on job contract basis. Certificate issued by BSNL will have advantage over others.
- d) The bidder should have PAN card of the firm/individual in case of proprietorship.
- e) The bidder should have Service Tax Registration Certificate with proof of up to date payment.
- f) The bidder should have valid labour license under contract Labour Act 1970(R &A)(Central Govt.)
- g) The bidder should have EPF & ESI Registration certificate with proof of up-to-date payment.
- h) BSNL will not in any way be responsible for any breach of labour act or any cases relating to labour and employment. However the following points may be implemented.
 - (i) Muster roll has to be maintained by the contractor in respect of contract labourers engaged by them.
 - (ii) The payment of contract labourers by the contractor is to be carried out as per rate approved by the State Govt. from time to time.
 - (iii) The contract labourers engaged by the contractors may be covered under ESI and EPF scheme by the contractor himself as per rules.
 - (iv) The contractor will issue employment cards of engaged contract labourers.
