#### SPECIFICATION AND FUNCTIONAL REQUIREMENTS:

The Rechargeable batteries (As mentioned in column-2 of the NIT) are planned to be used in FWTs (As mentioned in 5 against the battery types) for replacement of faulty batteries. Hence the capacity of batteries in term of volt and ampere-hour must be the same as per column-4. The physical dimensions (Size), connecting cables and the connectors of the batteries are also very important as these batteries are to be accommodated/ fitted inside the battery boxes/slots provided in IFWTs. In order to facilitate inspection for intending bidders, the purchaser shall arrange for display of the Samples/Models of batteries proposed to be procured and FWTs/ IFWTs with which the batteries are to be used. These FWTs and Battery samples shall be kept with Sri J.N. Senapati, A.G.M. (WLL-Plg), 2<sup>nd</sup> (09437288188). Bhawan. Unit-III, Bhubaneswar **Bidders** their telephone representatives may ask for inspection of these materials during office hours.

### 2. ELIGIBILITY REQUIREMENT

- a. The eligible bidders should be **Indian companies**/ **firms registered to manufacture the tendered item in India/ authorized distributor** in case of item imported, having valid MOU with the original Equipment Manufacturer.
- b. The eligible bidders should have successfully executed educational/commercial orders issued by the DOT/BSNL/ any other telecom service providers / Central Govt. organizations / PSUs for supply of the tendered item.
- c. The bidder should have sold at least 1000 units of either/all type of tendered item(s), to one or more customers. A certificate from the buyer regarding the satisfactory performance of the batteries during last 6 months should be enclosed as a part of the bid. The certificate should have easily verificable references.
- d. The bidder / authorized distributor should have a minimum turnover of Rs. 30 Lakhs for the last two consecutive financial years. Firm should enclose the turn over certificate in the form of Annual report certified by it's chartered accountant.
- e. In case of authorized distributor/ supplier, the bidder has to submit a certificate issued by OEM in this regard. Further the OEM certificate regarding support to this bidder for 3 years in the format given must be submitted.
- f. The proof of manufacturing of item in India/ copy of authorization in case of item imported, successful execution of educational /commercial orders and Annual Report/ turn over certificate shall form part of the bid.
- g. In case, the bidder is an authorized dealer/ distributor; valid Memorandum of Understanding (MOU) with the principal manufacturer to this effect must be enclosed with the Technical Bid.

#### 3. ISSUE OF BID DOCUMENTS-

Bid document shall be issued during the office hours on all working days from the date of Publication of NIT up to 1 day prior to the date fixed for receipt of Bid Documents.

#### 4. BID DOCUMENTS CAN BE HAD:

- b. Eligible bidders can also down load the entire bid document from our website <a href="www.orissa.bsnl.co.in">www.orissa.bsnl.co.in</a> and submit the same along with the required cost of the bid document as mentioned against the item(s) at pre pages in the form of DD from any scheduled bank in favour of Accounts Officer (A&P) BSNL, Office of the Chief General Manager Telecom Orissa, Bhubaneswar –1 payable at Bhubaneswar. The DD towards the cost of bid document is required to be kept in the "Envelope-A: Bid Security".
