The contractor must be reputed and registered with the Bharat Sanchar Nigam Limited or with any other Central or State Governments in the State of Orissa and must posses valid Labour licence

### INSTRUCTIONS TO THE TENDRERS

The sealed Tender will be accepted either by registered post or by hand up to 1400hrs of ----- and opened at 1500hrs on the same date in presence of the bidders or their authorized representatives if any. BSNL is not bound to accept the lowest Tender.

- 01. Earnest money of Rs.22000/-(Rupees twenty two thousand) Only must be deposited in the shape of Bank Draft drawn from any nationalized bank in favour of "The Accounts Officer, BSNL O/O the Deputy General Manager (Mtce) ETR, Bhubaneswar-751012 payable at Bhubaneswar and the same be enclosed with the Tender bid.
- 02. The EMD of the unsuccessful biders will be returned as such after signings of the agreement with the successful biders with out any interest and that of the successful biders will be released after signing the agreement with out any interest.
- 03. The nature, type of works, mode of payment and compensation of liquidated damages etc as per the terms and condition illustrated in the Tender document.
- 04. The successful Tender will be required to sign and agreement with the DE OFC(Mtce) ETR, Bhubaneswar before work is allotted to him. If he fails to do so within the stipulated time, the EMD deposited by him will be liable to be forfeited.
- 05. The successful Tender has to deposit a sum equal to 10% of the annual tender value at the rate fixed after finalization of tender as "Performance Security Money" which will be released only after the completion of the contract period successfully with out any interest.
- 06. After finalization of the Tender WORK ORDER will be issued to the party for carrying the job. If the party fails to carry out the job during the specified period quoted in the work order, the Performance Security Money deposited by him will be liable to be forfeited.
- 07. In case of any dispute the matter will be referred to the Arbitrator and the Arbitrator will be the Chief General Manager(Mtce) ETR, Kolkata or any other Officer appointed by him and the decision of the Arbitrator will be final.
- 08. The Divisional Engineer OFC(Mtce) Bhubaneswar on behalf of the BSNL reserves the right to accept or reject any or all tenders with out assigning any reason there of.

### TERMS AND CONDITION.

The successful Tenderer generally has to operate the Departmental Vehicle of different Mtce Division under ETR Sub-Region Bhubaneswar, and if required so the agency deployed the party may be asked to operate other Departmental Vehicle during the allotted time period by the officer in charge of the Vehicle. The operator deployed by the party must possess valid professional heavy vehicle driving licence.

- 1. For the time being 9 Nos of Vehicle operators are required for driving the departmental Vehicles of the following Mtce Sub-Divisions.
  - (i) NALCO OFC Stn-1 (ii) Nayagarh OFC Stn-1 (iii) Bhawanipatna OFC Stn-1 (iv) Keonjhar OFC Stn-1 (v) Rayagada OFC Stn-1 (vi) Sambalpur OFC Stn-1 (vii) Bolangir OFC Stn-2 (viii) O/o DGM(M),ETR,Bhubaneswar-1.(Total-9 nos)

However the successful tenderer will have to provide additional operators, if required for any other Mtce divisions under this Sub-Region in future in the specified period of the tender with the same terms and conditions.

2. Normal duty period is 8(eight)hours per day. How ever he must be available for the operation of the vehicle on 24 hours basis including Sundays and Holidays. The wages for extra duty performed may be paid as per the following calculation:-

- 3. The agency deployed by the party apart from operating the Vehicle, has to carry out other allied works like checking the mobile of the engine and toping the same if so required, checking the water of the radiator, changing of the tyres, in case of puncture cleaning the vehicle etc.
- 4. No advance payment will be given to the party. He has to submit the bill every month after successful completion of the work, in triplicate. The bill submitted by him will be send to "The Deputy General Manager (Mtce) ETR, Old Microwave Campus, Unit-8, Bhubaneswar-751012 after due scrutiny and certified. The payment will be made to him by Demand Draft/Cheque what ever preferable, after deducting necessary Income Tax and Sales Tax etc what so ever applicable.
- 5. The operator deployed by the party should carry one Authorization letter issued by the party by certifying his bonafideness. BSNL will not take any responsibility for providing boarding and lodging to the Operator. In case of inefficiency or negligence of the operator, the party will be asked to change the operator as and when required.
- 6. In case of out station extra wages is permissible as per Clause (1) for running period only and in the event of night halt, no halting charges will be admissible.
- 7. The rate fixed will be valid for one year from the date of entering in to the agreement and will not be changed under any circumstances
- 8. The contract will generally be for one year but subject to termination at any time during the course of contract period with out assigning the reasons there of by giving one month notice. The contract may be extended to another one year with the same terms and conditions.
- 9. Regarding payment of wages, other statutory benefits like EPF/ESI, payments on National Holidays and payment of Bonus to the operator, the contractor should make BSNL free from legal litigations.
- 10. The contractor should strictly comply the statutory requirements such as payment of minimum wages, EPF/ESI deposits etc. and other statutory requirements
- 11. The Driver should have upto date Driving License and experience of running the vehicles minimum 2(Two) years and no criminal case should be pending against him
- 12. The party has to make good of the losses, if any cause to the properties and the Vehicle of BSNL and also to the operator during the time of vehicle operation for the contract period agreed to.
- 13. The tenderer should have completed similar nature of work in any Govt. organization.
- 14. The tenderer should have valid labour license in similar nature of work.
