# TENDER DOCUMENT

### INSTRUCTIONS AND GUIDELINES TO TENDERERS :

- 1. The Tenderer must carefully read all the terms, conditions and specifications before filling up the tender schedule and his quotation. Tenderers are requested to get well versed with the tender conditions/specifications and guidelines written hereunder.
- 2. Tenderers who are bidding for the work should be firms having
  - (i) Experience in similar type of work.
  - (ii) Minimum annual turnover of Rs. 10 lakhs during the last two financial years i.e. 2007-08 & 2008-09 each.
- 3. The tender is for Establishment of 3G Experience Zones in OrissaTelecom Circle Specifications of the items are as per clause 24.

#### GENERAL TERMS USED AND INTERPRETATION:

#### SUBMISSION OF TENDERS:

5. (i) Tenders shall be submitted in the prescribed forms placed in double sealed covers super scribed 'Tenders for Establishment of 3G Experience Zones in Orissa Telecom Circle '. The bid should be submitted in two covers.

(a)Technical Bid : The first cover shall contain documents establishing bidder's eligibility with EMD. This is to evaluate the competence of the bidder in carrying out works as per the specifications given. Technical bid is to be submitted as per Annexure-A and must contain details like (a) Name and address of the firm

(b) Details of experience in the field (c) Proof of annual turnover for the last two years (d) All pages of Tender document should be duly signed by the bidder.

(b)Financial bid: The second cover shall contain the Financial bid. The rate to be specified shall be inclusive of transportation charges to BSNL at various CSCs mentioned in Annexure-D. The bid is to be submitted in the bid form given in Annexure B, failing which, the bid submitted will not be considered for evaluation.

- ii) Tender Covers for Financial bid and Technical bid should be clearly superscribed with 'Tender for Financial bid' or 'Tender for Technical bid' as the case may be.
- iii) Both the covers should be sealed separately by the personal seal of the bidder. Only bidders qualified in the technical bid will be considered for financial evaluation
- iv) Tenders received in covers not sealed will not be opened or considered.
- v) The tender papers should be sealed properly.
- 6. (i) The GM(CM) Orissa Telecom Circle reserves the right to reject any or all tenders without assigning any reason whatsoever and he is not bound to accept the lowest tender.

(ii) The GM(CM) Orissa Telecom Circle reserves the right to disqualify such bidders who have a record of not meeting the contractual obligations against earlier contracts entered into with the Officer inviting the tender.

- 7. Tender will be accepted on fulfilling eligibility conditions and will be finalized if all necessary papers have been submitted as per tender document. However GM(CM), Orissa Telecom Circle reserves rights to waive off minor infirmities.
- 8. The Tenderer has to put his Signature with seal on all the pages of the Tender document as a token of having read, understood and accepted all the terms and conditions of the contract/tender mentioned therein. He has to submit this along with his quotation.
- 9. Any attempt for negotiation direct or indirect on the part of a tenderer with the authority who is competent to finally accept it after he has submitted his tender or endeavors to secure interest for actual or prospective tenderer or to influence by any means the acceptance of the particular tender will render the tender liable to be excluded from consideration.
- 10. The tenderer will be bound by all terms, conditions and specification as detailed in this Tender.
- 11. Any tender with conditions other than those specified in the tender document will be summarily rejected. No modification by the contractor of any of the conditions will be permitted after the tender is opened.
- 12. BSNL has the right to amend supply schedule or order minor changes in design/ specification during the validity of the contract. No compensation, whatsoever, shall be payable on this account.

13. Tender forms not accompanied by prescribed EMD will be rejected.

## LATE TENDERS :

14. (i) Tenders received after the specified time will not be opened or considered.

(ii) No tender will be received in person by the AGM(Marketing) or any other staff subordinate to him. Any tenderer wanting to deliver the tender in person should deposit it in the tender box kept in the office of AGM (Marketing).

The slit of the tender box will be sealed immediately after the specified time for receipt of tender. Any tender presented in person by any tenderer or his representative after the tender box is sealed will not be received either by the AGM(Marketing) or by any of his subordinates.

### DOCUMENTS TO BE SUBMITTED WITH TENDER :

- 15. (i)One copy of the complete set of tender documents duly filled in and signed on each page to be Submitted.
  - (ii) Experience certificate for having done similar type of work is required to be submitted by the bidder.
  - (iii) EMD of Rs.8600/- in the manner as specified in the tender document.
  - (iv) 'Power of Attorney' in case any person other than the Tenderer himself has signed the tender.
  - (v) Authenticated copy of Partnership Deed, in case of partnership firm and power of attorney to the representative of the firm to operate the tender.
  - (vi) Proof of annual turnover for the last two years i.e. 2007-08 & 2008-09.
  - (vii) PAN No.

  - (ix) IT & ST return copy submitted for the assessment year 2009-2010.

#### EMD and PERFORMANCE SECURITY :

16. (i) EMD: Each sealed tender should be accompanied by EMD of Rs.8,600/- (Rupees Eight Thousand Six hundred only) in the form of crossed *Demand Draft* in favour of Accounts Officer (Cash), BSNL O/o General Manager, CMTS, IDCO Tower, BBSR, payable at Bhubaneswar through any Nationalized/ Scheduled bank.

The bidders (Small Scale Units) who are registered with National Small Scale Industries Corporation under Single Point Registration Scheme are exempted from bid security upto the amount equal to their monetary limit. In case of bidder, having monetary limit as "WITHOUT LIMIT" the exemption will be limited to Rs. 50,00,000/- (Rupees fifty lakhs only) as per the existing policy of BSNL. Any Small Scale Industry / firm claiming exemption from the payment of bid security should submit the copy of the current registration with National Small Industries Corporation (NSIC) for the tendered items along with documents in respect of their monetary limit and financial capabilities duly certified by the NSIC in the Envelope of Technical bid.

(ii) On acceptance of tender the contractor shall submit a **Performance Bank** Guarantee (PBG) @5% of the contract value within 7 days of acceptance of APO, issued by a scheduled/ Nationalized bank in the name of GM(CM), Orissa Telecom Circle, BSNL for a period of one year.

(iii) The Performance Bank Guarantee Security will be forfeited by BSNL as a part of compensation for any loss resulting from his failure to meet the obligations under the contract i.e., for non performance of contractor's obligations.

(iv) The EMD/ security deposit will not bear any interest. The EMD of unsuccessful Tenderers will be refunded to them after the tender is finalized and approved. The EMD of successful bidder shall be refunded after submission of PBG by him.

## TENDER SCHEDULE / QUOTATION :

17. (i) The tenderer shall quote the rates in English both in figures and in words. In case both rates do not tally the rates in words only shall be considered.

(ii) All corrections, additions and alterations in the entries and Tender papers shall be signed in full by the Tenderer with date. No errors, over-writing shall be permissible unless attested under the signature of the Tenderer with date.

(iii) The tender shall contain the name, residence and places of business of person/ persons submitting the tender and shall be signed by the Tenderer . Partnership firms shall furnish the full name and address of all partners or by a duly authorised representative followed by the name and designation of the person signing the tender. In case, it is signed by authorised representative, a duly certified copy of the power of attorney in that behalf shall accompany the tender. In case of the partnership firm attested true copy of the partnership deed must be submitted along with the tender.

(iv) The tenderer or a person holding power of Attorney to sign on behalf of the Tenderer before submission of the tender has to put his signature in full at the bottom right hand corner of all the pages of the Tender document and wherever required in the Tender Papers. All signatures in the tender document shall be dated.

### **REJECTION OF TENDERS**:

18. BSNL reserves the right to reject;

a. Any tender not supported by the requisite Earnest Money Deposit in the manner mentioned therein.

b. Any tender deficient or incomplete in any of the requisite matters, particulars or formalities or for any other reason.

c. Any tender/ offer which change the terms and conditions other than those envisaged in the tender document sold.

### VALIDITY FOR ACCEPTANCE :

19. Bids submitted by Tenderers will remain valid for acceptance for a period of 150 days from the date of opening of the tender.

### TENDER EVALUATION :

20. Tender will be evaluated on the basis of (i) quality as judged in conformity to specification, minimum time for delivery or other features and (ii) cost of total quantity of materials as indicated in the tender notice.(iii) Evaluation will be done on consolidated cost.

### SIGNING OF CONTRACT AGREEMENT :

21. (1) The successful tenderer has to enter into an agreement with the GM (CM), IDCO Tower, BBSR, in non-judicial stamp paper of value Rs.100/-(Rupees one hundred only) at his cost setting forth the tender condition etc., within 7 days from the date of intimation of the acceptance of his tender failing which the acceptance of tender will be revoked and EMD forfeited.

#### PERIOD OF VALIDITY OF TENDER :

22. The rates quoted should be firm and valid for any purchase order that may be issued within a period of **six months** from the date of entering into agreement or until the completion of the supply assigned under such a purchase order.

23. The quantity of work estimated is approximate and liable for variation. The quantity of work required is indicated in the Notice Inviting Tender. The quantities indicated in the Tender Schedule/ Notice Inviting Tender shall not be considered as final. BSNL, in exceptional cases, reserves the right to reduce the quantity of items to be ordered under this tender and in that event, no claim, whatsoever, for any damages, loss or compensation on any account shall be entertained by BSNL.

#### 24. SPECIFICATIONS AND OTHER TERMS& CONDITIONS

The items shall be of the size and specification mentioned above. The items need be supplied as per designs given /approved by BSNL. The GM (CM), Orissa Telecom Circle, BSNL, IDCO Tower, BBSR reserves the right to change the design of items within short notice at a later date. Transportation of items should be arranged by the tenderer at his/her own cost.

25. The material used should be of the quality specified above failing which the consignment shall be summarily rejected and will invite penalty as per clause 17(iii).

### CONSIGNEE AND PLACE OF DELIVERY :

26. ALL ITEMS SHOULD BE DELIVERED AT 8 Nos.of CSCs IN ORISSA AS REQUIRED BY THE PURCHASER.

### SUPPLY SCHEDULE :

27. 50% of the work specified in the work order has to be completed within **Fifteen days** of awarding of the work. Balance 50% has to be completed within **one month** of awarding of the work. Any damage, loss, pilferage, theft, etc., until the goods reaches the destination shall be on suppliers account & have to be replaced free of cost. Delay by the supplier with respect to delivery obligations shall render the supplier to any or all of the following sanctions, forfeiture of its security deposit, imposition of liquidated damages and/ or termination of the contract and forfeiture of EMD/PBG for default as specified in Clause 30.

### EXTENSION OF TIME :

28. Except as in clause 35, if at any time during performance of the contract, the supplier should encounter conditions impeding timely delivery of the goods and performance of service, the Supplier shall promptly notify within 3 days of the date of hindrance, to the Purchaser in writing of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the Purchaser's notice, the Purchaser shall evaluate the situation and may at his discretion extend the period for performance of the contract after mutual discussion with the supplier. Supply after due date may be made only after getting written extension order.

#### **INSPECTION, QUALITY ASSURANCE & CHECK :**

29. The supplier will prepare a sample and install it at one of the CSCs in Bhubaneswar and get it approved before starting installation at other CSCs.

#### LIQUIDATED DAMAGES :

30. The successful tenderer will have to supply the materials as specified in clause 24, failing which will invite penalty as follows. For each week of the delay or part there of to supply, a penalty of 0.15% will be deducted for a period of first 14 days and thereafter 0.2% of the value of the delayed supply for another 21 days. The delay will be counted from the delivery date specified in the purchase order. The purchaser may short close the P.O. with levy of LD equal to 5.5% after 30 days of prescribed schedule of 2 weeks. Final authority for imposition of liquidated damage rests with the General Manager(CM) Orissa Telecom Circle, Bhubaneswer.

#### WORK COMPLETION CERTIFICATE :

31. The In-charge of CSC shall issue a 'work completion certificate for all items installed in good condition. The work completion certificate shall not be delayed for minor defects which in no way hamper the commercial use of the item supplied, provided that the supplier under takes to make good the defect within a period of one month.

### PAYMENT :

32. NO ADVANCE PAYMENT will be made to the supplier.

Bills in duplicate duly pre-receipted should be forwarded to GM (CM), Bhubaneswar for effecting payment after the supply of materials. The payment will be made after receipt of **work completion certificate** from respective In-charge of CSC.

## TERMINATION FOR DEFAULT :

33. The GM(CM), Orissa Circle, BBSR may, without prejudice to any other remedy for breach of contract, by written notice of default, sent to the supplier, terminate this contract in whole or in part and on such termination the entire amount of Performance Bank Gurantee to the credit of the supplier shall stand forfeited to BSNL.

(i) If the supplier fails to deliver any or all of the goods within the time period(s) specified in the purchase order, or any extension thereof granted by the Purchaser.

(ii) If the supplier fails to perform any other obligations under the contract ; and

(iii) If the supplier, in either of the above circumstances, does not remedy his failure within a period of 30 days (or such longer period as the supplier may authorise in writing) after receipt of default notice from the Purchaser.

#### 34. OPTIONAL TERMINATION BY BSNL (OTHER THAN DUE TO DEFAULT OF SUPPLIER) :

BSNL may, at any time, at its option cancel/ terminate this contract by written notice to the supplier. No compensation shall be payable to the supplier for termination of the contract under the clause

### 35. FORCE MAJEURE :

If at any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract shall be prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics quarantine restrictions, act of God (hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non performance or delay in performance, and deliveries under the contract shall be resumed as soon as practicable after such event may come to an end or cease to exist, and the decision of the supplier as to whether deliveries have been resumed or not shall be final and conclusive, provided further that if the performance, in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 30 days either party may, at its option terminate the contract.

### 36.<u>ARBITRATION</u>:

If any question, dispute or differences arise in the interpretation about the terms and conditions under this agreement / tender or otherwise, such disputes shall be referred to the sole arbitration of The Chief General Manager, Orissa Circle , Bhubaneswar or in case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted functions of the Chief General Manager, Orissa Circle , Bhubaneswar or whatever designation such an officer is called (here-in-after referred as the said officer) whether in additions to the his normal duties, and if the said officer is unable or unwilling to act as such to the sole arbitration of some other person appointed by the Chief General Manager, Orissa Circle , Bhubaneswar of the said officer as per Rules.

There will be no objection to any such appointment that the arbitrator is a BSNL Employee or that he has to deal with the matter to which the agreement relates or that in the course of his duties, he has expressed his views on all or any of the matter under dispute. The award of the arbitrator shall be final and binding on the parties. in the event of such arbitrator to whom the matter is originally referred, being transferred or vacating his office or being unable to act for any reasons whatsoever such General manager or the said officer shall appoint another person to act as arbitrator in accordance with terms of the agreement and the person so appointed shall be entitled to proceed from the stage at which it was left by his predecessors. The arbitrator may from time to time with the consent of parties enlarge the time for making and publishing the award. Subject to aforesaid India Arbitration Act, 1940 and the rules made there under, any modification there of for the time being in force shall be deemed to apply to the arbitration proceedings under this clause. The venue of the arbitration shall be the office of Chief General Manager, Orissa Circle, Bhubaneswar or such other places as the arbitrator may decide.

Should any litigation still arise on any matter pertaining to this tender, the case shall be in a court having jurisdiction in Bhubaneswar.
