- 1) For the purpose of arriving estimated cost three nos. of semiskilled staff to attend any fault/operation.

- 2) The Contractor should have full setup along with all Paraphernalia /tools/equipment/spare accessories/skilled and appropriately trained staffs etc. for proper maintenance as and when required.
- 3) Electrical faults are to be attended as and when required. Complaint register to be kept as per Engineer in Charge's instructions.
- 4) DG set & Pump sets are to be operated as and when required through standby power when load shedding and to fill water tank when empty respectively.
- 5) For consumable items/spares will be paid extra.
- 6) The staff engaged by the agency should be paid as per minimum wages act as amended from time to time through Cheque/On line only.
- 7) The contractor has to submit necessary documents to BSNL regarding the proof of payment of EPF & ESI contribution along with all bills. EPF challans in respect of engaged workers should be submitted along with bills. Without EPF Chalans in support of EPF amount remittance in favour of engaged contractual staff, bill should not be passed. The employer part of EPF & ESI will be reimbursed with the bill to the contractor.
