3. (b) BSNL has decided to use the process of e-tendering for inviting this tender and thus the physical copy of the tender would not be sold.
3. (c) The bidders shall furnish a declaration that no addition / deletion / corrections have been made in the downloaded tender document being submitted and it is identical to the tender document appearing on Web-site (**www.tenderwizard.com/BSNL**) as per Annexure-E of Section VII.
3. (d) In case of any correction/ addition/ alteration/omission is found in the original tender document; the tender bid shall be treated as non-responsive and shall be rejected.
4. (a) **The bidder should have minimum of Rs. 1.5 Lakh (One Lakh Fifty Thousand) experiences in supply of Electronics or FTTH related accessories materials during last two year (in BSNL/MTNL/Other PSUs/Central Govt.) taking together.** Experience certificate in this regard is to be issued by an officer not below the rank of **Deputy General Manager or equivalent.** Experience certificate issued by any TDE or equivalent duly countersigned by an officer not below the rank of DGM will also be considered.

Experience certificate in this regard is to be issued by an officer not below the rank of Deputy General Manager or equivalent. Experience certificate issued by any TDE or equivalent duly countersigned by an officer not below the rank of DGM will also be considered.
- 11.2 The Bidder should have PAN No (In case of Partnership / Pvt. Ltd. firm PAN No. of firm is required & in case of Proprietorship firm PAN No. of proprietor is to be enclosed).
- 11.3 The bidder should have obtained registration certificate for GST in bidder’s/firm name.
- 11.4 The bidder should have **full-fledged office in Bhubaneswar** to support timely service for activities within the scope of work. The Bidder shall furnish a self-certification in this regard clearly mentioning the address of the location. BSNL shall reserve the right to verify the same by visiting the Bidder’s premises.
