- 3(a) Intending bidders are requested to register themselves with. NIC through the website www.etenders.gov.in/eprocure/app.
- 3(b) BSNL has decided to use the process of e-tendering for inviting this tender and thus the physical copy of the tender would not be sold.
- 3(c) The bidders shall furnish a declaration that no addition / deletion / corrections have been made in the downloaded tender document being submitted and it is identical to the tender document appearing on Website (https://etenders.gov.in/eprocure/app) as per Annexure E of Section VIII.
- 3(d) In case of any correction/addition/alteration/omission is found in the tender document; the tender bid shall be treated as non-responsive and shall be rejected.
- 4(a) The bidder should have experience of Rs.10 (Ten) Lakhs or more in OFC or U/G Cable laying works in BSNL/MTNL, Central Govt./ PSU in the last three financial years (2016-17, 2017-18 and 2018-19 taking together). Experience certificate in this regard is to be issued by an officer not below the rank of Deputy General Manager or equivalent. Experience certificate issued by any TDE duly countersigned by an officer not below the rank of DGM will also be considered.
- 4(b) The documents as listed out in Section VII should be uploaded in the E-Tender Portal.
