1.4 BSNL enlisted contractors in Electrical category of respective class with valid HT electrical licence as per their tendering limits.

1. Valid GST Registration Certificate issued by statutory authority.

2. The company or firm or any other person is not permitted to tender for work in BSNL unit in which his/her near relative(s) is(are) posted .

3. Similar work means repairing work of 25 KVA transformer sub station & above. Testimonials of satisfactory completion of works should be obtained from an officer not below the rank of Executive Engineer, wherever required clearly mentioning the name & scope of work.

4. Valid electrical HT licence issued by any State Government is required in all the cases.

2 All other terms& conditions as per BSNL EW-6 and BSNL EW-8 form.

3 The tenderer shall submit the tender in 2 sealed covers marked as cover 1st and 2nd inscribing the name of work. Both should be separate & they should not be enclosed in common third cover. The first cover should contain the earnest money deposited in the shape of demand draft/pay order of a schedule bank/nationalized bank/state bank guaranteed by reserve bank of India drawn in favour of Accounts Officer(Cash), O/o GMTD, BSNL, Cuttack. In case submitting tender down loading from web site, the 1st cover should contain DD towards cost of tender document and EMD drawn in favour of AO (cash), BSNL, O/o GMTD, Cuttack along with attested copies of eligible criteria with mandatory documents. The second cover contains the tender documents. If the 1st cover is not annexed in proper form, the second cover containing tender documents will not be opened at all.

4 If the date of opening is declared as holiday, then the tender shall be opened on next working day.

5 If the performance of the contractor is not satisfactory his tender shall not be opened. EE(E)'s decision shall be final and binding.

Copies of other drawings and documents pertaining to the works will be open for inspection by the tenderers at the office of the above mentioned officer. Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the ground and sub - soil. (so far as is practicable), the form and nature of the site, the means of access to the site the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender . A tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water electricity access, facilities for workers and all other service required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plants, etc. will be issued to him by the department and local conditions and other factors having a bearing on the execution, of the work.

1 The competent authority on behalf of the BSNL does not bind himself to accept the lowest or any other tender and reserves to himself the authority to reject any or all the tenders received without the assignment of any reason. All tenderers in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the renderer shall be summarily rejected. The public enterprises that avail benefits of the purchase preference should be subjected to adequate penalties for cost overruns etc.

2 Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who restore to canvassing will be liable to rejection.

- 3 The competent authority on behalf of BSNL reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 4 The contractor shall not be permitted to tender for work in the BSNL (responsible for award and execution of contracts) in which his near relative is posted as divisional account tant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer(both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in the BSNL or in the Ministry of communication. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
- 5 No Engineer of gazetted rank or other gazetted officer employed in Engineering or Administrative duties in an Engineering Department of he Government of India is allowed to work as a contractor for a period of two years after his retirement from Government service , without the previous permission of the Government of India in writing . This contract is liable to be cancelled if either the contractor or any of his employees is found any time 'to be such a person who had obtained the permission of the Government of 'India as aforesaid before submission of the tender or engagement in the contractor's service. The tender for the works shall remain open for acceptance for a period of ninety days from the date of opening of tenders. If any tender withdraws his tender before the said period or makes any notifications in the terms and condition of the tender which are not acceptable to the department , then the Government shall , without prejudice to any other right or remedy, be at liberty to forfeit 50 % of the earnest money as aforesaid.
- 6 This Notice Inviting Tender shall form a part of the contract document. The successful tenderer/ contractor, on acceptance of his tender by the Accepting Authority, shall, within 15 days from the stipulated date of start of the work sign the contract consisting of :-

a) The Notice inviting tender , all the documents including additional conditions, specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading there to.

b) Standard C.P.W.D. form 8.

Near relative(s) of BSNL employee not permitted to tender :

The company or firm or any other person is not permitted to tender for works in BSNL unit in which his near relative(s) is (are) posted. The unit is defined as SSA/ Circle / Chief Engineer / Chief Architect / Corporate office for non- executive employees and all SSA in a circle including circle office / Chief Engineer/ Chief Architect/ Corporate office for executive employees (including those called as Gazetted officers at present). Therefore, it has been decided by the competent authority that a clause must be added in the tender and other related documents that the tenderer should give a certificate that none of his / her such near relatives is working in the units as defined above where he is going to apply for tender. In case of proprietorship form certificate will be given by the proprietor , for partnership firm certificate will be given by the partners and in case of limited company by all the directors of the company. Any breach of these conditions by the company or firm or any other person, the tender / work will be cancelled and earnest mone / security deposited will be forfeited any stage whenever it is so notices.

The department will not pay any damages to the company or firm or the concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.

GENERAL SPECIFICATIONS.

1) The work shall be carried out as per current department / CPWD specifications.

- 2) Layout of the work shall be given at site of work by the Engineering in Charge or his duty authorized representative.
- 3) Samples of the all articles shall be got approved from the Engineer in Change before they are used.
- 4) The work shall be supervised by the qualified supervisor from the contractor's side.
- 5) Any damage done o the building / equipment of the department shall be made good by the contractor without any extra cost.
- 6) No T & P shall be issued to the contractor by the department.
- 7) Testing shall be done in the presence of the Engineer in Change or his duly authorized representative.
- 8) The contract shall stand for guarantee against defective materials of manufacturing defects and workmanship for the work carried out by him for the period of one year from it's commissioning & make good / repair / replace the faults during this period without any extra cost , failing which the same shall got done at the risk and cost of the contactor.
- 9) Security deposited of the contractor shall be released only after satisfactory completion of guarantee period.
- 10) Makes of product shall be as per product directory enclosed or approved by the Engineer in Change.

- 11) Without prejudice of any of the rights or remedies under this contract, if the contractor dies, the Engineer in charge on behalf of the BSNL shall have the option of terminating the contract without compensation to the contractor.
- 12) INDULGING OF CONTRACTOR IN CRIMINAL/ANTISOCIAL ACTIVITIES AND CASES UNDER INVESTIGATION / CHARGE SHEETED BY CBI OR ANY OTHER GOVERNMENT AGENCIES ETC. : If the CBI/Independent External Monitor (IEM) / Income Tax /Sales Tax/ Central Excise/ Custom Departments recommend such a course – Action will be taken as per the directions of CBI or concerned department.

"ESSENTIAL CONDITIONS OF CONTRACT "

The firm shall read carefully the following conditions and shall quote accordingly conforming all the points in their offer. Firm should specifically note that if they do not enclose E.M.D. with their tender , their tender will not be opened at all.

1 TAXES AND DUTIES :

BSNL shall deduct income tax and other statutory deductions / cess from payments due to the firm as per rules of the State / Central Government. The Accounts Officer of the concerned Division shall issue certificates for such deductions to the firm. In case of statutory variation in GST within the stipulated date of completion of individual agreement, the same shall be paid or recovered as per the actual against documentary proof for major equipments/ materials. However, beyond this period BSNL will take advantage of any duty reduction but will not pay extra on account of duty increase.

2 Evaluation of Tenders:-The evaluation and comparison of responsive tenders shall be done on the basis of Net cost to BSNL, considering GST as Input Tax Credit.

- 3 Loading , unloading , transportation, insurance etc. shall all be included in their offer.
- 4 All the materials will be under the charge of the contractor till it is completed and handed over . No materials will be removed from site without written permission of the Engineer in Charge.
- 5 Firm shall confirm to carry out the work as per the N.I.T. conditions.

6 PAYMENTS TERMS :

No advance payments will be made. Stipulations like levy of interest if any payment is not made in specificied time is not acceptable to the department.

7 Offer should be clear .

Any ambiguous offer is liable for rejection by the department. There will be no negotiation with the lowest tenderer. Hence the firms are requested to quote carefully. Department's decision in this regard shall be final and binding on the tenderer. Offer with condition will be summarily rejected.

8 GST:

8.1 All taxes and duties are as per applicable GST. Variation if any will be guided by Statutes pertaining to GST.

8.2 The Firm shall furnish Invoices to BSNL for availing of applicable Input Tax Credit.

8.3 Vendors should furnish the correct HSN/SAC code. If the Input Tax Credit (ITC) under GST is found to be not admissible at any stage subsequently owing to wrong furnishing of data, the vendor will be liable such non-admissible amount, if already paid along with penalty if charged by the concerned authority.

8.4 If the Vendors fail to furnish necessary supporting documents for availing of input tax credit by BSNL, the amount pertaining to such input credit will be deducted from the payment due to the firm. 8.5 Invoices should clearly indicate break up details of composite price i.e. unit price of goods/services/materials and GST etc.

8.6 In case of any statutory variations in regard to GST or any other taxes, within the currency of contract including extension period if any, the same shall be admissible as per prevailing GST laws as applicable subject to the condition that, the reason for such extension of time period is not attributable to the agency

SPECIFICATION E.I & FANS :

- 1 The work is to be carried out as per CPWD specifications (External) and I.E Rule amended up to date.
- 2 Good workmanship is an essential requirement to be complied with. The entire work of manufacturer, fabrication, assembly and installation shall conform to sound engineering practice.
- 3 Rates quoted shall be inclusive of all taxes, packing, forwarding, insurance, freight, delivery at site watch and ward of all materials.
- 4 All Sundry fittings, accessories, hardware items, foundation bolts, termination lugs for electrical connection as required and all other sundry items which are useful & necessary for proper assembly and efficient working of the various components of the works shall be deemed to have included in the tender.
- 5 Following works shall be carried out by the contractor and therefore their cost shall be deemed to be included in their tendered cost.
- a) The contractor shall be responsible for repairing all damages and restoring the same to their original finish. He shall also remove at his cost all unwanted and waste materials arising out of his work from his site.
- b) All chases required in connection with the electrical works shall be provided and filled by the contractor to the original finish.
- c) Temporary shed if required over the storage space and locking arrangement ,watch and ward of the materials shall be provided by firm till completion of the work and final taking over of the installation by the department.
- 6 The contractor shall employ qualified engineer/Supervisor as required and intimate names of such persons to the Engineer- in- Charge on commencement of work. Failure to employ will attract penalty as per agreement.
- 7 If any conduit is laid before award of work recovery for the same will be made from contractor at the rate of S.R. 16 + Abatement of respective S/H of this tender.
- 8 All non- metallic conduit pipes and accessories shall be of I.S.I marked , conduit accessories shall be of grip type / threaded type.
- 9 PVC conduit to be used shall be ISI marked heavy gauge and fire retardant quality.
- 10 The switch box shall be made of mild steel of size 16 / 18 SWG as per CPWD specification except the front side. The clear depth of M>S> switch shall not be less than 60 mm. Phenolic laminated sheet cover of 3 mm thick shall be provided in the front side of box.
- 11 Earthing shall be carried out in presence of representative of the department.
- 12 Numbering and sign writing of entire installation shall be carried out by the contractor as per instructions of the Engineering in- Charge for which nothing extra shall be paid.
- 13 On completion of installation following tests shall be carried out:;
 - a) Insulation resistance test.
 - b) Polarity test.
 - c) Earth continuity test.
 - d) Earth electrode resistance test.
- 14 On completion of electrical installation a certificate shall be furnished by the contractor in prescribed proforma, this certificate shall be in addition to the certificate required by local electric supply company.
- 15 Breaking capacity of MCBs should be 10 KA.
- 16 In urgency the agency may be asked to carry out the work in adjacent SSAs as per the requirement. The decision of Engineer-in-charge in this regard shall be final & binding.
