4. Eligibility Criteria : The bidder should meet following eligibility requirements

4.1 General Qualification

- 4.1.1 The Bidder should have valid firm registration (Registration with Nagar Nigam/Local Authority in case of Proprietary firm & in case of Pvt. Ltd Company/Partnership firm registration with registrar of firms/company is required) certificate of incorporation of the firm/company.
- 4.1.2 The Bidder must not be black-listed for Telecom business by any Central/ State Governments/ PSUs in India at the time of submission of bid. An undertaking must be submitted in this regard.
- 4.1.3 The Bidder must have a valid PAN & valid registration under GST Act. If the bidder is not registered with GST authority at the time of bid submission, then he shall have to submit GST registration at the time of award of work/ Lol/signing of contract, if declared successful.

4.2 Technical Qualification

4.2.1 The Bidder must have an experience of executing works related to construction/ maintenance of underground telecom cables/ maintenance and installation of OF cables /telecom outdoor network / Up keeping & maintenance of Mobile BTS etc. in DOT/BSNL/MTNL/Central Govt. Department/ State Government/ any public sector undertaking of Central Government/State Government during last 04 years (FY 2016-17 to FY 2019-20) and should have satisfactory completed works as given below:

(a) One year experience of any one financial year of at least 80% of estimated cost

OR

(b) Two year experience of any two financial years of at least 50% of estimated cost in each financial year.

OR

(c) Three year experience of any three financial years of at least 40% of estimated cost in each financial year.

In case of Experience certificate in this regard is to be issued by an officer not below the rank of JAG/DGM level or equivalent officer of the concerned PSU i.e. BSNL/ MTNL/ Central Government/State Government/ any public sector undertaking of Central Government/State Government as the case may be and from Circle Head, in case of private TSPs.)

4.3 Financial Qualification

- 4.3.1 The Bidder must have Solvency certificate from its banker,(nationalized/ scheduled bank of India), **to the tune of 40% of annual estimated tender cost**, in favour of GMTD, Sambalpur (Solvency certificate should not be older than NIT publication date)

Tender Information

1. **Type of tender: Single stage submission & Two stage opening.**

Digitally signed online bids are to be submitted in Single Stage Bidding and two stage opening e-tendering process using two electronic Envelopes from the eligible bidders by the time and date specified in the Bid Document.

Note: The bids will be evaluated techno-commercially first and thereafter financial bids of techno-commercially compliant bidders only, shall be opened.

2. **Bid Validity Period** - The bid will remain valid for **120 days** from the tender opening date

3. The electronic envelopes will contain documents satisfying the eligibility / Technical & commercial conditions in first envelope called **Techno-commercial** envelope and second envelope called as **Financial Envelope** containing financial bid/ quote.

a. Techno-commercial envelope shall contain :-

- 1) Scanned copy of EMD.

4. **Payment terms**

- 4.1 The bidder should submit the invoice to the officer in-charge of the site. The Tax Invoices are to be submitted by bidder in triplicate. Bill to be certified by SDE I/C & countersigned by AGM I/C on **monthly** basis to O/o GMTD, Sambalpur for processing for payment. SDE I/C should specifically mention the penalty if any during the period. The payment will be made to the contractor observing all the formalities & satisfactory reports.
- 4.2 90% of the payment of the invoices shall be paid on submission of Invoices by the bidder and Balance 10% after six months from the payment of 90% of Invoice.
- 4.3 Tax Invoices shall be paid through Electronic Clearance Scheme (ECS) only. The contractor should submit the mandate form for this purpose along with the Agreement while entering into the Contract.
- 4.4 Online generated GST payment details of previous month shall be submitted with the invoice(s) for payments.

Note: - All statutory taxes and levies as applicable shall be deducted at source before payment.

SECTION- 3

SCOPE OF WORK

SCOPE, SPECIFICATION & JOB DESCRIPTIONS

This tender is meant for maintenance of telecom sites in Sambalpur SSA. The quantum of work may vary as per the necessity of the works.

3.1 SCOPE& JOB DESCRIPTION

Details of Service to be provided by the contractor or his/ her representatives at each Site

1. Refueling of diesel in DG sets and maintaining log book of diesel refueling. (supply of diesel on site shall be separate and is not part of this contract)
2. Starting/ stopping of the DG set in case of power failure and immediate reporting auto start up failure if occurred and making entries in the logbook.
3. Top up of lubrication oil in DG sets.
4. Top up of coolant in DG sets.
5. Checking of DG battery voltage and Battery Charger/ top up of electrolyte & distilled water.
6. Keeping light fittings in working condition inside the HUB site with replacement of faulty lamps. (spares to be supplied by BSNL)
7. Cleaning the filters of window AC /split AC/free cooling units.
8. Regular Checking of earth pit/ earthing connection accessories like IGB/copper cables/ GI strip etc. and Watering earth pit and ring earth of tower regularly. Measurement of earth resistance quarterly and maintaining records and report submission.
9. Manual Operation and running of DG sets during main failure / low voltage.
10. Replacement of blown fuse in DCDB box.
11. Air filter/Exhaust fan cleaning of BTS.
12. Regular checkup of external alarm extension for remote sensing.
13. Testing of E1/FE and other media activities from one site to another (when required)
14. Hardware check and replacement of faulty equipment/Power Plant modules/ battery cells / cards at site. (Repairing will be done by BSNL)
15. Air filter cleaning in BTS/ Node B/ e-Node B, every month and entry in log book of site
16. Replacement of faulty card / module with spare card/ module. (Repairing will be done by BSNL)
17. For prolonged failure of Electricity as intimated by BSNL officer, Coordination for restoration of EB in consultation with BSNL Site/ IP In charge.
18. To ensure the control card is functioning properly so that battery do not go to deep discharge.
19. In case of any Power Plant outages due to fault in control card intimation to be given to Site In charge for attending the same on priority.
20. Conducting Battery Backup test with Existing Load at least in quarterly & record the same in Log Book.
21. Bidder has to provide related testing equipments to discharge the functions listed.
22. Switching on and switching off of ACs and other electrical appliances .

23. Cleaning of power plant, Battery Sets, DG battery, firefighting, Exchange equipment, other equipment and floor of the building at site
24. Answering of telephone, noting of complaints and passing information immediately to specified competent authority.
25. Ensuring that the property of BSNL is not tampered with; Custodianship of site with control of Keys will be provided to the contractor during the time of infrastructure maintenance. Movement of any material from the site is to be allowed only with a written permission of site in charge and making log entries in the material movement register.
26. Restricting access to the site for un-authorized persons and opening & closing of gate as and when required. Protecting the BSNL property & store material laying in the exchange building/premises from theft etc
27. Keeping exchange/office premises in hygienic conditions.
28. Informing BSNL officer in charge Exchanges about any alarm/ fault message immediately.
29. Help in testing of fire alarm, firefighting equipment etc when desired by officer in charge. Also should help for the testing of Exchanges when required by testing officer/official. Testing procedure shall be trained by BSNL staff.
30. Running water pump (if any) as and when required.
31. Watering the plants (if any) as and when required.
32. . Any other works that may be incidental and related to proper up keep of the telecom site.
33. Noting of alarms on BTS, OFC system & Power Plants, and intimating to the concerned responsible officers of BSNL
34. Assisting in dismantling and re-arranging of battery cells/sets.
35. Watering to Tower earth. / dewatering the Exchange premises
36. Grass-cutting, bush/tree-cutting & general cleaning in premises of tower/exchange.
37. Protection of equipment/tower/other store materials in the premises from trace passers/invaders/cattle etc.
38. Collection of EB bill from electricity authority and subsequent submission to concerned BSNL authority for further processing for payment of bill.
39. The contractor has to depute his workers with required tools, instruments, safety devices etc.
40. The Vendor undertakes to deploy well trained personnel to attend sites. The Vendor also ensure that the personnel so deployed should have minimum Knowledge of Telecom and Electrical equipment present at site.
41. The behaviour and practice of the deployed personnel by the vendor should not hamper the network performance of BSNL as well as other TSP, if present at site.
42. The field staff being deployed should be provided with 2 SIMs one of BSNL & other from private TSPs for communication when any switches of site is down. The field staff must answer to the call made by any BSNL officer. In case he is busy, he should call back immediately.
43. Work may be assigned by call/SMS/Whatsapp/mail and to be regularized by site-in-charge afterwards. Contractor has to submit his mail-id for correspondence.
44. The bidder shall provide proper identity card to the persons utilized.
45. The bidder shall support/coordinate with other agencies working at the HUB sites which (who) are authorized by BSNL.
46. Any other work that is assigned by the BSNL officer incharge.
47. For category A1, A2 and A3, separate cleaning/sweeping and watching through security guard may be carried out by SSA, with separate approval/consultation from HR cell of Circle office.

48.No staff deployed directly or indirectly by the contractor for the contract service would have any claim for getting future employment in BSNL.

CLUSTER MANAGER

1. For smooth execution of the above routine and maintenance works the vendor is binding to engage one cluster manager for his zone. The cluster manager should have at least educational qualification in Diploma or should have minimum 5 years’ experience in maintaining telecom equipment/network.
2. Cluster Manager will be the overall in charge for upkeeping and maintenance of all the HUB sites within the cluster and he will report to JTO/SDE/AGM of BSNL. He must have a two wheeler for movement from site to site in emergency. He must have a mobile connection(s) for effective communication. He should have necessary skill and the required tools/instruments/safety devices for carrying out the BTS up keeping and maintenance works.
3. The contractor and cluster manager must answer to the call/sms/whatsapp made by any BSNL officer. In case of busy, they should call back immediately.

17. LATE BIDS

17.1 No bid shall be accepted after the specified deadline for submission of bids prescribed by BSNL.

18. MODIFICATION AND WITHDRAWAL OF BIDS

19.5 The date fixed for opening of bids, if subsequently declared as holiday by the BSNL, the revised date of schedule will be notified. However, in absence of such notification, the bids will be opened on next working day, time and venue remaining unaltered.

20. CLARIFICATION OF BIDS

20.1 To assist in the examination, evaluation and comparison of bids, BSNL may, at its discretion ask the bidder for the clarification of its bid. The request for the clarification and the response shall be in writing. However, no post bid clarification at the initiative of the bidder shall be entertained.

20.2 If any of the documents, required to be submitted along with the technical bid is found wanting, the offer is liable to be rejected at that stage. However BSNL at its discretion may call for any clarification regarding the bid document within a stipulated time period. In case of non-compliance to such queries, the bid will be outrightly rejected without entertaining further correspondence in this regard.

21. PRELIMINARY EVALUATION

21.1 BSNL shall evaluate the bids to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are generally in order.

21.2 Arithmetical errors shall be rectified on the following basis. Based on the quoted percentage of taxes, etc. the amounts quoted thereof shall be worked out and rounded off to 2 decimal points.

21.3 If there is a discrepancy between words and figures, the amount in words shall prevail. If the supplier does not accept the correction of the errors, its bid shall be rejected.

21.4 Prior to the detailed evaluation pursuant to Clause 21, BSNL will determine the substantial responsiveness of each bid to the Bid Document. For purposes of these Clauses, a

substantially responsive bid is one which confirms to all the terms and conditions of the Bid Documents without material deviations. BSNL's determination of bid's responsiveness shall be based on the contents of the bid itself without recourse to extrinsic evidence.

- 21.5 A bid, determined as substantially non-responsive will be rejected by BSNL and shall not subsequent to the bid opening be made responsive by the bidder by correction of the non-conformity.
- 21.6 BSNL may waive any minor infirmity or non-conformity or irregularity in a bid which doesn't constitute a material deviation, provided such waiver doesn't prejudice or affect the relative ranking of any bidder.

22. EVALUATION AND COMPARISON OF SUBSTANTIALLY RESPONSIVE BIDS -

- 22.1 The BSNL shall evaluate in detail and compare the bids previously determined to be substantially responsive pursuant to clause 21.
- 22.2 The evaluation and comparison of responsive bids shall be done on the basis of Net cost to BSNL on the prices of the services offered excluding GST, as per the price schedule in the Section -9 Part B of the Bid Document after arithmetical correction in the manner laid down in clause 21.2 above.
- 22.3 Vendors should furnish the correct HSN/SAC in the price Schedule. If the supplier fails to furnish necessary supporting documents i.e. GST invoices etc. in respect of the Duties/taxes for which ITC is available to BSNL, the amount pertaining to such Duties/Taxes will be deducted from the payment due to the firm.

23. CONTACTING BSNL

- 23.1 Subject to Clause 20, no bidder shall try to influence BSNL on any matter relating to its bid, from the time of the bid opening till the time the contract is awarded.
- 23.2 Any effort by a bidder to modify its bid or influence BSNL in BSNL's bid evaluation, bid comparison or contract award decision shall result in the rejection of the bid.

24. PLACEMENT OF ORDER

- 24.1 BSNL shall consider placement of orders on those eligible bidders whose offers have been found technically, commercially and financially acceptable and whose Services have been approved / validated by the Purchaser. The Purchaser reserves the right to counter offer price(s) against price(s) quoted by any bidder.

25. PURCHASER'S RIGHT TO VARY QUANTITIES

- 25.1. The GMTD, Sambalpur SSA reserves the right to offer the contract to any other tenderer or any other agency in case of unsatisfactory work. The contractor should carry out the work to the satisfaction of BSNL officer in charge and in the event of his failure the contract work will be got done from some other agency at the cost of the contractor and payment will be settled on prorata Basis.
- 25.2. The GMTD, Sambalpur reserves the right to cancel or divert the job contract of some area if he thinks fit without assigning any reason at any time.
- 25.3. The decision of GMTD, Sambalpur SSA on any matter connected to this tender is final binding.

26. BSNL's RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS

The Purchaser reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids, at any time prior to award of contract without assigning any reason whatsoever and without thereby incurring any liability to the affected bidder or bidders on the grounds of purchaser's action.

27. ISSUE OF ADVANCE WORK ORDER

- 27.1. The issue of an Advance Work Order shall constitute the intention of BSNL to enter into contract with the bidder.
- 27.2 The bidder shall within 14 days of issue of the advance work order, give its acceptance along with performance security in conformity with the proforma provided with the bid document at Section-7B.
- 27.3 L-1 bidder may be issued Advanced Work Order (AWO) in two stages. The first AWO shall be issued for L-1 quantity as defined in Clause above. The second AWO may be issued to L-1 bidder only when the Purchaser exercises the right for placement of order on balance tendered quantity on the bidder with the lowest evaluated price in conformity to Clause 24 of Section 4 Part A.
- 27.4 In the event of withdrawal of AWO/Lol, subsequent claim of bidder for placement of Work Order/signing of contract, shall not be entertained by this office.

28. SIGNING OF CONTRACT

- 28.1 The issue of Work Order (WO) shall constitute the award of contract on the bidder.
- 28.2. The successful tenderer shall be required to execute an agreement on a non-judicial stamp of Rs.100/- (Rupees Hundred only) at his own cost as per the enclosed Performa. In the event of failure of the tenderer to sign the agreement within Seven (7) days of being called upon to do so after the acceptance of the tender, or in the event of his failure to start the work as stipulated, the amount of earnest money deposit or performance security shall be forfeited by BSNL and the acceptance of the tender shall be considered as revoked.
- 28.3 Upon the successful bidder furnishing performance security pursuant to Clause 27 of this Section, the Purchaser shall discharge the bid security in pursuant to Clause 12 of this Section, except in case of L-1 bidder, whose EMBG / EMD shall be released only after finalization of ordering of complete tendered quantity in pursuance to Clause nos. 24 & 27 of this Section.

29. ANNULMENT OF AWARD

Failure of the successful bidder to comply with the requirement of Clause 27 & 28 shall constitute sufficient ground for the annulment of the award and the forfeiture of the bid security in which event the BSNL may make the award to any other bidder on its discretion or call for new bids.

30. QUALITY ASSURANCE (QA) REQUIREMENTS – This Clause is not applicable

31. REJECTION OF BIDS

- 31.1 While all the conditions specified in the Bid documents are critical and are to be complied, special attention of bidder is invited to the following Clauses of the bid documents. Non-compliance of any one of these shall result in outright rejection of the bid.
- a) Clauses 12.1 & 13.1 of Section- 4 Part A: The bids will be rejected at opening stage if Bid security is not submitted as per Clause 12.1 and bid validity is less than the period prescribed in Clause 13.1 mentioned above.
 - b) Clause 2 & 10 of Section-4Part A: If the eligibility condition as per Clause 2 of Section 4 Part A is not met and/ or documents prescribed to establish the eligibility as per Clause 10 of Section 4 Part A are not enclosed, the bids will be rejected without further evaluation.
 - c) Clause 11.2 (c) of Section-4 Part A: If Clause-by-Clause compliance as well as deviation statements as prescribed are not given, the bid will be rejected at the stage of primary evaluation.– This Clause is Not Applicable
 - d) While giving compliance to Section-5 Part A, General Commercial conditions, Section-4 Part B, Special Instructions to Bidders, Section-5B Special (Commercial) Conditions of Contract and Section-3 Technical Specifications ambiguous words like "Noted", "Understood", "Noted & Understood" shall not be accepted as complied. Mere "Complied" will also be not sufficient, reference to the enclosed documents showing compliances must be given.
 - e) Section-9 Price Schedule: Prices are not filled in as prescribed in price schedule.
- 31.2 Before outright rejection of the Bid by Bid-opening team for non-compliance of any of the provisions mentioned in Clause 31.1(a), 31.1(b) of Section-4PartA, the bidder company is given opportunity to explain their position, however if the person representing the company is not satisfied with the decision of the Bid opening team, he/they can submit the representation to the Bid opening team immediately but in no case after closing of the tender process with full justification quoting specifically the violation of tender condition if any.
- 31.3 Bid opening team will not return the bids submitted by the bidders on the date of tender opening even if it is liable for rejection and will preserve the bids in sealed cover as submitted by taking the signatures of some of the desirous representatives of the participating bidder/companies present on the occasion.
- 31.4 The in-charge of Bid opening team will mention the number of bids with the name of the company found unsuitable for further processing on the date of tender opening and number of representations received in Bid opening Minutes and if Bid opening team is satisfied with the argument of the bidder/company mentioned in their representation and feel that there is prima-facie fact for consideration, the in-charge of the bid opening team will submit the case for review to Officer competent to approve the tender as early as possible preferably on next working day and decision to this effect should be communicated to the bidder company within a week positively. Bids found liable for rejection and kept preserved on the date of tender opening will be returned to the bidders after issue of work order against the instant tender.
- 31.5 If the reviewing officer finds it fit to open the bid of the petitioner, this should be done by

33. Clause Deleted

34. NEAR-RELATIONSHIP CERTIFICATE

34.1. The bidder should give a certificate that none of his/ her near relative, as defined below, is working in the units where he is going to apply for the tender. In case of proprietorship firm certificate will be given by the proprietor. For partnership firm certificate will be given by all the partners and in case of limited company by all the Directors of the company excluding Government of India/ Financial institution nominees and independent non-Official part time Directors appointed by Govt. of India or the Governor of the state and full time Directors of PSUs both state and central. Due to any breach of these conditions by the company or firm or any other person the tender will be cancelled and Bid Security will be forfeited at any stage whenever it is noticed and BSNL will not pay any damage to the company or firm or the concerned person.

34.2. The Company or firm or the person will also be debarred for further participation in the concerned unit.

34.3 The near relatives for this purpose are defined as:-

(a) Members of a Hindu undivided family.

(b) They are husband and wife.

(c) The one is related to the other in the manner as father, mother, son(s) & Son's wife (daughter in law), Daughter(s) and daughter's husband (son in law), brother(s) and brother's wife, sister(s) and sister's husband (brother in law).

34.4. The format of the certificate is given in Section 6 (B).

35. VERIFICATION OF DOCUMENTS AND CERTIFICATES

The bidder will ensure that all the documents and certificates, including experience/ performance and self-certificates submitted by him are correct and genuine before enclosing them in the bid. The onus of proving genuineness of the submitted documents would rest with the bidder.

If any document/ paper/ certificate submitted by the participant bidder is found / discovered to be false / fabricated / tempered / manipulated either during bid evaluation or during award of contract or thereafter, then BSNL will take action as per Clause-1 of Appendix-1 of this Section.

Note for Tender opening Committee:

- At the time of tender opening, the TOC will check/ verify that the documents conforming to eligibility part are submitted by the participant bidder duly authenticated by the authorized signatory to obviate any possibility of doubt and dispute and maintain veracity of the documents / papers/ certificates.
- The documents/ papers to be submitted in respective bid part have been explicitly stated in Clause-7 of Section-4 Part A.
- This opened bid part which is already signed by the authorized representative of the bidder company during bid submission will be signed by the tender opening committee

on hard copy and preserve it along with the bids received online in case of e-tendering.

- These papers will be treated as authentic one, in case of any dispute.

36. Security Clause as per latest guidelines and requirement –

Mandatory Licensing requirements with regards to security related concerns issued by the Government of India from time-to-time shall be strictly followed and appropriate Clauses shall be added in all bid documents. Necessary guidelines in this regard shall be issued separately.

1. Evaluation

- 1.1. The evaluation process comprises the following three (3) steps:
Step I: Fulfilment of requirements of Eligibility criteria, EMD and tender fee.
Step II: Evaluation of Bidder's fulfillment of Qualification Requirements as per Clause 4 Section 1 DNIT
Step III: Selection of Successful Bidder

1.2. Step I - Responsiveness check of Techno-Commercial Bids

- 1.2.1. The Techno-Commercial Bid submitted by Bidders shall be scrutinized to establish responsiveness to the requirements laid down in Clause 4 of DNIT
- 1.2.2. Any of the following may cause the Bid to be considered "Non-responsive", at the sole discretion of BSNL.
- a. Bids that are incomplete i.e. not accompanied by any of the applicable formats inter alia covering letter, power of attorney supported by a board resolution as per Clause 5, format for disclosure, valid EMD;
 - b. Bid not signed by authorized signatory and / or stamped in the manner indicated in this Bid Document;
 - c. Material inconsistencies in the information/ documents submitted by the Bidder, affecting the Qualification Requirements;
 - d. Information not submitted in formats specified in the Bid Document
 - e. Bid not providing information/ document to satisfy Qualification Requirements;
 - f. Bidder not meeting the criteria mentioned in Clause 4 of Section 1 DNIT of this Document
 - g. A Bidder submitting more than one Bid for the same zone.
 - h. Bid validity being less than that required as per Clause 13 Section 4A of this Bid Document;
 - i. Bid being conditional in nature
 - j. Bid not received (Electronic and offline) by due date and time as specified in Clause 6 of DNIT;
 - k. More than one Bidding Company using the credentials of the same Parent /Affiliate;
 - l. Bidder delaying in submission of additional information or clarifications sought by BSNL.
 - m. Bidder makes any misrepresentation of facts.
 - n. Bid not accompanied by valid EMD
- 1.2.3. Each Bid shall be checked for compliance with the submission requirement set forth in this Bid Document before evaluation of Bidder's fulfillment of Qualification Requirement is taken up.

- 1.3.1. After ensuring EMD with respect to its amount and validity; evaluation of Bid will be carried out based on the information furnished by the Bidder as per the prescribed Formats in Section 7 and related documentary evidence in support of meeting the Qualification Requirements as specified in Clause4 of Section 1 DNIT
- 1.3.2. Price Bid of only those bidders will be opened whose Techno-Commercial qualification requirement, prima facie meets the Qualifying Criteria. However, if at later stage it is found that Techno-Commercial bid doesn't meet the qualification criteria, bid can be rejected at sole discretion of BSNL.

1.4. Step III – Selection of Successful Bidders

- 1.4.1. Only the bids qualifying in Step II above, shall be financially evaluated for respective cluster, in this stage, on basis of their quote as per Financial schedule in Section 9 Part-B.
- 1.4.2. Successful Bidder shall unconditionally accept the AWO, issued by BSNL, within 14 days of issue of AWO.
- 1.4.3. If the Successful Bidder, to whom the AWO has been issued, does not accept the AWO unconditionally, BSNL reserves the right to annul the award of the Letter of Intent to such Successful Bidder and forfeit EMD (in case of L-1 bidder).
- 1.4.4. It shall not be binding upon BSNL to accept the lowest bid as successful.
- 1.4.5. It shall not be obligatory on the part of BSNL to furnish any information or explanation for cause of rejection of Bid or part of the Bid. Notwithstanding anything stated above, BSNL reserves the right to assess the credibility, capability and capacity of the bidders and viability of the Proposal to perform the contract should circumstances warrant such an assessment in the overall interest of BSNL and Bidder shall furnish all other required documents to BSNL.
- 1.4.6. 20.5 If any of the Arbitrators so appointed dies, resigns, becomes incapacitated or withdraws for any reason from the proceedings, it shall be lawful for the concerned party / arbitrators to appoint another person in his place in the same manner as aforesaid. Such person shall proceed with the reference from the stage where his predecessor had left it both parties consent for the same; otherwise he shall proceed de novo.

20.6 Parties agree that neither party shall be entitled for any pre-reference or pendent elite interest on its claims. Parties agree that any claim for such interest made by any party shall be avoid
