Financial bids of only techno-commercially responsive bidders will be opened on a later date for which those bidders will be intimated by notice or e-mail. Non-responsive bidders will not be intimated regarding opening of financial bid.

**2) POWER OF ATTORNEY:**

- a) The power of attorney should be submitted and executed on the non-judicial stamp paper of appropriate value as prevailing in the respective states (s) and the same be attested by a Notary Public or registered before Sub-Registrar of the state(s) concerned.
- b) The power of Attorney is executed by a person who has been authorized by the Board of Directors of the bidder in this regard, on behalf of the Company/institution/body corporate.
- c) In case of the bidder being a firm the said power of attorney should be executed by all the partners in favour of the said attorney.

**3) ISSUE OF LETTER OF INTENT (LOI):**

The issue of an LOI shall constitute the intention of the Tendering authority to enter into the contract with the bidder. The bidder shall **within 14 days** of issue of the LOI give his unconditional acceptance to the terms & conditions of tender in writing along with performance security in the shape of Bank Guarantee for **5%** of tender value to be awarded for a valid period of **24 months** in conformity with proforma at **Section VI** provided with the bid documents.

**4) SIGNING OF CONTRACT:**

The issue of work order shall constitute the award of contract on the bidder. Upon the successful bidder furnishing the performance security, the tendering authority shall discharge its bid security.

**5) COURT JURISDICTION:**

The contract shall be governed by Indian Laws and Courts at Bhubaneswar/ Cuttack and will have the jurisdiction to entertain any dispute or claim arising out of this tender till issue of Work order.

**6) PAYMENT TERMS**

100% Payment shall be released after satisfactory completion of the work. To claim the payment, bidder shall have to submit following documents.

9) **Delay in Contractor's Performance**

Delivery of the Goods and performance of the services shall be made by the Contractor in accordance with the time schedule specified by the purchaser in its purchase order. In case the supply is not completed in the stipulated delivery period, as indicated in the Purchase Order, purchaser reserves the right to short-close/ cancel this purchase order and/ or recover liquidated damage charges. The cancellation/ short-closing of the order shall be at the risk and responsibility of the supplier and purchaser reserves the right to purchase balance unsupplied item at the risk and cost of the defaulting vendors.
