

<u>INSTRUCTIONS TO BIDDERS & GENERAL CONDITIONS OF</u> <u>TENDER</u>

A) DEFINITIONS

- (a) "The User" means the GMTD, BSNL, Cuttack, Orissa Circle, acting on behalf of CMD, Bharat Sanchar Nigam Limited.
- (b) "The Bidder" means the individual or firm who participates in the tender and submits its bid.
- (c) "The Contractor" means the individual or firm providing vehicles under the contract.
- (d) **"The Service"** means the supply of vehicle which the contractor is required to provide to the user under the contract.
- (e) "The letter of intent" means the intention of the user to place the work order on the bidder.
- (f) "The work order" means the order placed by the user on the contractor signed by the user including all attachments and appendices thereto and all documents incorporated by reference therein. The work order shall be deemed as "Contract" appearing in the document.
- (g) "The Contract Price" means the price payable to the contractor under the work order for the full and proper performance of its contractual obligations.

B) SCOPE OF TENDER:

The Bidder is required to provide commercial vehicles fully conforming to RTA/RTO regulation along with the cost of fuel, driver, other running and repairing charges etc and carryout periodical maintenance and execute the work through their Supervisor.

Terms and Conditions:

- 1(a) "BSNL" or "The Nigam" or "The Tendering Authority" means Bharat Sanchar Nigam Limited (A Govt. of India Enterprise) acting on behalf of the President of India and represented by the General Manager Telecom District, Cuttack.
- 1(b) "The Bidder" means the individual or firm who participates in this tender & submits its bid.

4. ELIGIBLE BIDDERS

The bidders should have a valid experience in providing light commercial vehicles and multiutility vehicles of an amount of Rs. 40,00,000/-(Rupees Forty Lakhs only) taken together during the financial year 2015-16 & 2016-17& 2017-2018, before the date of NIT from a competent authority of any unit of PSU / any Central Govt. Department / any State Govt. department or any reputed Private Ltd. Companies / Firms for having executed similar contracts of providing at least 01 (one), petrol/diesel/CNG driven commercial vehicles such as Non-AC Indica/Indigo or Swift Dzire, Jeeps Sumo, Bolero or equivalent etc.. Experience certificate in this regard is to be issued by an officer not below the rank of **Deputy General Manager or equivalent.**

5. **VALIDITY OFBID**: The bid validity period is 180 days from the date of opening of the bid.

6. PERFORMANCE SECURITY

The successful bidder(s) will have to furnish security equal to 5 % of the estimated cost of the work before award of

final contract to him by the competent authority, in the form of Bank Guarantee issued By any Scheduled/Nationalized bank valid up to 30 (Thirty) months from the date of signing of with BSNL duly pledged in favour of AO(Cash), O/o the GMTD, BSNL, Cuttack.

If the work is awarded to more than one contractor the security amount as mentioned above will be divided among the number of contractors, on proportionate basis as per decision of GMTD, Cuttack.

The security deposit (SD) is required to protect the BSNL against the risk of bidders conduct and will be forfeited in part / whole in case of -:

- a) Unsatisfactory service.
- b) Theft or misappropriation of articles of the BSNL by the bidder or his driver on duty.

- 9. The near relative of employees(either directly recruited or on deputation) of BSNL are prohibited from participation in this tender. The near relatives for this purpose are defined as, a) Members of Hindu undivided family. b) They are husband & wife, c) The one related to other in the manner as father, mother, son(s) & son's wife (daughter-in-law), daughter(s) & daughter's husband (son in law), brother(s) & brother's wife, sister(s) & sister's husband (brother-in-law). Declaration is available at Annexure-D of Section-VII.
- **10.** In case of any dispute arising out of the contract between the two contracting parties, the decision of the Principal General Manager, Telecom Dist. Cuttack shall be final and binding.
- **11.** The GMTD, Cuttack reserves the rights to increase/decrease or delete the scope of work without assigning any reason thereof.
- **12.** The works against this tender will be executed under the overall control of the General Manager Telecom District, Cuttack.

13. COST OF BIDDING

The bidder shall bear all costs associated with the preparation and submission of the bid. BSNL in no case be responsible for these costs regardless of the conduct or outcome of the bidding process.

14. CLARIFICATION ON BID DOCUMENTS

- (a) A prospective bidder, requiring any clarification of the Bid Documents shall notify the Tendering authority in writing or FAX or at the Tendering authority's mailing address indicated in the NIT. The Tendering authority shall respond in writing to any request for clarification of the Bid Documents, which it receives up to 13:00 hrs of 10/09/2018. Copies of the query (without identifying the source) and clarifications by the Tendering authority shall be sent individually to all the prospective bidders who have received the bid documents.
- (b) Any clarification issued by BSNL in response to query raised by prospective bidders shall form an integral part of bid documents and it may amount an amendment of relevant clauses of the bid document.

15. DOCUMENTS TO BE SUBMITTED FOR BID

- a. The details of documents to be submitted through online in e-Tender Portal are as detailed at **Section VI**. If any one of the above items required to be submitted along with the Technical bid is found wanting, the offer is liable to be rejected at that stage.
- b. Documents in original should be submitted for verification as required by the Tendering Authority.
- c. The bidder will verify the genuineness and correctness of all documents and certificates including experiences/performance certificates, submitted by the bidder or any other firm / associates before submitting them in the bid. The onus of proving genuineness of the submitted documents would rest with the bidder.
- **d.** As per the requirement of the tender's condition, if any documents/papers/certificates submitted by the bidder is found to be false/fabricated/tampered / manipulated at any stage during bid evaluation or after award of contract, then the bid security (EMD/PBG) of the bidder would be forfeited and the bidder would be disqualified from the tender. Action would be taken for banning of business dealing with the defaulting firm. In case contract has already been awarded to the bidder, then PBG would be forfeited and the contract would be rescinded / annulled and BSNL would be at liberty to avail / procure the services from any other source at the risk and cost of the defaulting bidder. An undertaking to this effect should be submitted by the bidder as per format at **Annexure-M of Section-VII.**

16. AMENDMENT TO BID DOCUMENT

- (a) At any time, prior to the date of submission of bid, tendering authority may, for any reason whether at its own initiative or in response to a clarification required by a prospective bidder, modify the bid documents by amendments.
- (b) The amendments shall be notified in the E-Tender Portal only and will not be published in newspaper and these amendments will be binding on them.
- (c) In order to afford prospective bidders reasonable time to take the amendments into account in preparing their bids, the Tendering authority may, at its discretion, extend the deadline suitably for the submission of bids.
- (d) It is the sole responsibility of the bidder to confirm from the E-Tender Portal and/or from the following contacts regarding amendments, if any, or any other clarifications before uploading of the tender document.

17.PREPARATION OF BID DOCUMENTS – TECHNICAL BID & FINANCIAL BID

It is a two bid system and the bid prepared by the bidder shall comprise Technical Bid and Financial Bid and should be prepared as per Clause.21 of this Section.

BID FORMS

The bidder shall fill in the tender document in all respects, sign on all pages along with seal of the firm if any and upload required scanned documents as per Section-VI of the same in e-Tender Portal.

17. BID PRICE

- (a) The bidder shall quote rates as per schedule given in Section VIII of financial bid for all types of vehicles given in the schedule of requirement and hire charges. The composite price should include all type of taxes, excluding GST etc as applicable from time to time. However the basic unit price needs to be individually indicated against the supply under the contract.
- (b) The price quoted by the bidder shall remain fixed during the contract period and shall not be subject to variation on any account. A bid submitted with an adjustable price quotation will be treated as non responsive and rejected.

18. COMPLIANCE

The bidder should ensure unconditional clause- by – clause compliance with all the terms and conditions of the tender document and a declaration to the effect in Annexure C of section VII should be given along with bid document.

19. A. BID SECURITY/EMD

- (a) The bidder must deposit the amount for bid security/EMD through DD/ Online Banking /NEFT/RTGS as stated in section I of NIT only from any nationalized/scheduled bank as per Section-I para 2(b).
- (b) The successful bidder's bid security will be discharged upon the bidder's acceptance of the award of contract satisfactorily and furnishing the performance security.
- (c) The Bid security of unsuccessful bidder will be discharged / returned as early as possible.
- (d) A BID WITHOUT BID SECURITY/ BID SECURITY WITH OUT BID SHALL BE TREATED AS NON- RESPONSIVE AND SHALL BE REJECTED BY THE TENDERING AUTHORITY.

B.FORFEITURE OF BID SECURITY/EMD

The Bid Security/EMD may be forfeited

- (a) If the successful bidder backs out to accept the tender and/or does not deposit the Performance Security Deposit @ 5% of estimated costs of tender, or
- (b) The successful bidders do not come for execution of agreement after deposit of performance security deposit within the scheduled time;
- (c) Withdraws his bid during the period of bid validity specified by the bidder in the bid form;

(c) Performance Security:

- (I) The successful bidder shall be required to deposit an amount equal to 5% of estimated cost of tender within 2 weeks of conveying BSNL's intention for accepting the bid as performance security.
- (II) Performance security shall be submitted in the form of performance Bank guarantee valid for 30 (thirty) months issued by the scheduled Bank (located within Odisha) as per the proforma provided in annexure –F of the bid document.
- (III) Performance security will be discharged after successful completion of service provider's performance obligations under the contract.
- (IV) If the service provider fails to neglect any of this obligation under the contract it shall be lawful for BSNL to forfeit either whole or part of performance security furnished by the bidder as compensation for any loss resulting for such failure.

20. FORMAT AND SIGNING OF BID

- (a) The bid shall contain no interlineations, erasures or overwriting, except as necessary to correct errors made by the bidder in which case such corrections shall be signed by the persons signing the bid.
- (b) The over writing / erasures in the bid made by the bidder shall be signed by the person signing the bid.
- (c) The letter of authorization shall be indicated by written power-of-attorney, if any, accompanying the bid. All pages of the original bid, except for un-amended printed literatures, shall be signed by the person or persons signing the bid.

21. PREPARATION & SUBMISSION OF BIDS:

I) Contents of the Bid:

The bid contains three parts –

II. SUBMISSION OF BIDS:

- a. All the clauses of the bids must be complied with and price bids must be Bids quoted online by the bidders before the locking/closing time of the bid that is 17:00 Hrs of 17/09/2018.
- b. Scanned documents wherever necessary are to be uploaded in the appropriate places of the etender portal.
- c. The bidder shall submit a set of entire document signed in all pages, downloaded from e-Tender Portal against each individual bid which is to be uploaded in the e-tender portal.
- d. The Bidder can bid through the user-id allotted to him by M/s ITI in e-Tender Portal along with requisite Earnest Money Deposit (EMD) and cost of Tender Paper.

22. LATE BIDS, MODIFICATIONS AND WITHDRAWAL OF BIDS

- (a) After the Locking Time, no bidder can submit the bid.
- (b) The bidder may withdraw his bid after submission prior to the deadline prescribed for submission of bids. The bidder's withdrawal shall have to be online and digitally authenticated.

27. <u>CONTACTING THE TENDERING AUTHORITY</u>

- (a) Subject to seeking clarifications on e-tendering and tender document, no bidder shall try to influence the Tendering authority on any matter relating to its bid, from the time of the bid opening till the time the contract is awarded.

The Bidder is required to provide light commercial vehicles and multiutility vehicles fully conforming to RTA/RTO regulation along with the cost of fuel, driver, other running and repairing charges etc and carryout periodical maintenance and execute the work through their Supervisor.

The work includes supply of vehicles on Monthly Slab Rate based on BSNL's requirement. This tender is floated for monthly hire slabs of upto 1500 run KMs in a month in various sections units under the GMTD,Cuttack jurisdiction.

(NOTE: The Bidders responding to this NIT may quote for the said slab. The Bidder is required to quote for Hiring slab of 1500 KMs /1800kms/2000/2500/3000/3500kms run in a month. The bidder should also quote for the extra Km run beyond KMs slab in a month as rupees per KM, detention charges beyond duty hours as rupees per hour and for night halt charges as rupees per night halt).

The Tables shown above are only indicative and for regular work. The actual deployment may vary from time to time depending on work schedule, company's policy, intensity of maintenance and interruption duties and developmental activities etc. The additional requirement for a short period to meet the 'Peak Operational requirement' if any on day to day basis is also to be met with at the same rate quoted for regular work. Moreover GMTD, Cuttack reserves the right to vary the scope of work without assigning any reason thereof. The number of such requirement may not exceed 25% of the above estimated quantity.

SECTION -IV

SERVICE PROVIDER'S OBLIGATIONS

- 1. **Service to be provided** is to supply on demand the commercial vehicles with licensed drivers, registered as commercial vehicles on hiring basis for running within the jurisdiction of CUTTACK SSA under .G.M.T.D. Cuttack and within the state of Odisha as and when required. The essence of the contract is to provide Prompt, Punctual, Efficient, Safe, Courteous and Quality Service. The contractor (Employer) must pay to each and every motor driver (Skilled labourer) employed by him for each and every commercial vehicle on applicable daily minimum wages rates for skilled labourers as circulated from time to time by Dy. CLC (Central), Bhubaneswar so as to ensure the compliance of minimum wages Act 1948.
- 2. **Quantity of Vehicles** to be hired are shown in the Scope of Work. However, BSNL shall place the order only as per the actual requirement from time to time from the empanelled transporters as per Section IV of tender document.
- 3. **Allotment of vehicles:** Allotment of vehicle to different site in charges or sections purely lies with GMTD, Cuttack. Decision of GMTD, Cuttack in this regard is final and binding on all the bidders.
- 4. **Duty Hours of** vehicles are normally for ten hours per day (preferably from 9.00 AM to 07.00 PM) on all working days of month excluding Sunday and National Holidays or as per actual requirement within the prescribed limit fixed. However actual duty hours shall be specified by actual users of vehicle. Vehicle will halt at night at outstations if required and night halt charges as applicable can be claimed by the contractor. Except vehicle used by GMTD, Cuttack, SDE (Trans),I & SDE(Trans)-II, OT is restricted to 10 Hrs in a month for all other vehicles .In case of emergency the vehicle can be utilized in Sunday and National Holidays, with prior approval of GMTD, Cuttack. The vehicle owner is not allowed to use the vehicle for any other commercial purpose after duty hours. If vehicle used for any unlawful purpose the vehicle supplier will be responsible for the consequence.
- 5. **Notice period for supply of vehicles** shall be one day in advance for Regular requirements. One hour in advance for additional requirement during office hours. Telephonic intimation shall be considered as notice. Vehicle allotted to one unit/station can be changed and will be allotted to other unit/section within the Telecom. District depending upon the requirement. Notice for change of station / unit will be given at least 15 days in advance and will be effective from first day of the following month.
- 6. **Reporting Place for vehicles** is within the jurisdiction of CUTTTACK SSA under GMTD, cuttack. Actual place of reporting shall be specified by users of vehicles.
- 7. **Counting of Distance** will be from the starting **point** of the user and closing at the point wherever user completes his / her travel. The distance covered per day between user delivery address and the garage/ normal parking place will be allowed on actual basis or 5 KMs whichever is less.
- 8. **Accuracy of Meters** will be checked periodically by any authorized officer of BSNL and GMTD, cuttack reserves the right to get the meter calibrated or checked at any time at his sole discretion and in the event of any error/fault in the meter being noticed, the bill for the journey undertaken (including those undertaken earlier) would be adjusted, besides any other penal action as decided by BSNL, which may even lead to termination of Contract.
- 8. **Miscellaneous Conditions:-** Service Provider should comply with the following:
- (i) **Telephones-** Telephones, where requisition of vehicles can be conveyed all the 24 hrs. Telephone Numbers must be specified in the bid.
- (ii) **Identity Cards-** Proper Identity Cards after verifying the antecedents of his drivers' through Local Govt. offices

- (iii) **Documents of vehicles-** The attested/self attested copy of R/C Book and the Insurance policy of vehicles supplied under this contract should be submitted to the authorised person of the BSNL and will be subject to scrutiny with originals.. All the commercial vehicles should be insured.
- (iv) **Uniforms-** provide his employees uniforms as required under the rules which shall be worn by them all the time while on duty.
- (v) **Statutory Requirements-** It is desirable to have the Registration with EPF, ESI Code but if any of the one or two as above is not available with the bidder then the self certificate with reasons for their non-applicability should be submitted by the concerned bidder along with the technical bid. However, the submission of copy of valid labour registration certificate or valid labour license certificate alongwith the technical bid by the concerned bidder is a statutory requirement. If not applicable, undertaking to this effect must be submitted.
- (vi) Govt.Tax / Levy / Duty other than GST for the vehicles will be borne by the Service Provider.
- (vii) **Parking / Toll Charges,** if any, may be claimed by Producing valid parking / Toll slips.
- (viii) **Drivers** attested/self attested copy of driving license (light motor vehicle)should be submitted during the contractual period.
- (ix) **Consumables** like lubricants, tyres, battery and repairs, maintenance, taxes, insurance, etc. will be to the Service Provider's liability.
- (x) **Assign** driving to only qualified experienced licensed drivers and also assume full responsibility for the safety and security of the officers/officials and store items.
- (xi) **Duty Slips** in duplicate copy to be printed and serially numbered by the Service Provider as per prescribed format of BSNL (**Annexure O**) and should ensure that at the end of duty; the duty slips are completed and signed by the users.
- (xii) **Vehicles Up-keep** shall be in good condition along with good and clean Seat covers & curtains. Vehicles so hired may be inspected by a pre-designated committee of BSNL officers with reference to good/properly maintained vehicle including cabin, upholstery, seats etc.
- (xiii) **Multi-utility Purpose-** If the department wants to take some stores to be transported, those stores to be transported by MUV.
- (xiv) Unused KMs if any during a particular month will be carried over to the subsequent two months and will be adjusted against any extra KMs if performed over and above the fixed ceiling limit for the vehicle allotted to the site In charge.

9. **Debarring Conditions:-**

- i) No sub-contracting of the Service allotted is permissible by BSNL. The near relatives of all BSNL employees either directly recruited or deputation are prohibited from participation in this tender.
- ii) The tampering of meter reading, vehicle usage timings, overwriting of Summary / log sheet and misbehavior of driver while on duty shall be viewed seriously, leading to even cancellation of contract. If meter tampering is proved then a penalty of Rs 1000/- (Rupees one thousand) on each occasion will be levied.
- iii) Any misbehavior of bidder to officers of BSNL will be viewed seriously, will subject to lead termination of contract at any stage.
- iv) Service Provider shall not engage any person below 18 years of age.
- v) If at any point of time it is found that the contractor has provided other vehicle than the allotted vehicle to the site in-charge as per the work order without prior approval of GMTD, cuttack,the contract with the bidder will be cancelled.
- vi) No vehicle should be supplied having registration in the name of an employee of BSNL or their close relative and certificate to this effect should be given on the body of the bill while submitting claim.

10 BSNL will not have obligation:-

- (i) No liability whatsoever for payment of wages/salaries other benefits and allowances to his personnel that might become applicable under any Act or Order of the Govt. in this regard and the Service Provider shall indemnify BSNL against any/all claims which may arise under the provisions of various Acts, Government Orders etc. and any breach of such laws or regulations shall be deemed to be breach of this contract.
- (ii) No direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under section 29 of IPC and any loss caused to BSNL have to be suitably compensated by Service Provider.
- (iii) BSNL will not be responsible for theft, burglary, fire or any mischievous deeds by his staff.
- (iv) Service Provider shall be the employer for his workers and BSNL will not be held responsible fully or partially for any dispute that may arise between the service provider and his workers.

11. Penalty for breach of terms & conditions:

- (i) In case of break down, after it's reporting for duty, the vehicles will have to be replaced by same type immediately or not more than one hour. In case of non-availability of suitable vehicle a penalty upto Rs. 200/- may be imposed in addition to deduction on pro-rata basis for the period. If the number of break down exceeds three times in a month, a penalty of Rs.300/- per break down shall be imposed.
- (ii) The penalty for absence during extra Hour duty will be Rs.150 per occasion and for Temporary absence during duty hours without valid permission shall be Rs.100per hour of absence.
- (iii) In case of non-availability of vehicles for any particular day penalty of Rs.1000/- per day shall be imposed in addition to deduction of hire charges on pro-rata basis for the period.
- (iv) If the vehicle provided by the Service Provider is found to be not in good condition or without proper document; the vehicle may be rejected and sent back. No payment shall be made on account of such rejection. However in case of dispute the decision of GMTD, cuttack would be final.
- (v) Replacement of vehicle due to any reason should satisfy all tender conditions like paper documents and license, Tax, Model, Registration, commercial etc. Replacement of vehicle may be intimated on writing to the controlling Officer on or before the engagement of new vehicle.
- (vi) Service provider should not refuse to provide vehicles against BSNL's requirement and on each refusal penalty as given at item (iii) above will be deducted from the running bills besides any other action which may even lead to termination of contract.

(vii) Signing of integrity pact.

The successful tenderer shall be required to sign the integrity pact on a non-judicial stamp paper of Rs.100/- (Rupees one hundred only) at his own cost as per the enclosed Proforma in **Annexure-H**. The integrity pact will be signed separately along with agreement.

SECTION - V

GENERAL (COMMERCIAL) CONDITIONS

- **1.0 Bidder's Eligibility conditions:-** bidder must submit attested/self attested copies of the following documents with the technical bid of the tender document:-
- 1.1 The bidder should have at least 10 (Ten) commercial vehicles either in his / her / company's own name or on lease hold on or before the date of NIT of model not older than year 2014. Vehicles should be registered as commercial in his name or in the name of company or lease holding for use as commercial as mentioned in preceding sentence. The proof of ownership in respect at least 10 (Ten) of commercial vehicles should be submitted along with the Technical bid.
 - The bidder should have a valid experience certificate for an amount Rs. 40,00,000/-(Rupees Forthy Lakhs) taken together during the financial year 2015-16 & 2016-17 & 2017-18 before the date of NIT from a competent authority of any unit of PSU / any Central Govt. Department / any State Govt. department or any reputed Private Ltd. Companies / Firms for having executed similar contracts of providing at least 01 (one), petrol/diesel/CNG driven commercial vehicles such as Non-AC Indica/Indigo or equivalent cars, Jeeps, Sumo, Armada, Marshall, Bolero or equivalent etc. Experience certificate in this regard is to be issued by an officer not below the rank of Deputy General Manager or equivalent. Experience certificate issued by any TDE or equivalent duly countersigned by an officer not below the rank of DGM will also be considered.
- 1.3 Attested/self attested copy of firm registration, partnership deed in case firm is partnership firm and affidavit from notary in case of sole proprietary firm must be submitted.
- 1.4 Copy of PAN card.
- 1.5 Copy of valid GST registration certificate./ GST Regd certificate. If GSTIN not obtained, undertaking to this effect may be given to submit the GSTIN.
- 1.6 Affidavit issued by notary on stamp paper regarding declaration of no near relative employed in BSNL.
- 1.7 Affidavit issued by notary on stamp paper for declaration regarding not blacklisted firm and firm is not debarred.
- 1.8 Copy of valid labour registration certificate or valid labour license certificate must be Submitted if applicable or affidavit regarding non applicability of Labour license must be submitted.
- 1.9 Attested/self attested copy of Valid EPF & ESI Certificate, if applicable. If not applicable, then enclose self declaration with valid reasons that EPF and ESI is not applicable to his/her firm.
 In case of self attested copies, the concerned bidder should produce original when called for by the committee.

2. Right to Accept or Reject:

BSNL shall not be bound to accept the lowest or any tender and reserves the right to accept or reject any bid or to accept whole or a portion of tender, as it may deem fit, without assigning any reason thereof and without incurring any liability to the affected bidder(s) for the action of BSNL.

3. Right to vary quantities

BSNL reserves the right at the time of award of contract to increase or decrease upto 25% of the required quantity of services specified in the schedule of requirements without any change in hiring charges of the offered quantity and other terms and conditions.

4. Annulment of Award

Failure of the successful bidder to comply with the requirement of **clause 36 of section II** shall constitute sufficient ground for the annulment of the award and forfeiture of the bid security in which event BSNL may make the award to any other bidder at the discretion of BSNL or call for new bids.

5. Terms of Payment:

- 5.1 The payment shall be made within 30 days from the date of receipt of the bills in the office of GMTD, cuttack. Monthly bills in respect of vehicles engaged on monthly basis or daily basis shall be submitted in duplicate to the authority specified in contract along with completed duty slips duly signed by the user by the 15th of the following month for payment. The copy of GST paid Challan for the previous month / quarter as the case may be should be produced along with the bills for payment. In case, the bills are not submitted to BSNL as per above schedule, it will not take responsibility for delay in payment.
- 5.2 The bills should be submitted in duplicate to BSNL for payment vehicle-wise. It should be ensured that there is no overwriting in the duty slips. In no case, duty slip without signature will be accepted for payment and if it is found so, the amount will be disallowed.
- 5.3 In case the vehicle engaged on monthly basis is to be discontinued as per BSNL during the month, the bill is paid on actual basis, as per terms & conditions.

6. Clause by clause compliance.

A clause- by - clause compliance of service to be provided shall be given as per Scope of Work U/S III and General & Commercial Conditions U/S-II &IV. In case of deviation a statement of deviation shall be given.

7. **Duration / Period of Contract:**

Normally contract will be awarded **for 1 (one) year**. However, extension for the next year/part thereof will be considered keeping in view the various factors, such as prevailing market price, satisfactory performance of the firm.

8. Variation in tender cost-**BSNL** reserves the right increase to up to 100% in emergent case only with proportionate variation in tender period. The GMTD, Cuttack reserves the right to increase the contract period from the agreed period for a maximum 6 months with increase of 50 % of estimated cost. He also reserves the right to cancel the contract at any time without assigning any reasons thereof. In exigency GMTD, Cuttack reserves the right to increase the contract period to 1 year with 100% enhancement of estimated cost.

9). The bid security will be forfeited.

- i) If the bidder withdraws or amends its bid of impairs of derogates from the bid in any respect during the period of bid validity specified by the bidder in the bid form or extended subsequently; or
- ii) If the bidder does not accepted the APO / AWO and / or does not submit PBG & sign the contract / agreement.

Note: The bidder shall mean individual company / firm or the front bidder and its technology / consortium partner, as applicable.

- 9.1) Performance Security will be discharged after completion of Service Provider's performance obligations under the contract.
- 9.2) If the Service Provider fails or neglects any of his obligations under the contract it shall be lawful for BSNL to forfeit either whole or any part of performance security furnished by the bidder as compensation for any loss resulting from such failure.

10. Termination for insolvency

BSNL may also by giving written notice and without compensation to the Service Provider terminate the contract if the Service Provider becomes unwilling, bankrupt or otherwise insolvent without affecting its right of action or remedy as hirer.

11. Insurance

The Insurance cover protecting the agency against all claims applicable under the Workmen's Compensation Act, 1948 shall be taken by the Service Provider. The Service Provider shall arrange necessary insurance cover for any persons deployed by him even for short duration. BSNL shall not entertain any claim arising out of mishap, if any, that may take place. In the event of any liability/claim falling on BSNL, the same shall be reimbursed /indemnified by the Service Provider.

Read, Understood, Complied & agreed

12. Prices:

- 12.1) The rates should be on monthly basis. The KM slabs for monthly hire shown in **Scope of Work in Section-III.** The rate for extra per Hour detention and extra per km running is to be indicated in the above cases.
- 12.2) Rates charged by the Service Provider for the services given under the contract shall not be higher than the rates quoted by the Service Provider in his bid. In case of any reduction of taxes and statutory levies (if any) during the contractual period, BSNL shall take the benefit of decrease in such taxes/ duties for the services to be availed from the date of enactment of revised duties/ taxes.
- 12.3 In case of increase in taxes/ duties during the contractual period, BSNL shall be liable to revise the rates as per new taxes/ duties for the services to be availed for the remaining period of the contract.

13. Price Revision:

13.1 No escalation is admissible on any account whatsoever during the first three months of the contract. After three months of contract increase or decrease in hire charges due to variation in Fuel rates will be worked out and paid only when the variation to base rate is above 10%. Such increase or decrease in the hire charges due to these variations shall be worked out from the base rate on the following formula:

Increase or decrease in Petrol/Diesel during the month =

Actual KMs run by the vehicle X (Revised rate per litre - Base rate per litre)

Average KM per litre of Petrol / Diesel consumption (KMPL)

(Note:- The Base Rate of Petrol/Diesel is the prevailing rate on the date of commencement of work / contract. The average KMPL in case of Indigo /Indica/ Maruti Swift Dzire / SX4 petrol is 16 KMPL & 12 KMPL for Bolero/ Sumo both petro & diesel driven.

- 13.2 The review for change in hire charges due to change in fuel rates shall be affected at the end of quarter, irrespective of start of contract i.e. on 31st March, 30th June, 30 Sept, and 31st December. The change in hire charges, if any, shall be applicable from the 1st day of next quarter. Base Rate of fuel would be fuel prices as on date of award of contract.
- Arrear bills if any due to increase in fuel price is to be settled through supplementary bills to be submitted by the contractor. The supplementary bills is to be supported with proof of fuel price prevailing on 1st March of Month.

The Service Provider agrees with the BSNL and with each authority competent to order that every contract of hire order should be subject to the terms of this Agreement for vehicle Hire and in the event of a conflict between these terms and the terms in hire order, the terms of this Agreement for vehicle Hire shall prevail.
- 5. Service Provider will provide vehicles to BSNL not older than 2014 model and registered for the commercial purpose only and taxes; insurance etc. due on such vehicles shall be the liability of the Service Provider.
- 6. The Service Provider should provide the particular make & model of vehicle as agreed upon in the contract. The BSNL only reserves the right to substitute it with another similar vehicle. If for any reason whatsoever the BSNL is not happy with the condition of the vehicle provided, the Service Provider's nearest office will be informed immediately and they should accept any liability to replace it as per requirement. If for any reason the Service Provider is not in a position to provide a substitute vehicle as demanded by the BSNL then the BSNL will be free to engage a vehicle from the open market and debit the expenditure on account of it on the claims payable to the Service Provider
- 7. Service Provider will submit bills in accordance with Section-V, Clause (5) of the Bid document to General Section of GMTD office Cuttack on monthly basis for release of payment by BSNL.
- 8. The driver of the vehicle shall always hold a valid Photo Identity Card issued the local Central / State govt. office competent to issue such cards as per Section-IV, clause 8(ii) and also carry duty slips printed by the Service Provider as per the Format prescribed by BSNL, where the date, time, KMs reading, purpose and places visited are to be filled in and signed by the Users / BSNL officials. On the basis of these duty slips, the bills shall be raised to BSNL by the Service Provider. Counting of distance will be from the starting point of the user and closing at the point wherever user completes his / her travel. The distance covered per day between user delivery address and the garage/ normal parking place will be allowed on actual basis or 5 KMs whichever is less.
- 9. If the Service Provider fails to provide the vehicle to BSNL and if the service is not found satisfactory enough, the BSNL shall have the right to terminate the contract in whole or part and action deemed fit as per clause (36) of Section II of Bid Document.
- 10. In the event of any mechanical failure/breakdown of vehicle after it's reporting for duty, the Service Provider shall arrange for replacement by another Commercial Vehicle. Non-compliance may attract penalty as per Clause (11) of Section IV of Bid Document.
- 11. The following penalties will accrue to the Service Provider in addition to the deduction on hire charges on pro-rata basis on monthly hire slab. The penalty amount shall be deducted from the running bills besides any other action which may even lead to termination of contract:-
- 11.1 In case of break down, after it's reporting for duty, the vehicles will have to be replaced by same type immediately or not more than one hour. In case of non-availability of suitable vehicle a penalty up to Rs. 200/- may be imposed in addition to deduction on pro-rata basis for the period. If the number of break down exceeds three times in a month, a penalty of Rs.300/- per break down shall be imposed.

- 11.2 The penalty for absence during extra Hour duty will be Rs.150 per occasion and for Temporary absence during duty hours without valid permission shall be Rs.100per hour of absence.
- 11.3 In case of non-availability of vehicles for any particular day penalty of Rs.1000/- per day shall be imposed in addition to deduction of hire charges on pro-rata basis for the period.
- 11.4 If the vehicle provided by the Service Provider is found to be not in good condition or without proper document; the vehicle may be rejected and sent back. No payment shall be made on account of such rejection. However in case of dispute the decision of .G.M.T.D. Cuttack, would be final.
- 11.5 Service provider should not refuse to provide vehicles against BSNL's requirement and on each refusal penalty as given at item (iii) above will be deducted from the running bills besides any other action which may even lead to termination of contract.
 - 12. In case of any accident resulting in loss or damage to property of life, the sole responsibility for any legal or financial implication would vest with the Service Provider. BSNL shall have no liability whatsoever.
- 12.1 Replacement of vehicle due to any reason should satisfy all tender conditions like paper documents and license, Model & Type, Tax, Registration, commercial etc.
 - 13. The Bid Document No. NIT No:, schedules annexure/appendix which are annexed to this agreement shall form part and parcel of this Agreement and integral part of this agreement.
- 14. That Service Provider is/ shall be liable for any legal dispute/cases/claims that have arisen or may arise during the currency of the agreement in respect of vehicles provided by Service Provider. BSNL shall not be liable for any loss, damages, etc suffered/ to be suffered by Service Provider or third party as the case may be.
- 15. If for any reason the BSNL is dissatisfied in any way with the standard of the vehicle or felt deficiency in service during the hire period, it will be reported to the Service Provider in writing. The Service Provider without raising any dispute on such assessment by the BSNL regarding the standard of the vehicle provided or quality of service rendered by them may immediately replace it with another commercial vehicle on receipt of such complaint.
- 16. The Service Provider shall also be liable for all fines, penalties, and the like of parking, traffic and other criminal offences arising out of or concerning the use of the vehicle during the hire period and any toll Charges or entry Taxes payable locally and the Service Provider accordingly indemnifies the BSNL against all such liability.
- 17. The Service Provider shall not act as a broker for other hire companies or any individual or transfer or assign or sub-let any part of the service once agreed or any share of interest in any manner or degree, directly or indirectly, to any third party whatsoever and the contract will be valid only if the company signing the contract supplies the vehicles themselves from their own or leased fleet.
- 18. The Service Provider will also ensure that they will not supply the vehicles to BSNL which are either owned by employees of BSNL either directly recruited or on deputation to BSNL or their near relatives as defined in Company Act 1956 and clause (9.) of Section-II of the Bid documents of this agreement. A certificate to this effect is annexed to this agreement as Annexure-D.
 - 19. The Service Provider will not be tampering the meter reading, vehicle usage timings, overwriting of Summary / log sheet and misbehavior of driver while on duty will be viewed seriously. Such incidents shall be viewed seriously, leading to cancellation of contract.
 - 20. Any type of misbehavior by the driver on duty or the bidder to BSNL officers will be viewed Seriously and may lead to termination of contract. Decision of GMTD, Cuttack in this regard is final not under prejudice.

- 21. Service Provider shall not engage any person below 18 years of age.
- 22. Rates charged by the Service Provider for the services given under this contract shall not be higher than the rates quoted by the Service Provider in his bid and will be regulated by clauses-12 of Section-V of Bid Document. The revision of rates may be allowed on account of increase or decrease in price of Petrol/Diesel and these variations shall be worked out from the base rate as per formula indicated in Clause -13 of Section-V of Bid Document.
- 23. The KMs not used during a particular month—shall be carried over to the subsequent two months and extra KMs if any traveled during these two months will be adjusted against these unused KMs. Maximum limit up-to 1500 KM for all the vehicle. In exigency if vehicle used beyond 1500 KM
- 24. Except for vehicle of GMTD, Cuttack, SDE (Trans-I&II) OT is limited for 10 Hrs for all other vehicles.
- 25. In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to the matters, the decision to which is specifically provided under this agreement), the same shall be referred to sole arbitration of CGMT, Odisha Telecom Circle, Bhubaneswar of Bharat Sanchar Nigam limited (BSNL) of the respective Circles/District or any other person appointed by him. In case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the function of the CGMT, Odisha Telecom Circle, Bhubaneswar or by whatever designation such officers may be called (hereinafter referred to as the said officer). In the event of such Arbitrator to whom the matter is originally referred to vacates his office on resignation or otherwise or refuses to do work or neglecting his work or being unable to act as Arbitrator for any reasons whatsoever, the CGMT, Odisha Telecom Circle, Bhubaneswar of BSNL shall appoint another person to act as Arbitrator in the place of outgoing Arbitrator and the person so appointed shall be entitled to proceed further with the reference from the stage at which it was left by the predecessor and that the award of the arbitrator shall be final and binding on both the parties. Service Provider will have no objection in any such appointment that arbitrator so appointed is an employee of BSNL or a Government Servant or that he has to deal with the matter to which the agreement relates or that in the course of his duties as a BSNL employee he has expressed his views on all or any of the matters in dispute. The adjudication of such Arbitrator shall be governed by the provisions of the Arbitration and Conciliation Act 1996, or any statutory modification or reenactment three of or any rules made thereof.

The venue of Arbitration proceeding shall be Office of CGMT, Odisha Telecom Circle, Bhubaneswar of BSNL at Bhubaneswar or such other place as the arbitrator may decide.

Section 1 - Commitments of the Principal

 - (b) The Principal will, during the tender- process treat all bidder(s) with equity and reason.  - (c) The Principal will exclude from the process all known prejudiced persons.
- (2) If the Principal obtains information on the conduct of any of its employees which is a criminal offence under the relevant Anti-Corruption Laws of India, or if there be a substantive suspicion in this regard, the Principal will inform its Vigilance Office and in addition can initiate disciplinary actions

Section 2 - Commitments of the Bidder(s)/Contractor(s)

- (1) The Bidder(s)/Contractor(s) commits itself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the tender process and during the contract execution.
 - (a)Thee Bidder(s)/Contractor(s) will not, directly or through any other, person or firm, offer; promise or give to any of the Principal's employees involved in the tender process or the execution of the contract or to any third person any material or immaterial benefit which he/she is not legally entitled to. in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.
 - (b). The Bidder(s)/Contractor(s) will not enter with other Bidder^ into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
 - (b) The Bidder(s)/Contractor(s).will not commit any offence under the relevant Anti-corruption Laws of India; further the Bidder(s)/Contractor(s) will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans technical proposals and business details, including information contained or transmitted electronically.

The Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor is under contractual obligation to treat the information and documents of the Bidder(s)/Contractor(s)/Subcontractor(s) with confidentiality. Notwithstanding anything contained in this Section, the 3idder(s)/Contractor(s) shall have no obligation whatsoever to provide any internal! costing mechanisms or any internal financial or commercial data pursuant to any audit or review conducted by or on behalf of the Principal. If the Monitor has reported to the CMD of the BSNL, a substantiated suspicion of an offence under relevant Anti-Corruption Laws of India, and the BSNL has not, within reasonable time, taken visible action to proceed against such offence or reported it to the Corporate Vigilance Office, the Monitor may also transmit this information directly to the Central Vigilance Commissioner, Government of India.
- 6. The word "Monitor would include both singular and plural.

Section 9 - Pact Duration

This Pact begins when both parties have legally signed it. It expires for the Contractor 12 months after the last payment under the contract, and for all other Bidders 6 months after the contract has been awarded.
